The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 02-19-05 at 3:12 pm, Milwaukee Police were dispatched to 605 W. Lapham for a shooting. Investigation revealed a substantial battery occurred and took place at a rooming house located at 500 W. Maple St. A report was filed regarding the substantial battery. (050500194)
- 2. On 09-14-05 at 4:50pm, Milwaukee Police were working undercover for the Vice Control Division. While at 502 W. Maple, a control substance (cocaine) was delivered to an officer. 2 arrests were made and a report was filed regarding this incident. (052570148)
- 3. On 09-14-05 at 5:00 pm, Milwaukee Police conduct an FI on the steps at 500 W. Maple. A delivery of controlled substance to an undercover officer had just occurred at that location and officers observed this subject to have a plastic baggie sticking out of her hand. Investigation revealed she was in possession of cocaine that was consistent with delivery. She was identified as Latrice A. Oliver and was arrested and charged with same. (052570151)
- 4. On 01-28-06 at 6:20 am, Milwaukee Police were dispatched to 500 W. Maple for a battery complaint. Investigation revealed that a substantial battery occurred and victim required 40 stitches for eight lacerations to the right side of the face. An arrest was made and a report was filed regarding this Sub. Battery. (060280041)



- 5. On 04-28-06 at 8:10 pm, Milwaukee Police were in a foot pursuit of James W. Hollis (b/m 02-14-56) who was wanted for DOCS THC. The transaction occurred on the step of the residence located at 500 W. Maple. Hollis ran into the front door of 500 W. Maple and locked the door behind him. Officers fearing escape and destruction of evidence, forced the door and arrested Hollis. Report was filed. (061170171)
- 6. On 05-16-06 at 5:00 pm, Milwaukee Police officers conduct several FI's in front of 500 W. Maple. Officers were told by one subject that she was there to buy crack cocaine for her addiction. She was identified as Kim M. Rossettie (w/f 10-31-65). When asked if she had anything illegal in her possession, she admitted to having a crack pipe. She was issued a citation for Possession of Drug Paraphernalia. Another woman, identified as Pethobe Wherry, (b/f 04-03-39) was observed drinking a can of beer. As officers approached, she threw the beer on the ground. Wherry was issued a citation for Public Drinking.
