You are hereby notified that the Milwaukee Common Council will hold a hearing on May 31, 2006, commencing at 9:00 a.m., or as soon thereafter as this matter may be heard, in the Common Council Chambers on the third floor of City Hall, 200 East Wells Street, Milwaukee, Wisconsin 53202 to consider the revocation of the Tavern Dance license of John M. Raymond for the premises located at 1818 North Hubbard Street, City and County of Milwaukee, Wisconsin ("Roots").

Attached you will find a copy of the Report of the Utilities and Licenses Committee which includes their Findings of Fact, Conclusions of Law and Recommendation, recommending revocation of the Tavern Dance license. The recommendation is the result of a public hearing on the complaint of Manuel Torres and Kathy Torres before the Committee held on May 18, 2006. The committee recommended that the license be revoked based upon the complaint.

You may file a written objection to the Report of the Licenses Committee and if you file written objections you may have the opportunity to present arguments supporting that objection to the Common Council. Any written objections to the Committee's Report must be filed with the City Clerk at least three (3) days prior to the above-mentioned date set for hearing by the Common Council. You or a legal representative may also appear at the Common Council meeting and request an opportunity to address the Common Council for approximately five (5) minutes to present an oral argument on your own behalf.
