To Whom It May Concern:

On March 8th 2006 at 6480 North 56th Street the Milwaukee Police Department broke the door in to the property (6480 N. 56th St.) checking for a felony suspect per Milwaukee Police Department Damage Notice left.

At 9:11 PM the Milwaukee Police Department District #4 proceeded to kick in the rear door to the property (I own) splitting the edge by the door by the deadbolt and handle so the door can no longer be closed properly or lock at all, the door had to be nailed shut from the inside to close it. This does create a safety hazard for my tenants that live there.

I was not informed of this incident until the following morning from my tenant, Nicole Bridges. I called District #4 and spoke with a Supervisor Sergeant Brad Buddenhagen regarding what had happened. He informed me that they where looking for a Joseph Scott. And they where going on a tip that was provided to them. Joseph Scott has not lived at this address since June 2004 and according to the Probation and Parole Department his address on file with his PO is 2462 S. 12th St., which is a far cry from N. 56th St.

My tenant told me that the police said this was the last none address that they where given from his probation officer? I know there will always be different sides to the story, but needless to say, I need to

have my door replaced. I am providing 2 estimates as required, along with a copy of the Damage Notice left by the police for my tenant to give to me. As you can see there are again 2 different versions.

Your immediate attention to getting this replaced is greatly appreciated.
