Parking enforcement issues 20,000 citations annually for violation of the 24-hour rule. It is unknown how many citations would be issued in the pilot area under this ordinance, but it would be reasonable to assume the number would decline. Other implications of the ordinance includes the inability to detect abandoned or stolen vehicles in a timely manner, extends the timeframe to respond to potential abandoned or stolen vehicles from 1 day to at least 10 days, utilizes short-term on-street parking for long-term parking needs, and makes it more difficult to plow the streets sufficiently if a snow fall occurs before December 1 and after March 1.
