Re: Common Council Files 060290 and 060147

Common Council File 060290 contains the following recommendation:

Recommendation of suspension for 90 days, based on the police report and neighborhood objections, of the Class "B" Tavern and Tavern Amusement Cabaret (Nite Club) license of Jodie Komfehl, Agent for "JK Fun Holdings, LLC" for the premises at 618-24 N. Broadway ("Jungle") in the 4th aldermanic district. (Committee vote: Ayes: 3, Noes: 1)

With regard to the file listed above, the Licenses Committee held an evidentiary hearing on June 23rd, 2006.

Common Council File 060147 contains the following recommendations:

Recommendation of renewal, with a 14-day suspension based on the police report, of the Tavern Dance license of Dean Zarkos, Agent for "Dino Z, LLC" for the premises at 777 N. Jefferson St. ("Dino's Taverna") in the 4<sup>th</sup> aldermanic district. (Committee vote: Ayes: 3, Noes: 2)

Recommendation of non-renewal, based on the police report, neighborhood objections and non-appearance, of the Class "B" Tavern license of Dawn Wheaton for the premises at 3001 S. 9<sup>th</sup> St. ("HUH?") in the 14<sup>th</sup> aldermanic district.

With regard to the file listed above, the Licenses Committee held an evidentiary hearing on June 27th, 2006.
