I hope this finds you in good health & spirits. I am writing to ask your support of what I believe is truly a unique opportunity for the city and the county to partner together to help achieve great progress in our community.

On Thursday, July 6th, 2006 the Common Council's Economic & Community Development Committee will meet, one of the items that you will discuss is a commitment by the City of Milwaukee of \$38,000 over the next 3 years to help assist with establishing bus service to the quickly emerging Menomonee Valley. This commitment would be part of an approximately \$77,000.00 local match needed to secure Job Access and Reverse Commute (JARC) funding from the State of Wisconsin.

In addition to the City of Milwaukee, the MVBP BID has committed \$10,000.00 annually over the next 3 years to provide the local match. In order to ensure that the present companies located in the valley and that future companies we hope to attract and retain in the valley have an ample, viable workforce, a bus route serving the valley is a logical and important next step in the valley's development.
