Honorable Members of the Common Council:

This office has been retained by Jodie Kornfehl to represent her interests regarding the license renewal for "The Jungle". Pursuant to Section 90-12-5-c-2 of the Milwaukee Code of Ordinances, Jodie Kornfehl does respectfully file these written objections to the June 23, 2006 Utilities and Licensing Committee findings of fact and Conclusions of Law mailed to the licensee and received on June 27, 2006 for your consideration at the Common Council Meeting of July 12, 2006, at 9:00 a.m., at which time the Committee's recommendation will be decided.

BACKGROUND

Jodie Kornfehl has been a tenant at the location since 1998. The location was known as the Tom Tom club at that time. There have been several names and changes over the years. Jodie Kornfehl has always tried to cooperate with the City of Milwaukee in regards to how she operated her business. In 2005 she agreed to stop doing a teen night at the request of her Alderman. She has learned of certain complaints by the complainant and prior to the filing of the complaint had already determined that she was going to try to sell her business, or in the least close for awhile and change her format.

The Committee's report is based upon a): a police department report that was submitted to

the committee for a meeting on June 23, 2006 and b): A complaint filed by a citizen named Don Arenson pursuant to the Milwaukee Code of Ordinances 90-12. 1.f. which states in relevant part as follows:

The Licensed premises is operated in such a manner that it constitutes a public or private nuisance, or that conduct on the licensed premises, including but not limited to loud and raucous noise, has had a substantial adverse effect upon the health, safety or convenience and prosperity of the immediate neighborhood; or

Local ordinance and Wis Stat. 125.02 defines premises as the area described in a license or permit. In other words the area stated upon the application where the licensee designates the location that they will sell intoxicating liquor. The Licensee submits that her defined premises only includes the interior of the location. The Licensee also submits that she is aware that she has some responsibility for her customers outside behavior, but Licensee also submits that there has to be some reasonable limitation in the things that she can control because neither she nor her agents have Police authority.

In examining the findings of fact and the allegations of the complaint it is clear that all the issues that brings the Licensee before the Common Counsel concern incidents that occur outside on the street. As to paragraph 5A. The licensee did involve the police because a patron engaged in disorderly conduct. The next reported incident in paragraph 5B was 16 months later. At the time of the License Committee hearing it was submitted that this was an event that occurred in the 300 block of North Broadway, which is three blocks away from the licensed premises. The Licensee submits that this distance is to far away from her premises for her to have any control. The Licensee stopped doing underage nights due to this incident and her license was subsequently renewed.

Item 5C demonstrates that the Police Department has an agenda to report every single incident in order to create a record to have the license revoked. This item was based on some hearsay statements that a fight occurred, once again, outside. The investigation revealed no proof of any such incident and it should not be held against the Licensee.

Item 5D was another attempt to create a record. It is clear that the Citizen Complainant has an interest in creating a record. He has gone out of his way to call the Police regularly and even purchased video equipment to record the crowd leaving every night. He is also the **only** resident living in this downtown office environment. This item shows that the Police went to the location 8 times without finding any incident occurring. Tavern checks were also conducted regularly. The Licensee submits that the Police were not needed or requested at these times, and it is clear that she **never** received a citation for any violation or incident in her premises.

Item 5E demonstrates the poor relationship that the Police may have with certain members of our society. It is unknown the extent at which the Police intimidated or incited the people leaving

the premises. The Licensee states this incident was once again outside where she can't control the alleged patron from giving the finger to the Police. Items 5F, G, and H are unfortunate items but may not be different from such items that occur at other locations that serve 50,000 people per year. Item K concerns crowd and traffic control with no incidents reported. This is clearly an item included to demonstrate a problem. However it was not determined by anybody other that the Police Department that they were needed.

Item M concerns an incident that the Complainant and Police showed on a video tape. The incident was described as a huge fight with some kind of melee going on. But the video showed an argument between two people and one person pushing the other person. The Security staff witnessed the event contained it, and assisted the Police in arresting the individual. One member of the Committee even commented that the video did not demonstrate an incident that was as serious as what was described.

The remainder of the record demonstrates a clear effort to gather evidence. The Police did

video surveillance and were regularly at the area, and on most nights there were no incidents. The Licensee submits that this is a busy night club area in the downtown of Milwaukee. There are at least 8 clubs in a four block radius. There are several popular spots on Milwaukee Street. There is also a very large club called Ladybug with more than double the capacity that uses the same parking lot. The Licensee believes this demonstrates that a common use of buildings in downtown is to have night clubs because the area is not very residential in nature. The filed complaint in this case is from one residential neighbor in the entire block. Although there may be some cruising and crowd noise at closing time, it is generally dispersed within 20 to 30 minutes. The activities are not such that they shock the sensibilities or community standard for a downtown club.

The duty of the Common Counsel in disciplining a license is to engage in progressive discipline. It is an accepted tenet of law that the discipline be fair, progressive, and not discriminatory. The Licensee has been involved with this license since 1998. In those seven years the license was never suspended or revoked. The Licensee has never even received a citation for any incident that occurred at the location. It would be unduly harsh to impose the maximum suspension of 90 days in this case, especially, in consideration of the fact that the location has been voluntarily closed.

In these types of matters the Common Counsel's actions may be reviewed by a Court. The reviewing Court determines "whether the action was arbitrary, capricious or discriminatory." <u>State ex. Rel. Ruffalo v. Common Council of the City of Kenosha</u>, 38 Wis.2d 518, at 524. In looking at whether or not something is discriminatory it is well settled law that the idea of discriminatory action is rooted in the equal protection clause of the 14th Amendment to the Constitution. In <u>Village of Menomonee Falls v. Michelson</u>, 104 W.2d 137, the court stated as follows:

The equal protection clause of the fourteenth amendment

is violated if an ordinance is administered "with an evil eye and an unequal hand, so as practically to make unjust and illegal discriminations between persons in similar circumstances, material to their rights." Michelson at pg. 145

In this regard the legislative action to discipline this license is also a matter where discrimination is a Constitutional violation. (See ex.Rel Ruffalo id.). The Licensee submits there are many licenses that have been issued with two warning letters where the issues are similar to the ones raised in the Complaint. Attached hereto by reference as though fully stated are the recent actions of the Licensing Committee and Counsel in regards to similarly situated class B licenses of popular night spots.

For example "Rain" which is in an old warehouse area on Barclay street has received two warning letters in the past when it was disciplined. The incidents include a bouncer for the establishment attacking a patron, and the Police noting illegally parked cars and traffic problems as a hindrance. The next incident involved a patron observed leaving playing very loud music, and then it was subsequently discovered that the person was under 21 years of age, and another incident where Officers were flagged down on the street and it was reported that a patron was assaulted in the club.

On 10/24/2004 the applicant was cited for Disorderly Premises. It can only be assumed that the location had a large fight.

Also attached is the record of the Water Street location known as "McGillicuddy's" where many incidents have been reported. There Police reports indicate that citations have been issued for not having licenses posted. On 2-19-02 police were alerted to an incident that went from the bar to the street. A bartender and employee got into a fight with patrons they were ejecting and issued Assault and Battery charges, and the Police had to request other officers to back them up. There are a total of 8 incidents listed most of which involve police being flagged down to deal with Battery complaints that occurred inside the location. This location seems to require a lot of Police attention and yet there has been no discipline to this license. The Licensee submits that there were only two fights outside her location in the last license year, yet it is recommended that she receive a 90 day suspension.

Next attached is the record of "Judge's Irish Pub" a location that has had numerous neighbor complaints and incidents that require a large amount of Police attention. On at least one occasion a citation for disorderly premise was issued. This license was also issued with a warning letter, and no suspension.

Finally attached is the record of "Regano's Roman Coin" which showed a written complaint from one patron that had issues with noise that bothered his sleep. There was no disciplinary action taken and the license was issued. Like the Licensee there was a complaint of one person that apparently fell on the death ears of the committee.

Based upon the records attached and the arguments herein the Licensee requests that her license be issued without a suspension at all. This license has never had a warning letter, and in order to be progressive there should be no suspension, or one that is minimal in duration.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 04/14/2004, while officers were patrolling in area of 906 S Barclay Street, a citizen stopped the squad and requested help because he was attached by bouncers that work at Club Rain, 906 So Barclay St. The subject was told to stand on the sidewalk while the officers parked their vehicle. While parking the squad they observed the citizen/victim being again attacked by Club Rain security, and struck in the face by one of the bouncers, Aaron Henry. More squads were called because there were several subjects fighting in the street. A large crowd gathered. It should be noted that it was difficult for squads responding to the officers call for assistance because of the great amount of traffic and illegally parked vehicles in the area. 
