There is a possibility that your application may be denied for one committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. See attached police report or correspondence.

Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

This report is written by Police Officer David NOVAK, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. INCIDENT On 1-13-2005 an underage Milwaukee police aide entered Hideaway, 9000 W Kaul Ave. at the direction of Milwaukee police officers. The aide was able to purchase an alcoholic beverage from the bartender Patricia L Becker, who was issued a citation for Purchase Alcohol By Minor. No further information.
- 2. On 09-04-05 at 1:05am, Milwaukee Police were called to investigate an Armed Robbery that occurred at The Hideaway Inn. Police spoke to George WILLIAMS III, B/M 08-08-80, 8500 W. Fond du Lac. George stated he was in the bar and was betting on a game of pool he was playing with friends when one of his friends took his money. A fight started outside of the bar and George stated he was beaten up. George told officers he did not want to prosecute and officers filed a report regarding this incident. It should also be noted that the bartender, Jacqueline A. READER, w/f, 05-03-65, 11735 W. Bobolink Ave. 353-8002, pressed the hold-up alarm to get police to respond to the fight.
- 3. On 12-30-05, at11:25 AM, Binyoti F. AMUNGWAFOR, called police regarding a patron who was disorderly and making threats to harm other patrons in the bar. Subject was identified as Leonard T. BARTON III, (B/M 06-27-61, 9442 W Fond Du Lac Ave). Leonard BARTON was arrested for Disorderly Conduct while armed. There were no violations found at The Hideaway and no citations were issued.

- 4. On 11/24/07 at 3:25 am, Milwaukee police were dispatched to 5000 W Chambers (St Joseph's Hospital) for a Battery/Cutting complaint. Police spoke to the victim who stated he was in the Reds Hideaway Bar playing pool. At closing time, he and others were leaving the tavern out of a back hallway when he felt a sharp pain to his leg. The victim could not identify anyone who did this and stated he did not have any conflict with anyone inside the tavern. The victim received three staples and was later released. Officers attempted to conduct follow up at the tavern but no one answered. Officers returned on 11/25/07 and spoke to the licensee Binyoti Amungwafor. Amungwafor provided videotape that showed the victim was at the tavern but it did not show the incident itself. A report was filed.
- 5. On 12/14/07, Milwaukee police were dispatched to 9000 W Kaul for a Fight complaint. Investigation revealed an argument in sued inside the tavern and continued outside in the parking lot. A patron that was not involved in the initial fight went to break it up and in turn was beat up. The victim sustained a laceration that required stitches and a broken nose. During the investigation, another patron began disorderly and was cited for same.
 - 6. On 12/15/07 at 12:09 am, Milwaukee police were dispatched to 9000 W Kaul for a Subject With Gun complaint. Officers spoke to a security, Michael Williams, who stated there were 5 to 6 males who started a fight inside the tavern and "trashed" the place. Williams further stated the bartender was injured during this fight and that no guns were seen or involved. Police spoke to the bartender James McClendon who stated a fight broke out between an unknown female and an unknown male and when he went to break it up, the fight grew into a brawl with pool sticks being broken along with beer bottles and pitchers. McClendon stated he was hit with a beer bottle in the head during this time. McClendon refused medical attention at the scene. McClendon has not follow-up with officers regarding possible charges in regards to the battery.

7. On 09/04/08, Milwaukee police were dispatched to 10234 W Spencer Place for an Armed Robbery complaint. Officers spoke to the victim who stated he had left the Hideway bar and attempted to get into his car when he was approached by two males who robbed him of his belongings. Officers conducted follow up at the tavern and spoke to the bouncer Jeffery Simmons who stated he observed two males walk up the parking lot but that they never entered the tavern. Simmons stated another patron entered the tavern and that he (Simmons) had to go inside (the tavern). Simmons related he was waiting for the two males to enter the tavern but they never did. Simmons did not witness the robbery. The licensee Binyoti Amungwafor entered the tavern and spoke with officers. Amungwafor was able to show the officers the incident that was captured on video surveillance, however he stated he was unable to download a copy for police that night.

- 8. On 11/08/08 at 12:36 am, Milwaukee police responded to a Fight complaint at 91st/ Fond Du Lac, The Hideway Bar. Officers attempted to speak with the victim who was observed to be bleeding from the face and head and who also had a cut to his right arm. The victim was highly intoxicated and stated to officers that 20-30 unknown subjects inside the bar attacked him. The victim was did not provide descriptions and stated he only wanted to go home. Medical personnel was on scene but the victim refused treatment. Officers spoke to the victims' friend who stated an unknown female threw a drink at him and that he threw a drink back at her which started a fight inside the bar. He further state as patrons were leaving the bar one shot was fired but that he did not know who was shooting. Officers recover a casing which was found near the front entrance to the tavern. Police spoke to the security guard Andrew Anderson who provided police a description of the actor who fired the gun. Anderson stated he observed this subject go to his car, retrieve a gun and observed a flash from the weapon as it was shot into the air. Police also spoke to the bartender James McClendon who stated he observed some patrons arguing and that both patrons had thrown drinks at one another and that a fight occurred. Anderson could not provide any more information. Officers also spoke to Binyoti Amungwafor who stated the establishment did have three camera's outside and four cameras inside however upon review of the camera hard drive, it was determined the incident was not recorded.
- 9. On 01/10/09 at 3:14 am, Milwaukee police were dispatched to 9205 W Birch for a Battery complaint. Officers spoke to the victim who stated he had been at the Hideway bar and it was near closing time when he was attacked. The victim stated he was rapping with another patron when that patron became angry with the victim and slammed the victim's head into the wall. The victim stated he left the bar and did not notice that the subject followed him outside. Words were exchanged and another fight started when two other individuals got involved and also began punching and kicking the victim. The victim sought medical attention and was treated for bruising and an abrasion to the right ear. Officers did speak with Binyoti Amungwfor regarding the incident.
- 10. On 01/07/12 at 2:08 am, Milwaukee police were dispatched to St. Joseph's Hospital to investigate a Battery that occurred at The Hideaway bar located at 9000 W Kaul. Investigation revealed two battery victims were injured with one victim needing six stitches to close a laceration on her nose. On 01/08/12, police conducted follow up regarding the complaint and spoke to Antone Brazil, who is one of the bars managers. Brazil stated there was a fight and he went out to assist his security with it. Brazil stated once outside, the fight had broken up and all subjects left. Officers also spoke with Binyoti Amungwafor who also stated a fight did take place but that he didn't call police because everyone left the parking lot. Amungwafor also stated to police that he is not responsible for the problems in his parking lot. Amungwafor attempted to retrieve video surveillance for officers but was unable to. Police returned on 02/11/12 to retrieve the film and were told by Brazil that the system resets after a period of time and the footage from the incident had been erased.
- 11. On 03/11/12 at 1:56 am, Milwaukee police were dispatched to 9000 W Kaul for a Shooting complaint. Investigation revealed two subjects were shot while inside their vehicle that was parked in the parking lot near the bars front entrance. Further investigation revealed the shooting victims were shot after an argument occurred inside the tavern involving multiple patrons. The owner of the bar, Binyoti Amungwafor, was not on scene at the time of the incident but later arrived after being called by officers. Video surveillance was obtained and captured the events as it happened.

- 12. On 03/12/12, Milwaukee police along with the owner of the bar, Binyoti Amungwafor, had a meeting at District 5 regarding the shooting that occurred the night before. Discussions were held on how to prevent future incidents from happening with Amungwafor stating he would add more security and make sure his ID machine was working and that he would train all his security guards on how to use the metal detector. Amungwafor also agreed to have all his employees call police when there are problems instead of trying to handle it on their own. A suggestion by the district Captain to have a cover charge was made and Amungwafor stated he would consider it, but that the last time he had a cover charge, the crowd was small. Amungwafor was also advised that random license premise checks would be conducted on Fridays and Saturdays.
- 13. On 03/13/12 at 12:30 am, Milwaukee police conducted a License Premise Check at 9000 W Kaul. No violations were observed at the time with police speaking with Antoine Brazil, who is the bar's manager.
- 14. On 03/16/12, Milwaukee police conducted a License Premise Check at 9000 W Kaul. Police spoke with Antoine Brazil and no violations were observed.
- 15. On 03/24/12, Milwaukee police conducted a License Premise Check at 9000 W Kaul. Police observed about 50 patrons with two security guards at the front door. Police observed two bartenders and asked for their licenses. One stated she didn't have it on her but did possess one. The other bartender stated she was new and did not have one. Officers needed to do follow up regarding the bartender who stated she had a license. No other violations were observed.

16. On the following dates and times, a License Premise Check was conducted by Milwaukee police with no violations being observed:

17. On 05/20/12 at 2:00 am, Milwaukee police were dispatched to Hideway tavern for a Trouble With Subject complaint. Prior to police arrival, a couple was arguing in the parking lot about who was going to drive home. The girlfriend was pushed out of the vehicle and the boyfriend drove off with the vehicle. The woman sustained a right arm injury during this incident. MFD was on scene to treat the woman.

- 18. On 07/29/12 at 12:21 am, Milwaukee police conducted a License Premise Check at 9000 W Kaul. Officers spoke with bartenders Jessica Downey and Julianah Coker regarding the check and no violations were observed.
- 19. On 07/29/12 at 2:28 am, Milwaukee police were dispatched to 9000 W Kaul for a Shooting complaint. Upon arrival, the bar appeared to be closed and officers found spent gun casings in the bar's parking lot. Police were able to speak with Terry Harmon who works security for the bar who stated he heard gunshots but did not observe who was shooting and where the shots were fired from. Harmon stated that when the shots were fired, patrons ran back into bar and that Harmon inquired with another security guard, Jerry Simmons, about what was going on outside and Simmons informed him that an unknown female was shooting a gun into the air but that Simmons never told him where the shooter was firing the gun. Police attempted to view video surveillance, but the cameras did not capture where police believed shots were fired. Further investigation revealed two subjects were shot; one to the ankle and buttocks and the second victim was shot in buttocks. An officer was made aware by another department personnel that an unknown individual from the Hideaway staff spoke to police via phone prior to police arrival. The Hideaway staff was instructed not to close their establishment and that the police would be there to investigate an incident. The Hideaway staff seemingly ignored police instruction and closed the business anyway.

20. On 06/16/2013 Milwaukee police conducted a licensed premise check at 9000 West Kaul Avenue (Hideaway Tavern). No violations were observed.

- 21. On 11/03/2013 Milwaukee police were dispatched to St. Joseph's Hospital to investigate a Substantial Battery complaint. Investigation revealed that around 1:20am the victim, Hakeem Williams, was in the Hideaway Tavern at 9000 West Kaul Avenue. There was an altercation between Williams and several other bar patrons. All of the involved parties were escorted out of the bar by security. Williams was attacked by the other patrons in the parking lot of the business, resulting in the need for 2 staples to the back of his head as well as treatment of other injuries. Milwaukee police incident report #13370043 filed.
- 22. On 11/10/2013 Milwaukee police were dispatched to a Battery complaint at 9000 West Kaul Avenue (Hideaway Tavern). Investigation revealed the victim, Etienne Pouirier, lives above the business. Pouirier stated that as soon as he entered the bar, he was attacked by two men that he has had previous altercations with. Pouirier states the attack continued until security from the business intervened. Milwaukee police incident report #133140016 filed.
- 23. On 11/23/2013 Milwaukee police were dispatched to the anonymous complaint of drug dealing at 9000 West Kaul Avenue. The information contained in the dispatch indicated this address is a gas station. The officer checked both the gas station at 91st and Kaul and the business located at 90th and Kaul (Hideaway Tavern) but was unable to locate the caller and did not discover anyone dealing drugs.

- 24. On 05/18/2014 officers responded to Hideaway Tavern at 9000 W. Kaul Av for a property damage complaint. The investigation revealed that at female patron of The Hideaway was kicked out for being disorderly after getting in an argument with another patron. The female then went outside and broke the rear window of the other patrons car. The applicant was on scene and cooperative with the investigation.
- 25. On 05/24/2014 at 1:37am officers responded to the Hideaway at 9000 W. Kaul Av for a shots fired complaint. The call had come in at 12:04am as a trouble with subject but was upgraded to the shots fired at 1:35am. The officers spoke with security outside the tavern and they stated they heard no shots. The applicant was on scene and became agitated when the officers advised him why they were there. He stated he made the call for people not leaving the bar an hour ago but has heard no shots fired. The officers found no evidence of shots fired. The applicant was argumentative with the officers during this investigation.
- 26. On 02/04/2015 a meeting was held at District Four regarding a homicide that occurred on 02/08/2015 at 8340 W. Fond du lac Av and its relation to The Hideaway at 9000 W. Kaul Av. Present were Captain Beecher, ACA Nick Desiato, the applicant and his manager Tony Brazil. BRAZIL stated the bar has cameras, ID scanner, security and a metal detector. All patrons are wanded for weapons when they enter. Anyone entering with a gun is told to leave the building. BRAZIL stated the crowd gets big between 12:30am and 1:00am on Friday and Saturday nights and they have started a cover charge to keep the crowd down. Captain Beecher asked about gang activity. BRAZIL stated there are 5-6 males that come in together and an additional 2-3 at a time. He stated they never cause trouble inside and he asks them to leave if the throw gang signs. BRAZIL stated he does not believe the shooting was related to the bar and did not believe the victim of the shooting was at the bar that night. The applicant was advised of the importance of calling if there is an incident at the business.
- 27. On 03/20/2015 the applicant was cited in the City of Milwaukee at 9000 W. Kaul Av for Refilling of Liquor Bottle.

This report is submitted by Police Officer Jeremy CARTER, assigned to District Four on Late shift,

On Sunday May 18th 2014, while assigned to Squad 4368, P.O. Daniel PRIEWE and I were dispatched to a Property Damage complaint located at business Hide Away Tavern on 9000 W. Kaul Av., which is the city and county of Milwaukee.

Upon arrival P.O. PRIEWE and I spoke with the victim, Antqone L. BRAZIL(m/b 1-29-80) who informed me that his 2011, Hyundai Sonata with a WI plate of "646 UMX" had been damaged by a female acquaintance named "Latoya" who had been removed from the bar because she became disorderly after he would not talk with her.

P.O. PRIEWE was informed that after "Latoya" was escorted out by security around 1:00am the security officer, Wendell P. BARNES(m/b 1-4-70) observed "Latoya" throw an object, which was later found to be a stainless steel U-haul pad lock, through the rear window of the above vehicle, causing damage. Brazil estimated the damage to be approximately \$350.00. Brazil also informed P.O. PRIEWE that his vehicle had been "keyed" on the hood, front passenger quarter panel, front passenger door, and rear passenger door. I observed the scratches and I also photographed all of the damage. Brazil nor any witnesses had observed "Latoya" scratch the vehicle. It was unknown who caused this damage.

I spoke with the security who were at the entrance way of the tavern, who informed me they had a count 60 patrons inside. I observed inside the tavern a posted sign of 80 patrons for the occupancy limit. I also observed the tavern license located in the northwest corner of the bar. I spoke with the owner, Binyoti F. AMUNGWAFOR(m/b, 07-07-57), regarding surveillance of this incident. AMUNGWAFOR was cooperative in showing me the recorded surveillance that the tavern had.

I observed surveillance cameras, which were angled facing the parking lot. A subject was observed on the surveillance that matched the description of "Latoya", outside in the parking lot, amongst other people. However, the surveillance did not capture the area which Brazil's vehicle that was parked or "Latoya" throwing an object at BRAZII's vehicle.

- P.O. PRIEWE was informed that a vehicle with a WI plate of "109SCH", that "Latoya" was seen in, had fled the scene. A check of the license plate was conducted through WI DOT, which revealed the vehicle was listed to a gray 1996 Chevy Tahoe, with WI plate# 109SCH and was registered to Lashunda L. MOSS(f/b 5-27-82). P.O. PRIEWE and I went to the listed address, which was 5475 N. 62nd St, and P.O. PRIEWE and I spoke with MOSS, who informed us that she and her sister Latoya l. GILLIAM(f/b 5-4-84) were at the HideAway, on 9000 W. Kaul Av.
- P.O. PRIEWE and I were informed that Latoya did get into a verbal argument and was "kicked" out of the tavern, while MOSS was in the restroom. MOSS informed me that she did not observe Latoya damage Brazil's vehicle; however, she stated that Latoya did have a Uhaul pad lock. Moss described her sister as wearing a white t-shirt, blue jeans, and having a short haircut, which was also what BARNES described "Latoya" as wearing.
- P.O. PRIEWE and I checked her residence, of which she was not located at. "Latoya" was cited(#48917511133) for vandalism because a witness observed her damaging the rear windshield.

No one observed the subject(s) who scratched Brazil's vehicle.

P.O. PRIEWE photographed the vehicle and issued BRAZIL a PV-17.

This report was written by P.O. Gerald KULWICH, assigned to District Four, Late Shift.

On Saturday, May 24, 2014 at 1:37AM, Sergeant Todd WEBER (Squad 4411, 018141) and I (Squad 4320, 022620) were dispatched to The Hideaway Tavern located at 9000 W. Kaul Ave. regarding a shots fired complaint. It should be noted that at 12:04AM a call was placed for a trouble with subject at the same location, and the two calls were patched together. The trouble with subject call was placed by the owner, identified as Binyoti F. AMUNGWAFOR (W/M 9-21-1971). The trouble with subject call was changed to a shots fired at 1:35AM.

Upon arrival, I spoke with security that was outside of the Tavern. Security stated that they did not hear any shots fired or make the call regarding. I attempted to contact the caller that was listed in the Computer Aided Dispatch (Louis 414-795-1048) and did not receive an answer. The CAD information provided stated "caller heard 1 shot fired, came from area of the hideaway bar." I did not observe any bullet holes in the building or any surrounding vehicles, nor observe casings in the area.

I then went inside and spoke with AMUNGWAFOR who became agitated and argumentative when we informed him that we were on scene for a shots fired complaint. AMUNGWAFOR stated that he was the one who called because subjects would not leave the Tavern. AMUNGWAFOR stated that he placed that call more than an hour before our arrival, and those subjects have since departed from the location. Sgt. WEBER and I informed AMUNGWAFOR that we were aware of his previous call, but explained that there was another call regarding a shots fired. AMUNGWAFOR was argumentative, stating that there were no shots fired. We again informed AMUNGWAFOR that a call was placed for a shots fired, and AMUNGWAFOR continued to argue and raise his voice at Sgt. WEBER and I.

I was instructed by Sgt. WEBER to complete a license premise report. I also spoke with the bartender, identified as Shanon N. HORACK (W/F 12-9-1981) who was cooperative. HORACK stated that she was not aware of any shots fired. HORACK stated that AMUNGWAFOR did call for police, but the subjects left the location before we arrived.

On Tuesday 02/24/15 at 1:50pm, We had a meeting regarding the homicide (Inc#150390014) that occurred on 02/08/15. The homicide did not occur at this location, it occurred at 8340 W. Fond Du Lac Ave, but there was an incident involving the victim in the parking lot of The Hideaway

Present for this meeting was, Captain Beecher, Assistant City Attorney Nick Desiato, P.O. Carrie Resnick, Myself, the owner of Hideaway- Biyonti Amungwafer and his mananger Tony Brazil.

Tony began by stating, the bar has cameras, ID scanner, security and a metal detector. He stated the tavern doesn't usually have any problems. He stated on Friday and Saturday nights between 12:30am and 1am the crowd gets big, because people want to come in and order food. He stated they have started a \$5.00 cover charge to deter the crowd. Captain Beecher began to ask about the gang activity that comes into the tavern. Tony stated there is five to six black males that always come in together, and an additional two to three at time. They never come in all at once. Tony stated they never cause any trouble when inside. When they start throwing gang signs, he tells them they have to leave. Captain Beecher stated, our concern with the gang activity on the weekends is retalliation from the previous shooting. Tony stated he didn't believe the homicide had anything to do with the tavern. Tony did not believe the victim's of the shooting were ever in the bar on that evening. Tony stated, The tavern doesn't have gang violence, people come to party then they leave.

Tony stated everyone (males and females) who enters the tavern are all wanded for weapons. He has been told by security, people who attempt to enter with a firearm are told to leave the building. Everyone who enters must show an ID.

Nick Desiato explained the importance of the calls and the factors of a situation. He stated it's important if there is an incident, it's expected that the person operating the tavern should call the Police.

Captain Beecher advised them to contact the Police if they have an increase of crime.

I observed the vehicle traveling southbound and stopped the vehicle at the intersection of N. 68th St. and W. Fond Du Lac Ave. The victim, Phillis L. COLEMAN, B/F, 1-1-90, was sitting in the passenger seat of the vehicle. I had COLEMAN exit the vehicle and I spoke with her about what occurred.

COLEMAN stated that at 1:30am she and the father of her son, Bryan WINTERS, B/M, 11-17-81, were dancing inside the night club, Dee's Elegance. COLEMAN stated that she turned around for a moment away from WINTERS. COLEMAN stated that when she turned back around she noticed that WINTERS was dancing with a different female. On Monday, January 26th 2015 at 12:37 A.M. I was assigned with P.O. Daniel PRIEWE on squad 4374 when we were dispatched to a Shooting at 7420 W. Villard Ave which is Dee's Elegance Tavern.

Upon arrival to the location, I observed a subject later identified as Kevin D. WILLIAMS (B/M, 01/26/85) who was lying on the side walk in front of the tavern who had been shot.

I was informed that a shooting had occurred in the parking lot of the tavern and that a subject who was working security for the tavern may have been involved in this incident. This subject, Shaqille E. MADISON(M/B 4-19-92) was located inside of the tavern. MADISON was armed with a firearm which was secured by other officers who were in the tavern. I escorted MADISON out to my squad car and conducted a preliminary interview. MADISON informed me that he was hired by Dee's Elegance to do security and he was a valid CCW permit holder.

I briefed the on scene supervisor which was Squad 4312(Sgt. Jeffrey DOLKIEWICZ).

The interview by Det. Robert CRAWLEY, revealed that WILLIAMS, who was intoxicated, pointed a fire arm at MADISON. MADISON then shot WILLIAMS. This incident is still currently being investigated and will be reviewed at the DA's office.

Dee's Elegance is located in District 4 but its location bordesr District 7. Thirteen squads responded to the incident due to its seriousness and the amount of patrons who possibly witnessed the shooting. Three detectives also responded later to take over the investigation

The capacity was not observed because the patrons had exited the tavern once the shooting occurred.

The owner, Sheila D. MILTON (01/16/63), was very cooperative with police and detectives. She had been notified by staff and arrived on scene.

P.O. Lisa BAAKE had viewed the surveillance cameras which were working and had captured the incident.

I did not observe any tavern violations.

Rutherford stated Wallace did ask for his ID. Rutherford stated he presented his Wisconsin DL (Drivers License R361-0609-4244-07) while inside his wallet. Rutherford stated he did not believe the birthdate was viewable, however was unsure. Rutherford removed a \$20 bill from his wallet and handed it to Moftah. Rutherford received change of \$9.45. The change and beer was later returned to Moftah and a \$20 bill was returned to uniformed officers from Moftah's till. Regarding the incident Moftah stated she did remember carding Rutherford and stated he thought he was of age to purchase alcohol. Spirits Liquor has a valid posted Class D (0208367 Exp-12-31-14) and Class A (0198835 Exp-06-28-15). Moftah was issued this citation regarding this incident. Officers did view Rutherford on security cameras. The cameras depicted Rutherford approach the front counter and purchase a 12-pack from Moftah.
