When the green light is displayed for southbound traffic on South Jackson Park Overpass, it is red for westbound traffic on West Forest Home Avenue when vehicles or pedestrians are present on West Kinnickinnic River Parkway/West Jackson Park Drive. Since there is a short distance and because drivers make the southbound right turn at high speeds during the southbound green on South Jackson Park Overpass, vehicles making the southbound right turn under the current yield control may be disregarding the red light at West Kinnickinnic River Parkway/West Jackson Park Drive, contributing to the high frequency of right angle crashes at the intersection.

In order to reduce the speeds of the southbound right turns on South Jackson Park Overpass and attempt to decrease the number of disregards of the red light at nearby West Kinnickinnic River Parkway/West Jackson Park Drive, a stop sign with a stop ahead sign will be installed on the southbound right turn bypass on South Jackson Park Overpass to require drivers to stop before turning on West Forest Home Avenue.
