Please be advised that the undersigned represents Ijaz A. Gill and JJ Sub in the above-referenced matter. My client objects to the Licenses Committee's Findings of Fact, Conclusions of Law and Recommendation.

Since the Licenses Committee's decision Mr. Gill and I have been working with Alderman Bauman to address the concerns raised at the Licensing hearing and he prepared to install table service at the restaurant and remove some of the Plexiglas partition that is currently in the restaurant. In addition, my client is prepared to install security cameras and expend additional sums of money to spruce up both the inside and outside of the restaurant.

Mr. Gill and his family have been residents of Alderman Bauman's District for over four years; in fact, he resides just around the corner from his restaurant. The restaurant is Mr. Gill's sole source of income and his wife and three children depend upon it for their livelihood.

I therefore, respectfully request that this matter be sent back to the Licenses Committee so that we may make these proposals to that Committee and for any additional testimony.
