Re: Request for Full Time Equivalent Position for Heidi Wick Spoerl

Dear Mr. Nicolini:

Assistant City Attorney Heidi Wick Spoerl is currently in a .8 FTE position. We are writing to request that her position now become a full time position due to an increase in her workload.

Ms. Spoerl's area of expertise over many years is the defense of worker's compensation claims at hearings and through appeals. She also pursues reimbursement of compensation and medical expenses the City has paid in the event the injured employee has a claim against a third party. Her work is critical to reducing worker's compensation benefits and medical expenses for the City, and MPS.

As you will see from the enclosed chart, Ms. Spoerl's case load had been slowly rising through 2012. From 2013 to 2013, the rise began to accelerate and from 2013 to 2014 the total cases opened went from 80 to 114 which is approximately a 40% increase. The experience through April 28, 2015 put the statistic for 2015 on pace with 2014.

From our discussions with Ms. Spoerl, it is clear that this increase in work is not temporary. Further, in addition to the increased number of cases being opened annually, the complexity of the cases has increased, with many more matters now requiring defense of overlying or underlying psychological (stress) claims. In legal terms, the inclusion of a stress component to a worker's compensation claim increases the amount in controversy and can transform an otherwise "scheduled" injury with a fixed percentage of permanent partial disability, to a claim for loss of earning capacity and the potential for permanent total disability. The additional work has required Ms. Spoerl to now work many hours

beyond what she is paid as a .8 FTE, and regardless of her high level of professionalism, it is only fair and appropriate that she receive a full-time salary for full time work.

I have presented this information to Maria Monteagudo, Director of Employee Relations and she has concurred in the need for this action. Please indicate your agreement to this request by June 10 or earlier, so it can be presented at the next Finance and Personnel Committee.
