We return the enclosed document which has been filed with the City Clerk and ask that it be introduced and referred to the Committee on Judiciary & Legislation with the following recommendation.

Claimant, Anthony Rudig, 2333 South 12<sup>th</sup> Street, Milwaukee, WI 53215, alleges that on July 12, 2007 he sustained damages to his 2007 Chevrolet when a tree branch from a City tree fell on it at 2326 South 12<sup>th</sup> Street.

Our investigation reveals that the Forestry Section was notified of an emergency service request involving a tree branch down on July 23, 2007 at the subject address. The tree branch had caused damage to the claimant's vehicle. Prior to this incident, the tree was alive and showed no external signs of decay. The Forestry Section followed their normal

procedures with this tree and there was no way the section could have foreseen nor prevented this loss. Since the City was not negligent and this loss occurred during windy conditions, it cannot accept liability. As such, we recommend denial of this claim.
