Communication from the City Attorney relative to expenditures from the Outside Counsel/Expert Witness Fund Special Purpose Account.

### **Background**

- 1. Common Council File # 030083 placed expenditure authority for the Outside Counsel/Expert Witness Fund Special Purpose Account with the Office of the City Attorney and directed that the City Attorney advise the Judiciary and Legislation Committee in writing within 48 hours of the hiring of any outside counsel; that the City Attorney advise the Judiciary and Legislation Committee in writing within 48 hours of the retention of any expert whose compensation is anticipated to exceed \$10,000; and that the City Attorney submit a written report to the Judiciary and Legislation Committee every other meeting of expenditures from the Outside Counsel/Expert Witness Fund Special Purpose Account.
- 2. The amount budgeted for the Outside Counsel/Expert Witness Fund Special Purpose account in the 2007 budget is \$225,000.
