

Report on the renewal application for a Food Dealer's License for Erik D. Gast, Agent for Family Dollar Stores of Wisconsin, Inc., for the premise located at 2021 West Capitol Drive

("Family Dollar Store #6587").

FINDINGS OF FACT

- 1. Erik D. Gast (hereinafter the "Applicant") applied for renewal of the Food Dealer's License for the premises located at 2021 West Capitol Drive ("Family Dollar Store #6587").
- 2. On June 30, 2015 the City Clerk's Office provided timely notice to the Licensee pursuant to Chapters 68 and 85. The matter was scheduled for a hearing on July 7, 2015, commencing at 10:30 a.m. in Room 301B of City Hall. At said date, time and place, the licensee did appear and was represented by Attorney Kristin Pierre, One Park Plaza, 11270 W Park Pl, Suite 500, Milwaukee, WI, 53224.
- 4. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds:
 - A. Attorney Kristin Pierre stated she understands there have been concerns about maintenance of the parking lot and cars being sold from the lot. There have also been significant issues with littering and loitering. They are trying to set up a meeting with the landlord and nearby grocery store to determine where the vehicle sale issue is originating from. They will also be putting up signs to prevent loitering, panhandling and dumping, There will also be a sign threatening the towing of vehicles that are being sold.
 - B. Michael Tracy of 134541 Roundbar Road, Plainfield, IL stated the property shares a parking lot with a grocery store. He did a site visit and observed vendors selling wares in the parking lot and panhandlers. They will have employees enforcing the panhandling and loitering rules. They will also meet with the grocery store and landlord to address these issues. He states the current dumpsters are hard for some employees to secure because of the height and they are looking into replacing the dumpsters to resolve the issues.
 - C. Alderman Hamilton stated the garbage cans in the alley need to be better maintained. Pick-ups should be more frequent, and garbage gets thrown outside of the cans as well. He suggests the business participate in the business improvement district to obtain help on improving the business.



CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapters 68 and 85 of the Milwaukee Code of Ordinances.
- 2. Based on the above facts found, the Committee concludes that the Licensee, Erik D. Gast has not met the criteria of Chapters 68 and 85 of the Milwaukee Code of Ordinances to allow the renewal of a Food Dealer License without serving a ten (10) day suspension based on hearing testimony.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council should exercise its discretion to renew the Food Dealer License of Erik D. Gast, for the premises at 2012 West Capitol Drive ("Family Dollar Store #6587") with a ten (10) day suspension based on hearing testimony.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of five (5) ayes and zero (0) noes, recommends that the Food Dealer License application of Erik D. Gast for the premises at 2012 West Capitol Drive ("Family Dollar Store #6587") be renewed with a ten (10) day suspension based upon aldermanic testimony.

Said suspension is to be in effect between 12:01 a.m. on July 21, 2015 and 11:59 p.m. on July 30, 2015.



Re: Report of the renewal application of Adam D. Kirchner, Agent for Dick's Pizza, LLC, for a Class "B" Tavern and Public Entertainment Premises licenses for the premises located at 730 North Milwaukee Street in the City and County of Milwaukee, Wisconsin ("Dick's").

FINDINGS OF FACT

- 1. Adam D. Kirchner (hereinafter the "Licensee") is the holder of a Class "B" Tavern and Public Entertainment Premises licenses for the premises located at 730 North Milwaukee Street in the City and County of Milwaukee, Wisconsin ("Dick's"). Said license expires at midnight, July 27, 2015.
- 2. An application to renew said license was filed with the office of the City Clerk on May 29, 2015.
- 3. Pursuant to Chapters 85, 90 and 108 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. The Milwaukee Police Department responded with a report that could form the basis of non-renewal or suspension of these licenses on June 1, 2015.
- 4. On June 25, 2015 the City Clerk's Office provided timely notice to the Licensee pursuant to Chapters 85, 90 and 108 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes with a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on June 7, 2015, commencing at 1:30 p.m. in Room 301B of City Hall. At said date, time and place, the Licensee appeared and was represented by Attorney Vincent Bobot, 5414 South 13th Street, Milwaukee, WI 53203-1918.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing the Committee finds the following:
 - A. On June 1, 2014, Milwaukee police were on patrol in the 700 block of North Milwaukee Street. Officers observed large groups of people exit Dick's and Apartment 720 around 2:15 a.m. Employees and officers moved customers away from the front of the businesses. While these patrons were being ushered away officers observed four of five subjects fighting. During the course of the investigation, one of the combatants retrieved a handgun from an auto and placed it in his waistband. The subject was arrested. (Item noted as No. 7 on police synopsis).



- B. On September 20, 2014, Milwaukee police were dispatched to a fight at 730 North Milwaukee Street (Dick's Nightclub). The investigation revealed the bouncer got into a fight with a patron. The patron suffered a broken nose. This incident was investigated as a substantial battery and was ultimately "no processed" by Assistant District Attorney Carmody. An incident report was filed. (Item noted as No. 9 on police synopsis).
- C. On November 14, 2014 Milwaukee officer were dispatched to a battery complaint at Dick's Tavern (730 North Milwaukee Street). The investigation revealed a patron of the business called police. This patron appeared intoxicated and would not answer questions asked by the officer. The officer was unable to locate any witnesses regarding this incident. An incident was filed. (Item noted as No. 10 on police synopsis).
- D. On December 7, 2014 Milwaukee police responded to a shooting at 730 North Milwaukee Street). The investigation revealed a patron of Dick's Tavern had gone outside to smoke a cigarette when a subject attempted to rob him. The victim was shot in the abdomen. An incident was filed. (Item noted as No. 11 on police synopsis).
- E. On December 27, 2014, Milwaukee police were flagged down by security for a battery which had occurred outside of Dick's Nightclub. The investigation revealed the victim, Besart Bajrami, had been the suspect's, Arnold Naqellari, employer and that the situation ended when the victim fired the suspect. The two parties ran into each other at Dick's and Bajrami was attacked by Naqellari and three other subjects. The victim suffered a broken wrist and lacerations to his scalp and eye requiring stitches. This incident was ultimately "no processed" by Assistant District Attorney McNutt. An incident was filed. (Item noted as No. 12 on police synopsis).
- F. Attorney Bobot stated that the May 3, 2014 incident was a positive occurrence where an underage police aide was denied entry to the establishment. On June 1, 2014 the establishment and another establishment were asking people to leave at closing time. The staff did not recognize the people outside fighting, but a police officer did observe an individual go get a gun from a vehicle. On June 13, 2014 security escorted a customer out and the person was cited for refusing to leave. On September 20, 2014, security intervened with a disorderly patron. The patron attempted to hit the security guard. On November 14, 2014, the victim was belligerent and uncooperative with the police. On December 17, 2014 a robbery victim who was in a nearby parking lot came to Dick's Pizza and they called police. On December 27, 2014, two individuals who knew each other encountered each other on the premises. One of the individuals was selling pizza. When the owner found out about the fight,

the employee was immediately fired. There was another incident where a police aide was turned away. On February 20, 2015, staff called police about an intoxicated female. Staff is doing a thorough clean-up each night.

- G. Jennifer Kroyofski of 741 North Milwaukee stated that there has been an on-going issue with violence. She stated there are constant fights, but not all incidents end up on the police report. She stated she read the police report and the two individuals involved with the shooting recognized each other from being in the establishment. She has observed congregating and fighting on the street outside the establishment. She states that bouncers yelling at people to leave at bar close are disruptive.
- H. Brad Warhick of 104 East Mason Street stated he has lived downtown for several years. He states the applicant does a good job of providing entertainment and jobs.
- I. Marc Bianchini of 921 East Calumet, Fox Point stated he is the co-owner of two businesses on the block Indulge and Cubanitas. He has seen a dramatic improvement in the location over the past couple of years. He also feels safe on the block.
- J. Malta Bianchini of 921 East Calumet, Fox Point stated she owns two businesses on the block. The building has improved dramatically in the last few years. She walks through the alley after closing her own business at night and the bouncers are outside keeping the area safe.
- K. Rebecca Barress of 2017 North Hubbard Street stated she has worked on the street for six years. She states the establishment feels safe.

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapters 85, 90 and 108 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the Licensee, Adam D. Kirchner, has not met the criteria of Chapters 85, 90 and 108 of the Milwaukee Code of Ordinances or Chapter 125 of the Wisconsin Statutes to allow renewal of his Class "B" Tavern and Public Entertainment Premises licenses without undergoing a ten (10) day suspension of said licenses based upon the police report and hearing testimony. The Committee finds the police report and hearing testimony as stated above, to be true.

3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew the Class "B" Tavern and Public Entertainment Premises licenses for the premises located at 730 North Milwaukee in the City and County of Milwaukee, Wisconsin ("Dick's") with a ten (10) day suspension based upon items #7 and #9-10 of the police report and hearing testimony.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of five (5) ayes and zero (0) noes recommends that the Class "B" Tavern and Public Entertainment Premises licenses be renewed with a ten (10) day suspension based on items #7 and #9-12 of the police report and hearing testimony.

Said suspension is to be in effect between 12:01 a.m. on July 30, 2015 through 11:59 p.m, August 8, 2015.



FINDINGS OF FACT

- 1. Shanekqua R. Chambers (hereinafter the "Licensee") is the holder of a Class "D" Operator's License in the City and County of Milwaukee, Wisconsin. Said license expired on December 31, 2014.
- 2. An application to renew said license was filed with the Office of the City Clerk.
- 3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. The Milwaukee Police Department responded with a police report that could form a basis for nonrenewal or suspension of said license.
- 4. On June 29, 2015 the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the report of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the police department report on July 7, 2015 at 1:00 p.m. in Room 301B of City Hall. At said date, time and place, the Licensee did not appear.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. A notice of the hearing as well as a copy of the police report was sent to Shanekqua R. Chambers, 1823 North 6th Street, Milwaukee, Wisconsin 53212 on June 29, 2015 by U.S. prepaid first-class mail in an envelope bearing the return address of the License Division. The address of 1823 North 6th Street, Milwaukee, Wisconsin 53212 is the address given by the Licensee on her application. The envelope was not returned to the License Division by the United States Postal Service. The Licensee failed to appear at the hearing on July 7, 2015.



CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
- 2. Based on the above facts found, the Committee concludes that the Licensee, Shanekqua Chambers has not met the criteria of Chapter 125 of the Wisconsin Statutes or Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of the Class "D" Operator's license based upon nonappearance.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council should exercise its discretion to not renew the Class "D" Operator's license held by Shanekqua R. Chambers based upon nonappearance.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, recommends that the Class "D" Operator's License not be renewed based upon a nonappearance.
