# NOTABLE CASES: MPD/MFD/FPC WHILE WORKING IN THE CITY ATTORNEY'S OFFICE

Pero v. City of Milwaukee, Chief Wentlandt, Fire and Police Commissioners of Milwaukee, Case No. 05-cv-1049 (E.D. Wis. 2007) (It is not a violation of Equal Protection, Constitutional law, or discrimination to discharge a firefighter with a felony conviction).

Leslie Barber v. City of Milwaukee, Chief Hegerty, Fire and Police Commissioners of Milwaukee, Case No. 05-cv-01081 (E.D. Wis. 2007) (Establishing that Assistant Chiefs serve at the pleasure of the Chief of Police).

*Koch v. City of Milwaukee*, (LIRC 6/9/2011) (The Equal Rights Division may not exercise jurisdiction over State fair employment claims arising out of actions of the Fire and Police Commission under Wis. Stat. Sec. 62.50(11)).

Milwaukee Police Ass'n v. Bd. Of Fire & Police Comm. of Milwaukee, 787 F.Supp.2d 888,889-890 (E.D. Wis. 2011) (Establishing that probationary police officers do not have a right to a termination hearing under Wis. Stat. Sec. 62.50).

Lewis v. City of Milwaukee, Case No. 08-cv-01040 (E.D. Wis. 2012) (It is not harassment or discrimination to place a police officer unfit for duty on an extended leave).

Milwaukee Police Ass'n v. Bd. Of Fire & Police Comm. of Milwaukee, 708 F.3d 921 (7<sup>th</sup> Cir. Wis. 2013) (the Milwaukee Police Association did not have standing to pursue an appeal on behalf of its membership).

**Brooks v. Bd. Of Fire & Police Commission of Milwaukee**, Case No. 13-cv-000393 (Milw. County Cir. Ct. 2013) (Plaintiff not entitled to reappointment under FPC Rules, and the FPC is not an entity that may be sued for monetary damages).

Gonzalez v. City of Milwaukee, 124 Fair Empl. Prac. Cas. (BNA) 239 (E.D. Wis. 2014) (Chief Flynn and the FPC acted appropriately in the discharge of plaintiff). The case on appeal to the 7<sup>th</sup> Circuit; oral argument was on April 1, 2015.

**Note:** I have also successfully represented the MPD/MFD in many cases alleging wrongful termination/discrimination, wrongful arrest, wrongful search, and excessive force.
