Dear Mr. Liebergen:

We have received your claims in the amount of \$292.27, relating to damage allegedly sustained to your vehicle on January 8, 2008 at the Highway 894 on ramp west from Loomis Road and January 26, 2008 at the Renee Street turn around. Each loss occurred when it collided with a pothole.

Regarding the January 8, 2008 loss, C.I. File No. 08-S-86, the Infrastructure Services Division (ISD) records indicate this is a county highway under the jurisdiction of Milwaukee County. You may wish to contact the Milwaukee County Highway Engineer 10320 Watertown Plank Road, Wauwatosa, WI 53226. Since your loss does not involve the City of Milwaukee, it cannot be held liable. Therefore, we are denying this claim.

Regarding the January 26, 2008 loss, C.I. File No. 08-S-86-1, our investigation reveals that the ISD records indicate that prior to January 26, 2008 the City had no notice of this hazard in the roadway and because of this lack of notice the City would not be liable. Therefore, we are denying this claim.
