We have received your claim in the amount of \$353.23, relating to costs allegedly incurred after backwater from the City's sewer backed up into the basement of your residence at 5627 West Custer Avenue on May 19, 2015.

The Infrastructure Services Division (ISD) records indicate that on May 20, 2015 they responded to a call of a backwater at 5627 West Custer Avenue. They found the City main sewer to be clogged with grease. A Sewer Jet Vac was used to open the sewer, clean and restore it to proper working order. They told you that your lateral also had grease in it and that you had to have it cleaned. The lateral is the responsibility of the property owner under City Charter Ordinance 12-15. The ISD records also indicate that the sewer is on a regular cleaning schedule and was last cleaned, prior to this incident, on October 29, 2014. Because the sewer is on a regular cleaning schedule and the City did not have notice of problems with the sewer, the City cannot be held liable. Therefore, we are denying your claim.
