I took cab number 297 from Northwestern Mutual Building to the Milwaukee Amtrak station at 5:15pm on 5/15. The driver loaded my luggage into the trunk, then proceeded to start the trip. He realized that the trunk was not properly closed, and proceeded to exit the vehicle and slam the trunk, forcing it shut, without first checking to see if anything was preventing it from closing. This resulted in severe damage to the leather handle of my bag (see photo below) which he had placed in the trunk in a manner that caused it to be caught when the door closed. The bag manufacturer does not provide repair services, so I would like to request that Yellow Cab Milwaukee cover the cost of repair as this situation could have been a avoided had the driver first checked to see if anything was in the way before slamming the trunk. Please let me know what the process for filing this claim is. I have included my phone number below as well.

For the record, I would like to say that other than this incident, the driver was very polite and apologetic once I brought the situation to his attention, which I very much appreciate.



As there were a lot of cars and we were all kind of in a rush, he tried to load the suitcases as fast as he could, during which process he broke one of them, as he didn't know how to retract the handle, so he just jammed it with this fist. Upon realizing it was broken, he just left it the way it was, risking an even worse damage and threw it on top of other suitcases.

We told him to drop us off at illding, located a. . I am not sure what the speed limit was, but the gentlemen was driving at one point what I believe to be 55mph or taster, passing cars in the right lane, accelerating and stopping aggressively for absolutely no reason. My girlfriend had to grab a hold of me couple of times as she was obviously disturbed.

Once we were dropped off, my gliffriend and him unloaded the sultaceses and I was paying for the fare, which was \$7.60. Annoyed with him breaking the \$250 sultaces and for driving like a maniac, I didn't leave the tip. As I was in the process of going inside of the building, my gliffriend reminded me to grab a receipt, which I need for my company for expense reporting, as I used a company credit card. I quickly ran back to the van and asked for a receipt and he said "I don't have a receipt for this kind of s***!" He is saying that as the receipt is being printed. At this point, he is holding it at his hand, completely refusing to give me a receipt and goes on and on about me not leaving the tip: "I am not giving you a receipt....! am losing money on this...! only get to keep 10% of what I charge you...! am trying to help you and this is how you treat me...! am not giving you a receipt....why didn't you leave the tip...what kind of a man are you." These were his exact words. I am leaning into the window, on the passenger side, explaining I need the receipt and he starts driving away as I am still very close to the car. I told him "since you broke the suitcase, you don't get the tip, I guess we'll call it even."


At that point, he stops the car, gets out of the car and starts yelling at me in front of the building in front of other people, yet again about how he was trying to help, how I am not a good person. He then pulled out a stack of cash from his pocket and starts yelling "Do you want me to pay? Why didn't you tip me? I am losing money on this!" He then starts telling me how he didn't break the sullcase, as I am clearly pointing to the handle that is completely destroyed, wedged into the suitcase, with the wire sticking out, completely useless. He is continuing to yell at me, saying he was trying to help, how I didn't tip and saying he didn't do it, but at the same time pulling cash and wanting to pay. At this point, my glirifiend is super upset and asking me to back off and let it go. I start walking back to her, because I just got back from a 30 hour trip and she just got back from Colombia and a 25 hour trip. As I am walking back, other people are staring at the guy as he is continuing to yell at me. If It weren't for my girlfriend, it was at a point I would have smacked him. I asked him why he was yelling and told him to tower his voice and I refused to give him a tip. He went back inside of his van and kept yelling at me until he drove away.

I reported this incident immediately after we were dropped off and was told to email you. I would not be spending time on this and calling, especially since I haven't seen my girlfriend in over six months and just got back dead tired from the trip. The experience was so memorable with this guy that I had to let somebody know right away. When I spoke with a very nice lady over the phone, she esked if there were any witnesses. I believe there are cameras in front of the building and our security guard was helping us with bags and she saw the whole thing. There were few other building tenants around the building but I don't know their names. Also, not sure how deep you want to get into this, but there are traffic cameras, showing how fast he was driving on the way to my home.

I would like to add that the guy was very pleasant at first, seemed like a very nice guy. Just before we arrived to my building, he received a phone call from what I understood to be a friend, possibly talking about a death in that friends family. He was clearly sad, upset, was saying he was sorry, so I don't know if that was a reason for his reaction. I don't want him to get in trouble, he seemed like a nice guy, but I didn't not appreciate the fast driving, yelling at me in front of my girlfriend and other people and then breaking my suitcase.

All I want from this is somebody to talk to him, remind him not to act like a maniac, for his own good. Getting into people's faces and yelling at them never ends well. I also want someone to get in touch with me regarding my suitcase, as I would like to be reimbursed for it in the amount of \$250.00. I will take a photo of the suitcase if you need to see it and will attempt to find a same one online, or a similar one for your information and comparison.

Don't care at this point what happens to this guy, just want the money for a brand new suitcase. Any other info you need from me, please let me know.



Monday 7/22 – 5:22am:
Driver calls my cell to tell me he is downstairs. As he has arrived 8 minutes early, I told him that I will be there at 5:30am as I wasn't quite ready.
5:30am:
I called back the driver to say that I am running behind and if he could wait a few more minutes. The driver did not pick up.
5:37am:

I reached the cub. As I'm walking to the cab with my 3 bags, the cab driver starts to drive off slowly, knowing that I am walking towards him. It was asthough he was trying to make a point that I had kept him waiting. It was extremely rude. I yelled at the cab "wait wait please" and he stopped. He did not help me with my bags or open the door for me. It was a minivan which can be opened from the inside with a press of a button. He could have pressed the button to help me, but he failed to do so.

When I got into the cab, struggling with my 3 bags (hand bag, laptop and gym bag), he yelled at me saying that I had kept him waiting for 20 minutes! This was a complete lie as he arrived 8 mins early and I was only 7 minutes late to my actual pick up time of 5:30am. So theoretically it was 7 mins late. He then continued to tell me that I don't need to order a cab the night before and that there are plenty of cabs at that time of morning, and that way they are not kept waiting. I argued back with him to say that I prefer to book as I can't afford to miss my train in the morning. Then he continued to complain that I kept him waiting etc. I told him that the customer is always right. He eventually stopped yelling, and it was a ideadly silence all the way to the station.

Once we reached the station I paid. The total was \$9.25. Which by the way, that route normally costs me around \$7-8, but he clearly took the long way to make more money. I gave him \$10 and told him to keep the change. I did not give him extra because he was so rude and did not deserve a tip. In my mind, a tip is something to be earned, and not expected. Clearly he was annoyed that I didn't tip him enough, and therefore started calling me names in his language. They were obviously derogatory but I could not understand as it was in a foreign language. As I was getting my 3 bags together, and to maneuver myself to get out of the taxi, he sarcastically said "do you need more time?" It was said in a very aggressive and sarcastic tone. He did not open the door or help me with my bags. I opened the door myself, and got out of the car. He immediately drove off with the door still open. As he was driving off, he was continuing to call me names in his language. The driver, driving off like that is dangerous. I could have still had my foot in the door, or one of my bags still attached the seat. He couldn't really see. An accident could have easily been caused.


As soon as I walked into the station, I called Milwaukee Yellow Cabs and left a voice mail with the complaints department. I was angry and shaken up. Nobody deserves to be spoken to in that manner. His behavior and attitude is unacceptable. You do not treat customers like that, especially regular customers like myself who have been using Milwaukee Yellow Cab for 3 years.

I would be grateful if action is taken against this person. I have no doubt there have been other complaints about this driver. I would be extremely surprised if nobody has yet come forward.

Once we arrived I asked him what the \$3 additional charges (see attached photo) were for and he told me "extra bag, and taxes".

I told him I believed taxes are included and nobody had charged me yet for an extra bag.

I paid him (tried to leave no tip but failed), unloaded my bags (this time he at least got out of the taxi) and called his firm Yellow taxi to ask about the fees.

They said I was correct – taxes are included, and the cab driver can charge for handling bags – but none of these charges should have applied.


The dispatcher asked which cab it was and I told her 193. "Oh him - we have had many complaints about him but we can't do anything".

This occurred just north of Holt Avenue, while I was driving in the far left lane. The vehicle number is 147. At that time of day there is still quite a bit of traffic on the Expressway (I-94). He was right on my rear bumper trying to push me to go faster. I couldn't because there was another vehicle in front of me. There was a semi truck in the lane next to me. The driver eventually gave up pushing me and went over to the far right hand lane, where he was again blocked by slower traffic. Traffic eventually opened up at about Lincoln Avenue, where the driver went to the middle lane and begin driving at over 80 miles per hour, in and out of traffic. I followed him from a distance, as I was concerned about his erratic driving. He exited to go east on 94 toward the lake with a final exit at Plankinton, where he proceeded through a red light without even slowing down and continued to Wisconsin Avenue, where he turned left. I presume he was going to a hotel for a pickup.

As soon as I arrived at work (9AM). I looked up GORITEWAY's phone number and called them. My call was transferred to a recorded message. I left a message for a return call. I waited an hour. When I did not receive a phone call, I called back. I was told by the person who answered the phone that they were very busy today and that I should call back tomorrow concerning this problem.

I was shocked that they showed little to no interest in being sure that their drivers we're driving safely. I told them at the time if I hadn't heard from them in an hour that I would call the license division about this situation. When I called your department, I was told to write an email to you, which I have now done.

I do not consider racing down the expressway at speeds in excess of 80 miles per hour and going through a red light as a minor infraction. I still cannot believe that the people at GoRiteWay showed no interest in taking care of this problem immediately. I will be waiting to hear from you and hope that this is resolved satisfactorily with public's safety in mind.





This letter is intended to describe an incident that occurred on the afternoon of January 2015 around involving the driver of Yellow Cab Co-Op Taxi number 517. I entered the taxi line outside of the Amtrak station and boarded the first available taxi. I entered the vehicle with my luggage and gave the driver my destination. The driver began en route to my destination, and aside from carrying on a cell phone conversation the ride appeared to be fairly typical. As we neared my destination the driver ended his cell phone conversation and asked for my address again. Being that traffic on Prospect Avenue was very busy as usual, I asked the driver to pull into the driveway of the apartment building neighboring my own. He did so and ended the trip requesting that I pay cash. After telling him that I did not have cash and would be paying with a Visa, I was told that his machine was not working but I could give it a try. After several failed attempts with the card transaction, he entered his glove compartment and proceeded to hook up a machine. After this, I was instructed to try processing my payment again. After doing so my payment was successfully processed and the driver began to pull out of the driveway into oncoming traffic on Prospect Avenue. He stopped directly in front of my apartment and waited for the payment receipt to print. In doing so, he stopped traffic and several cars began to blow their horns at the driver. I am not exactly sure why the driver pulled into the street versus finishing the transaction in the driveway.

After signing my receipt I asked the driver if he would pull up his seat and allow me to exit on the driver's side. After refusing I asked that he pull up a few feet into an open space that would allow me to get out without entering oncoming traffic. He became increasingly hostile as he moved his vehicle up and out further into the street. At this point cars were blowing excessively and zooming pass the driver in frustration. The driver then told me to get out and yelled "Fuck You". Afraid for my safety I began to gather my luggage and exit the vehicle slowly so that oncoming vehicles were aware that I was attempting to exit. The driver then began to exit his vehicle continuing to tell me to "Get the Fuck out". I exchanged words with the driver telling him that I would be reporting the incident to the city. As he approached me, I immediately jumped out of the vehicle dropping several of my items into oncoming traffic. He continued to

yell obscenities and stated, "Tell whoever you want. You can tell Obama." He then re-entered his vehicle and sped off. I waited for him to leave before retrieving my items that had fallen onto the street.

I am extremely disappointed in the events that occurred that evening. Not only was I treating poorly as a customer, but I was verbally assaulted and hostilely confronted. As a frequent user of taxis and rideshare services I have never encountered such an unprofessional, intimidating and blatantly disrespectful driver. While past experiences of poor service and refusal to accept credit cards has resulted in me avoiding Milwaukee taxis, I never imagined that an incident to this extent would occur. As a citizen and employee of Milwaukee, I am disgusted by the actions of the driver. While I understand that this could be seen as an isolated incident, it speaks volumes to the culture of Milwaukee taxi companies and the lack of accountability. The driver involved in this incident should not be allowed to service citizens of Milwaukee. Furthermore, Yellow Cab Co-op and the City of Milwaukee needs to be held responsible for ensuring that poorly trained drivers are not allowed to continue violating the rights of taxi passengers.

I have also filed a complaint with the Yellow Cab Co-Op and as of January 28, 2015 I have not heard from anyone regarding this incident. Please feel free to contact me about this issue. I look forward to discussing this incident and ensuring that the driver is held responsible for his actions.
