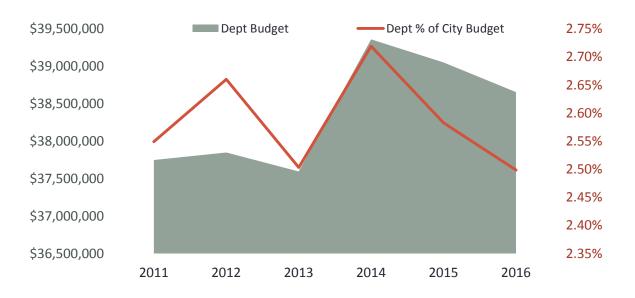

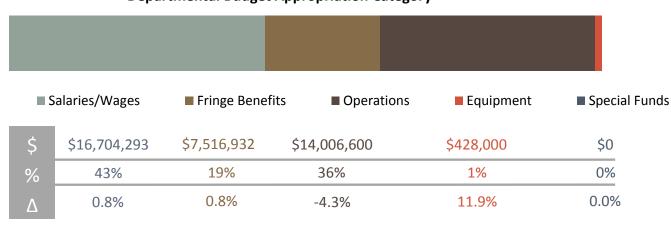

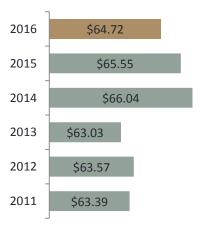

Budget per Capita



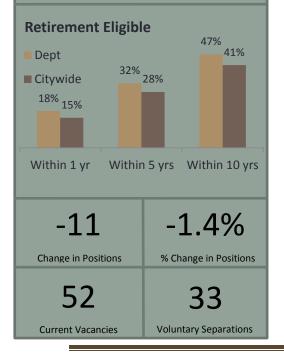


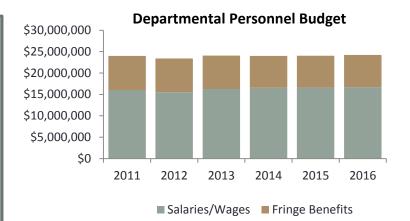

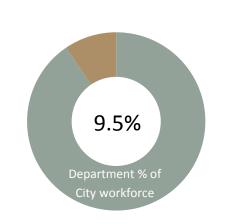

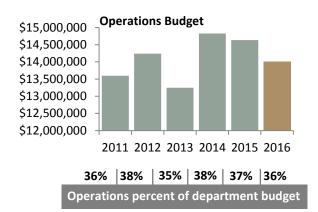

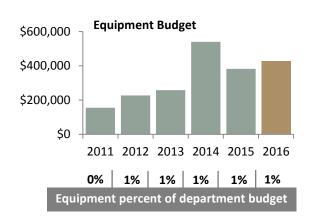

City Hall Foundation Project

Funding is provided (\$13 million) for the stabilization of the northeast corner of the building and the relocation of the basement mechanical room.

Project Civic Access

The City is negotiating with the Dept. of Justice to determine the scope and timing of the work that will be required to bring City facilities into compliance with the requirements of the ADA. 2016 will be a planning year for DPW. Significant capital expenditures may be required in 2017 and beyond.

Diggers Hotline Staffing

In addition to the new positions proposed for 2016, on October 7, 2015, the Finance & Personnel Committee recommended the creation of 3 new Locator Technician positions and 1 new Locator Technician Crew Leader position. The 4 new positions will be funded in part by the savings realized by the lower job classification of the new positions.

Roadway Condition

The City hired a consultant to survey the condition of the street network.

Compete Milwaukee

Nineteen transitional workers were used to patch potholes and perform other street-maintenance activities. The department expects to use 25 workers in 2016.

Pay for Performance

The department is developing a pay-forperformance plan. The plan, which creates a career ladder for all technical and professional positions, is nearly ready for review by DER. Career ladders for clerical and IT staff will be developed by DER.
