AMENDMENT INTENT

This amendment creates a Special Purpose Account funded at \$60,000 to pay five new transitional job placements that will function as Inspectors who will verify residence qualifications for Resident Preference Program (RPP) workers and other duties as assigned.

BACKGROUND

- 1. As part of its mission the Office of Small Business Development tracks citywide workforce data across various projects and contracts with Resident Preference Program (RPP) requirements as outlined in Chapter 355 of the Milwaukee Code of Ordinances.
- 2. In 2015, as part of the Compete Milwaukee Initiative, the City partnered with the Milwaukee Area Work Force Investment Board (MAWIB) and United Migrant Opportunity Services (UMOS) to fund 135 transitional jobs for long-term unemployed men and women to get immediate work to support themselves and their families while seeking unsubsidized employment.

DISCUSSION

- 1. This amendment creates a Special Purpose Account funded at \$60,000 to pay five new transitional job placements that will function as Inspectors who will verify residence qualifications for Resident Preference Program (RPP) workers and other duties as assigned.
- 2. It is the intent of the sponsor for these 5 Inspector positions to be part of the Compete Milwaukee transitional jobs program funded for 6 months at \$10.10/hr.

EFFECT

- 1. The net impact of this amendment on the 2016 Budget is \$+60,000.
- 2. The tax-levy impact is \$+60,000, resulting in a tax rate impact of \$+0.002 per \$1,000 assessed valuation.
