



If you previously paid the license fees you may be eligible for a refund, except for a portion of the fee that may be retained, by bringing in the receipt or filing an application for a refund within one year to date of Common Council action with the License Division, Room 105, City Hall. Your Provisional Public Passenger Vehicle Driver's license must be immediately surrendered to the License Division.
