Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. Investigation revealed two males robbed an employee and another patron while they were standing outside in front of Lorenzo's bar. Both suspects were armed with guns and obtained property before fleeing the area. Police spoke with the bartender Jimmie Harris, who stated he was inside and didn't observe the incident. Lorenzo's does not have video surveillance inside or outside the bar.

- 9. The applicant owes \$225.00 to the city of Milwaukee for Parking Citations with a violation date of 08/02/2004 and a due date of 01/17/2014 under case #04082484.
- 10. On 12/14/2013 Milwaukee police responded to a Battery complaint at 9403 West Silver Spring Drive #8. The caller stated he had been at Lorenzo's tavern (1218 West Cherry Street) earlier in the morning and another patron had punched him in the face. The caller received stitches at Mt. Sinai Hospital. Milwaukee police incident report # 133480101 filed.
- 11. On 01/18/2014 Milwaukee police responded to a Fight at 1206 West Cherry Street. Investigation revealed that a shooting had taken place in front of the tavern located at 1218 West Cherry Street (Lorenzo's). Witnesses told police that an unknown person began shooting at everyone in front of the business with an AK-47. The windows of a vehicle parked outside of the business were damaged as well as the victim being struck multiple times by gunfire. Milwaukee police incident report # 140180008 filed.
- 12. On 02/22/2014 Milwaukee police conducted a Traffic Stop of a vehicle that was leaving the area of the bar. The driver of the vehicle told officers he and his friends had just left the tavern and observed a fight occurring outside the business. The driver told officers that one or two of the subjects involved in the fight possessed firearms. The officers involved in the traffic stop then went to the business and were told by the applicant that everything was fine.
- 13. On 02/23/2014 Milwaukee police responded to a Battery Cutting at St. Joseph's Hospital. The victim told police she had been at Lorenzo's (1218 West Cherry Street) around 12:00am when a fight broke out inside the business. The victim decided to leave the business in order to avoid the fight. The victim later noticed she had a small cut on the right side of her abdomen, but does not where or when she received the injury. Milwaukee police incident report # 140540024 filed.

14. On Monday 04/28/2014 Milwaukee police conducted an investigation at 1218 West Cherry Street (Lorenzo's) based on information that the business was open in violation of the plan of operation, which indicated that the business should be closed on Monday. Officers found the business to be open, with several patrons eating and drinking on the premise as well as a lit "Open" sign on the west side of the business. The Class B License displayed at the business includes hours of operation Sunday, Tuesday through Thursday, Friday and Saturday but does not include hours of operation for Mondays. The applicant received two citations and a warning for a Food Dealers violation.

15. On 07/26/15 at 2:17 am, Milwaukee police were dispatched to 12th and Cherry for a male shot inside a vehicle. The auto was located at 1218 W Cherry Street. At 2:24 am, a squad was flagged down by security from Mt. Sinai Hospital regarding a gunshot victim that was just brought into the emergency room. It was determined to be the same individual reported to have been shot in the vehicle at 1218 W Cherry Street. Investigation revealed that both the suspect and victim were in the bar prior to the shooting. An argument between the two subjects occurred outside of the bar and the licensee reported hearing the argument and exited the bar in an attempt to resolve the issue. When the licensee thought the issue was resolved, he returned inside the bar. Gunfire then began outside the premise resulting in the victim being shot and later dying from his wounds. Multiply casings from several different guns were recovered from the scene.

16. On 10/17/15 at 1:47 am, Milwaukee police began monitoring the premise located at 1218 W Cherry. Police witnessed 3 male patrons entering the premise at 2:05 am and 2 female patrons shortly after in which the premise has a 2 am closing time. Police entered the premise at 2:17 am and found the bar had their lights on, music was being played and a DJ was operating music equipment. Police also found one subject behind the bar and the licensee was on scene and police counted 14 patrons inside the bar. One patron was observed to have an open ½ pint bottle of Remy Martin Cognac and a plastic glass in his hand. On top of the bar were 5 plastic glasses with a green liquid and a bottle of Bud Light. There were patrons seated at the bar and also at tables. Officer spoke with the agent and asked if he was aware of the 2 am closing time for his premise and he acknowledge he knew the closing time.

On Saturday, October 17, 2015 at 1:47am, Squad 3465 began monitory the premise. Officers witnessed 3 male patrons enter the premise at approximately 2:05am and 2 female patrons enter the premise at approximately 2:11am. The premise has a 2:00am closing time as part of its Class B Tavern License. P.O. YINKO and I entered the premise at 2:17am. My initial observations upon entering the premise were: the lights were on, music was being played, a DJ was operating music equipment, there was one subject behind the bar, the licensee was on scene and I counted 14 patrons inside the premise. I observed 1 patron seated in a chair in the southeast corner of the premise with an open ½ pint bottle of Remy Martin Cognac and a plastic glass in his hand. On top of the bar were 5 plastic glasses with a green liquid and a bottle of Bud Light. There were patrons seated at the bar, seated at tables against the east wall of the premise and standing.

I spoke with the licensee and asked if he was aware that the closing time for his premise was 2:00am on Friday nights and he acknowledged he knew the closing time was 2:00am.

This report is written by P.O. Michael FASULO, District #3, Late Power Shift.

This report is a summary of reports filed by Detectives and Officers reports.

On Sunday July 26, 2015 at 2:17am, Squad 3331 was dispatched to N. 12th St. and W. Cherry St. for a male subject shot inside a vehicle. The vehicle was located at 1218 W. Cherry St. located on the street in front of the premise. At 2:24am, Squad 3450 was flagged down by security from Mt. Sinai Hospital regarding a gunshot victim was just brought into the emergency room. It was determined this was the same individual reported to be shot in the vehicle outside the premise.

Both the suspect and victim were patrons of the premise. An argument between the 2 began outside of the front premise. The licensee heard the argument and exited the premise in an attempt to resolve the issue. When the licensee thought the argument had been resolved he returned inside the premise. Gunfire then began outside the premise resulting in the victim being shot. The victim died from a result of his gunshot wounds.

The Milwaukee Police Department Intel Fusion Gun Unit examined 18 casings that were recovered from the scene 16 9mm and 2 45acp. It was determined that from the 16 9mm casings that were analyzed 3 separate 9mm handguns were used and 1 45acp handgun was used.

- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Mustafa was placed in a MPD squad car to allow officers to conduct a thorough investigation. Asad Mustafa initially gave officers a false statement about a firearm being kept in the store but later retracted his initial statement. A firearm was later recovered in the back of the store in a garbage can that was placed in a sink. A single spent cartridge was recovered from a separate location in the store.

2. On 11/09/13, Milwaukee Police were working the Wisconsin WINS tobacco Initiative and had an underage student enter 3627 W Lisbon Avenue. The clerk stated they were .65 a piece, however if he bought Maverick cigarettes, they would be 2 for \$1.00. The UC officer was charged \$1.00 for Maverick cigarettes. Prior to the sale to the UC officer, the officer observed a sale of a single cigarette to a customer that was ahead of him. Due to attempts at establishing a pattern for this violation, uniform officers did not enter the store or advise the licensee or employees of the violation to which they contributed in at this time.

On Wednesday, May 21, 2014 an undercover operation was conducted regarding the illegal sale of single cigarettes occurring at 3627 W. Lisbon Ave "Ashraf Foods". This establishment does hold a valid Cigarette and Tobacco license through the City of Milwaukee.

This operation was conducted in response to complaints made by the Washington Park Association, which is comprised of residents in the Washington Park area, that are concerned with the illegal sale of single cigarettes occurring at the above listed convenience store.

At 3:08PM, P.O. James HUNTER, who was operating in an undercover capacity (plain clothes) did enter Ashraf Foods and was able to purchase two single cigarettes, "Maverick" brand, from the employee behind the register. P.O. HUNTER stated that the employee charged him \$1.00 in U.S. currency for said cigarettes, which he (the employee) had to open a new pack in order to give him (P.O. HUNTER) the two. Using a predetermined dollar bill (Serial #G52791971 C), P.O. HUNTER gave said dollar to the employee in exchange for the cigarettes, P.O. HUNTER initially attempted to purchase two "Newport" brand single cigarettes, but the employee advised P.O. HUNTER that they would be .65 cents apiece. However, the employee told P.O. HUNTER that he would be able to purchase two Maverick brand cigarettes for \$1.00, which is what he purchased. It should be noted that P.O. HUNTER did observe the same employee sell a single cigarette to a patron, who was ahead of him in line. P.O. HUNTER described the employee that sold him the single cigarettes as a Middle Eastern male in his 60s, approximately 5'4, wearing glasses. Due to attempts at establishing a pattern for this violation, uniformed officers did not enter the store or advise the licensee or employees of the violation to which they contributed in at this time.

On Saturday, 09/20/14, I was assigned to work the Wisconsin WINS Tobacco Initiative, which checks area vendors for age compliant tobacco purchases. Assisting in this assignment was: Xavier T. ASHFORD B/M 04/07/97 of 4506 N. 21st St. ASHFORD is 17 years old and not of legal age to purchase tobacco.

At approximately 11:45am., ASHFORD entered Ashraf Foods, located at 3627 W. Lisbon Ave., and purchased a 3 pack of White Grape flavored Jackpot Cigars, from the cashier described as A/F 40's wearing a grey and black sweater. I entered the store and identified the cashier based on the description as Zahra A. Mustafa A/F 09/20/64. Mustafa initially denied the sale, then after viewing a photo of ASHFORD, stated "I may have sold it to him, because I was distracted and on the phone at the time of the sale".

Dear License Committee Members.

Washington Park Partners opposes the use of Ashraf Foods at 3627 W. Lisbon Avenue as a convenience store and the applicant's Food Dealer Retail Application Renewal. Washington Park Partners is a collaborative of neighborhood residents, businesses, organizations and other stakeholders working together to create a thriving and safe neighborhood. The renewal of the existing use (a) significantly impairs the use, value and enjoyment of other property in the neighborhood and (b) does not protect the public health, safety and welfare.

In June 2015, Washington Park Partners met three times with the owner-operator to discuss the current building condition and business operations. In regards to improving the exterior façade of their building, the operator applied for a Washington Park Business Improvement Grant, for repairing and securing exterior doors and a window on the building. In order to qualify for the grant, a business must sign the Washington Park Good Business Agreement(see attached), which the owner agrees to improve the façade and signage of the building, address nuisances such as the removal of dead payphones, litter, and loitering, and not sell blunt tobacco products typically used as drug paraphernalia amongst other requirements. The operator would not sign the Good Business Agreement because of a desire to continue selling tobacco products and unwillingness to address signage and façade (see attached). Due to the unwillingness to sign the Standards Agreement, poor building conditions, loitering, products and lack of involvement with the surrounding community, the application was rejected by the WPP Business & Jobs Committee.

Use, Value and Enjoyment of Other Property. Washington Park has recently seen millions of dollars of investment in the area and the current use as a convenience store is not consistent with the other development in the area. Three blocks east on Lisbon Avenue from this Property is Autumn West Safe Haven, a \$2 million real estate development built in 2012, which houses 21 people who are homeless and living with mental illness with immediate shelter and assists those individuals to become healthy and independent. One block east, Progressive Community Health Center, a \$10 million, 42,000 square ft. community health center was completed in 2015. The new space includes an additional exam and procedure rooms, dental suites, a health education center, radiology and mammography services, and an area for specialty care access. This increased capacity will allow the agency to accommodate an additional 11,000 patients annually. One block west at 3726 W. Lisbon Av., Milwaukee Living LLC is currently undertaking a \$400,000 renovation of the former blighted. vacant "Charlet" mixed-use apartment building for affordable housing, and to open a day care center and the office for SGR Construction Contracting on the street level commercial spaces. In addition, two blocks west, Easley Construction is also undertaking renovation of a former city-owned mixeduse building at 3830 W. Lisbon for conversion into commercial retail space and residential apartments. The traffic and congestion a convenience store attracts, diminishes the use, value, and enjoyment of the major investments nearby property owners have made recently in the area, and the

existence of these types of stores may deter future investments and further inhibit additional revitalization along Lisbon Av.

Threat to Public Health, Safety, and Welfare. Milwaukee City Ordinances 295-311-2-d-1 indicates the geographic concentration of the proposed use is evidence of a threat to public health, safety and welfare. As indicated by the attached map, there is an overconcentration of convenience store uses already in the neighborhood. There are approximately twice as many convenience stores in our neighborhood than the city average. There are five convenience stores within a five block radius of the property, three of which have existing liquor license, in addition to the twenty-six licensed food operators within the Washington Park neighborhood. Organizations like Autumn West and Progressive Community Health Center support individuals suffering from mental health issues including substance abuse and these individuals receive treatment one block away from the property.

Amendment to Application and Plan of Operation Standards for the Washington Park Neighborhood

Applicant amends its Application for Food License and/or Liquor License to include the following.

I. Basic Requirements

A. Communication

- <u>Community Liaison Meeting</u>. At least 14 days prior to Applicant's scheduled hearing before the licensing committee, Applicant will schedule a meeting with the appropriate Milwaukee Police Department (MPD) representative to under a CPTED (Crime Prevention through Environmental Design) analysis. A prospective licensee further agrees to implement reasonable recommendations resulting from the analysis.
- <u>Contact Information</u>. Applicant's Contact information is as follows. Applicant agrees to update this information with the Washington Park Partners (WPP) office within 48 hours of any changes:

- <u>Community Meetings</u>. New applicants or existing licensees shall be expected to attend at least one MPD District Three Crime Analysis meeting or one WPP Jobs & Business Committee meeting every three (3) months. New applicants or existing licensees further agree to maintain a positive and constructive relationship with the WPP including participating in a dialogue with WPP to improve communication.
- <u>Notice of Changes</u>. Existing licensees agrees to consult with WPP before making any changes to its existing plan of operation or applying for any additional licenses.

B. Physical Improvements

- <u>Façade</u>. Applicant agrees to make the improvements listed on Exhibit A within 60 days of receiving Applicant's license.
- <u>Nuisances</u>. Applicant will work with WPP, MPD, and neighborhood groups to identify and remove any potential source for criminal activity (i.e. removing pay phones, removing bus shelters, etc).
- <u>Signage</u>. Applicant shall remove any existing sign that is hand painted or in violation of the
 City of Milwaukee sign regulations. Applicant will install up to one permanent sign on up to
 two sides of its building. Signage must be consistent with the City of Milwaukee
 Ordinances, the Guide to Storefront Signs (attached as Exhibit B) and the WPP Sign
 Guidelines (attached as Exhibit C). Applicant shall not include the advertisement of
 alcohol or tobacco as part of its primary signage.

- Other Signage. Applicant agrees not to cover more than 10% of window(s) with advertising, shelving, or other items that blocks the view through the windows. Applicant agrees not to post any flyers or advertising on entrance door.
- <u>Cameras</u>. Applicant will install digital cameras inside and outside of the store with access
 to digital video footage given to MPD and neighborhood groups upon request. The
 cameras will operate 24 hours a day, record at least 1 week of memory, and cover front
 entry, side walk, parking lot and cash register.
- Payphone: Applicant agrees to keep the licensed premise free of any an all pay phone(s) or other phone that is available for public use.
- <u>Lighting</u>. Applicant will install appropriate lighting to front, entrance, side(s) of building and parking lot.

C. Operations

- No Loitering. Applicant agrees to enforce no loitering by (a) Installing "No Loitering" sign(s) made of durable material, no spray paint or hand paint to building, (b) not allowing any persons to loiter outside the store or inside the store, (c) agree not to knowingly serve individuals who loiter in district, (d) contact MPD immediately when someone does not leave after you have requested they leave, and (e) complete/submit "Standing Complaint" form with MPD when loitering occurs.
- Access to Healthy Foods. Applicant should consider providing access to healthy food options for customers including fruits and vegetables.
- Prohibited Items. Applicant agrees (a) not to sell single cigarettes, (b) not to intentionally break packages of any liquor, beer, or malt beverage, (c) not sell individual can or bottles of malt beverages in greater than 32 ounces, (d) not sell products such as blunt cigars, blunt wraps, chore boy, love roses or other materials known to be used as drug paraphernalia.
- <u>Concealed Display</u>. Applicant agrees to not display tobacco products (i.e. cigarettes, cigars, etc.) outside, through windows, at front of counter and/or near "kid friendly" items (i.e. candy, chips, gum, etc.). Applicant agrees to move all tobacco products to rear of cash register.
- <u>Refusal of Service</u>. Applicant agrees not to sell alcoholic products to persons who are intoxicated or currently acting in a disorderly manner. Applicant also agrees to not allow open intoxicants or public consumption of alcohol on their premise.
- Repairs. Applicant agrees to repair any broken window or other damage to property within 5 business days.
- Graffiti Removal. Applicant agrees to remove any Graffiti within 24-48 hours and will report to WPP Neighborhood Coordinator within one week of occurrence.
- <u>Trash Removal</u>. Applicant agrees to clean the area around the store at least once a day, including city sidewalks and curbs.
- Reporting of Crimes. Applicant agrees that, in the event a crime occurs on your premise, applicant will immediately report to the MPD. Applicant further agrees to fully cooperate

with any and all police investigation(s) and to provide any of all information it possesses relating to the investigation and criminal activity under investigation. Applicant will keep a written record of any occurrence of crime on or near property.

- Responsible Beverage Course. If any employee is allowed to sell or serve alcohol at the location and is not licensed by the City of Milwaukee, then such employees will complete a responsible beverage Course offered by the City of Milwaukee.
- No Hoods or Masks. Applicant will post and enforce a no hoods or masks policy.



Non Illuminated Signs

GOOD



Non-Illuminated signs should be hung perpendicular to the building façade. Signs should be hung using wrought iron looking fasteners. Sign itself should be made of durable outdoor material and be 3 dimensional and well designed.



Alternatively, a sign can be placed above the store front window. Again signage should be 3 dimensional and well designed.

BAD




Cheap one dimensional signs printed on cardboard, plywood, or corrugated plastic should be avoided. Simple undersigned text should also be avoided.



Hand painted signs of all kinds should be avoided. Only one sign should be used and placed similar to the pictures at the left. Sandwich board signs should be avoided.

Illuminated Signs

GOOD



Signs should be illuminated using well designed architectural lighting that should either "up-light" or "down-light" the sign.

BAD



Back lit sign boxes, like the one pictured above, should be avoided.



Alternatively, a well designed sign could be back-lit as shown above.



Neon signage should be avoided.

Too many signs give customers an impression of clutter and disorganization.

ow do you make sure customers know your business exists? Most businesses answer that question with one word: signs. They know signs promote awareness of their business name, products, hours, and special features that attract an impulse shopper.

But when it comes to signs, "more" isn't "better." Research shows signs like those in the picture above don't attract shoppers. As shoppers search for information among so many competing signs, the message of each one is lost. Based on the impression they receive from the signs, shoppers may conclude the store is disorganized and cluttered.

There's another reason "more" isn't "better." Milwaukee's zoning ordinance restricts the amount and type of signs that businesses may display. Businesses are subject to citations from a building inspector if they have more signs than the code allows, types of signs not allowed by the code, signs installed without permits, and damaged or abandoned signs.

This customer information sheet tells you what kinds of signs you may display, how to get sign permits, and sources of assistance to pay for quality signs for your business.

What kind of permanent signs may I have for my business?

Permanent signs contain information like the business name, type of services or products available, hours of operation, and so on. Businesses are allowed to display this information on permanent wall signs, projecting signs, lettering painted on clear window glass, neon signs, and lettering on the edge of window awnings.

Several types of wall signs are permitted: a professionally painted boardtype sign, a cabinet box-type sign with a lexan or plastic panel insert, or individual letters mounted on the building.

All permanent signs require a pennit from the Milwaukee Development Center. If your business is in a locally designated historic district, the Historic Preservation Commission must also approve the sign.

What kind of permanent signs are not allowed?

Exterior signs made of paper, cardboard, or flexible plastic are not allowed. Banners are not allowed.

Guide to Storefront Signs

How large can my permanent signs be? How many can I have?

The amount of signage you may display depends on the zoning district in which the property is located.

In the most restrictive zoning districts, businesses are allowed to have a maximum of 18 square feet of wall signage. This can be one sign or multiple signs; however, the total of all the signs added together may not exceed 18 square feet. In the most restrictive zoning districts, businesses may also have one projecting wall sign, no more than 12 square feet in area. If you have a non-lighted awning, you can have 10 square feet of signage on the awning. If you have an internally lighted, translucent awning, you are allowed to have only 5 square feet of signage on the awning.

Any information or graphics relating to your business painted directly on an exterior wall will be treated as signs, and counted in the calculation of how much signage you are allowed to have.

Some zoning districts allow more signage. Call the Milwaukee Development Center at (414)286-8210 to determine the amount of signage allowed for your building. You must provide the exact address of your building.

Are temporary signs OK?

Temporary signs are typically paper or plastic signs and displays that advertise special sales or promotions. Temporary signs are allowed under these conditions:

- The sign must be installed inside the window, not on the exterior
 of the building.
- 2. The sign must be displayed for no more than 30 days.
- All temporary sigus, added together, may cover no more than 25% (one-fourth) of the business's windows.


Temporary signs do not require a permit. However, if the temporary signs you install do not meet these three conditions, you are subject to a citation from the building inspector.

If you currently have temporary signs that are mounted outdoors, have been up for more than 30 days, or cover more than 25% of the window area, you must remove them now.

Special rules for store windows

Milwaukee ordinances require windows on retail businesses. At a minimum, windows must exist in a clear vision zone that starts about 3 feet from the floor and extends vertically to the spot 7 feet above the floor.

New buildings must be designed and built to meet these ordinances. For existing buildings, existing windows must be maintained and may be enlarged, but generally may not be reduced in size. Existing windows may not be painted over, blocked or filled in to restrict the view into the business from the street.



The window requirement affects the amount and type of signs that may be displayed in windows. It also affects what fixtures may be placed in front of windows inside the store.

Here are the rules:

- 1. Only two kinds of permanent signs are allowed in windows: individual letters painted on clear window glass, and neon signs consisting of individual letters. The permanent sign in the window may not obscure the view into the store in the vision zone. Permanent signs in the window may cover up to 25% (one-fourth) of the window area.
- Display racks, point of purchase displays, and other items that significantly obscure the view in and out of the store may not be placed in front of windows in the vision zone.
- Temporary signs may cover no more than 25% (one-fourth) of the store's window area.

What is an illegal sign?

Any permanent sign that was hung or mounted on a building or in a window without a sign permit is an illegal sign. Any temporary sign that doesn't meet the conditions listed on the previous page is an illegal sign. This is true even if a previous operator of the business put up the sign.

Anything put up for more than 30 days that displays the name of the business, services or products offered, special promotions, or even graphics depicting products is a sign and needs a permit. There are some small exceptions, such as small, neatly applied emblems relating to credit cards accepted, business associations, and hours of operation.

Guide to Storefront Signs

What should I do if I have an illegal sign at my business?

If no permits exist, you may either remove the sign, or apply for a permit for the sign. The permit will be granted if the size and other factors are allowed by City ordinances. If the existing sign does not meet the ordinances, you'll be required to remove it or alter it to meet the law. If you fail to take action to correct or remove illegal signs, you will receive a citation from the building inspector.

How can I find out if any of my existing signs are illegal?

The existing signs on your business may remain if they were installed with permits. If you cannot find permits in your files for each of the signs on your building, you can check the city files at the Milwaukee Development Center to verify that you or the previous operator took out permits. Permit files are available for public inspection from 8 a.m. to 4:30 p.m., Monday through Friday. The Development Center is located at 809 N. Broadway, first floor.

What are the penalties for illegal signs?

If a building inspector orders removal of illegal signs, and the property owner does not remove them, the owner faces significant financial penalties. The owner is subject to reinspection fees that range from \$50 to \$300 per reinspection. An owner who failed to remove illegal signs for a year would be charged reinspection fees of nearly \$3,000. The owner also is subject to citations that carry a fine of up to \$320 a day, and a municipal court fine of up to \$150 per day.

When I close or move my business, what should I do about the signs?

When a business leaves a location, the signs pertinent to that business must be removed. If you are a tenant, talk to your landlord to decide whether you or the landlord will remove the signs.


If a new business will be moving in immediately, a box-type sign cabinet may be re-used by the new business operator by inserting a new "face" in the sign. A permit is required to put this new face in. If a new business is not moving in within 90 days of the former leaving, a blank panel may be inserted temporarily until a new business rents the space. In no case can a sign box be left with a broken or missing sign panel for any length of time.

In cases where totally new signs or awnings are being put up for a business, the old signs they replace must be completely removed.

If signs belonging to a former business are not removed, the property owner will receive a citation from the building inspector.

Where do I apply for sign permits?

To apply for a permit, you need to present drawings and measurements of the proposed signs, photos of your business, and a permit fee to the Milwaukee Development Center, located on the 1st floor at 809 N. Broadway. The Development Center is open from 7:30 a.m. to 4:30 p.m., Monday through Friday. Call (414)286-8210 for information about how many and what types of signs you may install. Information about the permit process is available on the Development Center's web site, www.mkeded.org/build. Click "customer information and applications" and consult the article titled "Signs."



How can I improve the signs on my business?

Following these guidelines will help you achieve signage that conveys a positive image of your business.

- Many buildings were designed with sign bands. These are areas above the front door with space for signage. If your building has a sign band, install your sign in the band rather than at some other spot.
- 2. If you want signage on a building awning, choose an unlighted cloth style, rather than a lighted plastic model. You'll be allowed to devote a larger portion of the awning to your message, and your building will have a more distinctive look than would be achieved with a"pre-fab" plastic awning.
- If the windows of your business have been blocked in or painted over, open them upl Remove the paint! Install clear glass that allows your customers to see inside your business.
- Avoid painting sign information directly on the wall. Painted wall signs are vulneable to graffiti, and they're hard to maintain.
- If you've got a broken sign at your business, repair or remove it. Broken signs are illegal, and they send a negative message about your business and your neighborhood.

He saw what appeared to be a bullet hole in the upper left corner of the door. A mark was found on a decorative pillar about 20 feet inside the tavern. A misshapen round was found by Willie Neely on the sink behind the serving bar. This incident does not appear to be related to the shooting at 4428 W Lisbon Ave.

Page 5 RE: NEELY, Ralph

16. On Saturday, 5-12-2001 at 2:22am Milwaukee Police were dispatched to 4538 W Lisbon to respond to a subject down called in by Milwaukee Fire Dept. They observed a male about 45 years old lying in the parking lot of Ralph's Lounge. The victim identified as Tony Carter was unconscious and bleeding from his head. He was conveyed to Froedtert Hospital accompanied by a police officer.

A hospital security person, per their policy, searched Carter's belongings and discovered a clear plastic baggie containing 20 corner cut bags containing suspected crack cocaine. The security person gave the suspected cocaine to the police officer who conveyed it to the Vice Squad where it was tested positive to cocaine (.2 grams). Police Department records indicated that an anonymous female called that a black male was stomped to death, he's bleeding.

At the scene, officers observed a blood trail, leading from the victim to the tavern. Officers interview the licensee, **who was uncooperative**, who related that the victim had been given a "Counterfeit" one-hundred-dollar bill and pulled a gun, which was taken away from the victim. And used to beat the victim. One of the investigating officers "followed the blood trail into the tavern, around the bar and into the archway to a back room of the tavern. There was what appeared to be a large area of blood spots in this archway. This area was damp and appeared to have been cleaned up. Directly in front of these spots was a portal wet-carpet cleaner, which was plugged in. (Mr.) Neely denied that there was an attempt to clean up blood spots yelling "you must be fucking crazy, telling me this is a crime scene!" (Mr.) Neely repeated denied that any incident occurred inside of the tavern. On the east entrance where the blood trail entered the tavern, was a wooden porch, with brick stairs. This stairway was wet, consistent with being washed down with water. (Mr.) Neely denied that there was any attempt to clean up any blood, inside or outside of his tavern. (Mr.) Neely was extremely uncooperative with police, refusing to answer questions and attempting to order the (the police) to leave his tavern."

17. On 05/30/2001 at 12:59 AM officers responded to Ralph's Lounge at 4538 W Lisbon Av regarding a shooting. Investigation revealed that several patrons had been shot during a gunfight IN the tavern. Four patrons received various gun shot wounds, however, none were life threatening. Mr. NEELY, who was on the scene at the time, was described by the investigating officers as uncooperative. Mr. NEELY was observed sweeping up shell casings and bullets. Mr. NEELY was also over heard saying to patrons "Why are giving the police all that information. They don't need to know all of that". (Or words to that substantial effect.) Officers also discovered one 20-year-old patron, who had been sold alcohol by Mr. NEELY.

- 18. On 06/08/2001 at 12:30 AM officers made a lawful inspection of the licensed premises at 4538 W Lisbon Av, Ralph's Lounge. Officers observed a man, who was identified as a security guard. This guard was armed with a 9 MM semi-automatic handgun, in a holster, in plain view, however, he was NOT in any type uniform. Incident Report Filed
- ❖ NOTE: On 06/21/2001 the Class B Tavern license renewal filed by Ralph E Neely was withdrawn. He was facing a possible license denial. On 06/25/2002 the applicant's wife, Sandra POLK applied for a Class 'A' and Malt license for the above address. That application is still pending before the Utilities and Licenses Committee.
- 19. On 10-14-05 at 11:34pm, Milwaukee Police were dispatched to 4538 W Lisbon for a shooting. Investigation revealed a male subject, (identified as Kenneth McDade b/m 12-20-70 3620 N 12th St) was shot four times. McDade stated prior to his arrival at Ralphs Coffee Shop, he had snorted cocaine. He then arrived at Ralphs and had a couple of beers when a male approached him and stated, "Keep my name out of your mouth!" McDade stated words were exchanged and it then became a physical altercation. McDade stated the male left the tavern but returned later, walked up to McDade and stated, "Bitch Ass Nigga" and then started shooting. No violations were observed at the tavern and CIB handle the shooting investigation.

20. On 01/29/10 at 10:05 pm, Milwaukee police were dispatched to 46th and Lisbson for a Shots Fired complaint. An anonymous caller stated that a security guard from Ralphs Coffee was running after a vehicle shooting at it and further stated that 15-20 shots were fired. Milwaukee police also received two additional calls regarding shots being fired. Officers spoke with two patrons who stated they were in the bar waiting for a food order when they overheard two males at a near-by table, state he was going to get something from the trunk of his car. Both patrons stated they took this to mean he was going to get a gun so they immediately left the bar, got into their car and circled the block. As both patrons returned to the bar, they observed one of the males with a gun in waistband. Both patrons stated to police that they never observed any security at the bar and that while they were in the tavern, no altercations took place. Officers spoke to the bartender Willie Neely who stated he did not hear any gunshots being fired and that there were no incidents inside the tavern that night. Neely stated to police that they do have security cameras however they were not operating due to no tape being in the machine. No licensing violations were observed.

21. On 05/20/11 at 9:35 pm, police were in the rear parking lot of Ralph's Coffee Shop located at 4538 W Lisbon Avenue. Officers have spoken to the owner of the property Ralph Neely regarding subjects loitering on the property with Neely stated he does not give permission to anyone to loiter in his parking lot and wants police action when subjects are found to be violating. Neely does have two signs posted in the parking lot that state, No Loitering. Officers observed a subject standing near the rear exit of the business who was holding an open intoxicant in his hand. A field interview was conducted and the investigation revealed that the subject was in possession of an illegal substance and because of this, began fighting with police. Because of this, a crowd of patrons began to gather around the police yelling obscenities causing officer to call for more squads. There are no surveillance cameras outside of the business. While on scene, police spoke to Willie Neely, brother of the owner, who stated he doesn't allow people to loiter outside the establishment, but is unable to watch every person.

Dear Ralph Neely:

This letter is notice to you that the Milwaukee Chief of Police, by the chief's designee, the district commander, has determined that the premises located at 4538 W Lisbon Ave ("the premises") is a nuisance pursuant to Milwaukee Code of Ordinances ("MCO") § 80-10, Chronic Nuisance Premises.

The Milwaukee Police Department has responded to the following described nuisance activities at the premises on the corresponding dates, which qualify the premises as a nuisance:

- 1. On Thursday May 7, 2015 at about 11:58 pm two patrons of Ralph's Coffee, at 4538 W Lisbon Ave, were shot in the parking lot of Ralph's Coffee that started with an argument inside of the location. MPD IR #151270171 MCO 80-10-2-c-1-k.
- On Saturday November 14, 2015 at about 11:09 pm the victim exited Ralph Coffee, at 4538 W Lisbon Ave, when he was robbed and shot in the parking lot at the location. MPD IR#153180177 MCO 80-10-2-c-1-k

As a consequence, the premises may be subject to a special charge for the cost of future enforcement for any of the nuisance activities listed in MCO § 80-10-2-c that occur at the premises.

You are directed to respond to my office within 10 days of receipt of this notice with an acceptable, written course of action that you will undertake to abate the nuisance activities occurring at the premises, or file an appeal. You may appeal this nuisance determination to the Administrative Review Appeals Board. Any appeal must be in writing and a processing fee will

be charged. Please contact the Office of the City Clerk at (414) 286-2231 for additional information.

If you elect to provide a written course of action, I shall evaluate it to determine if it is a reasonable attempt at abating the nuisance activity.

Prior to responding with a written course of action, it is highly recommended that you obtain records relating to police responses regarding the premises. You may obtain these records from the Computer Aided Dispatch System (CADS) at the Open Records Section of the Milwaukee Police Department (District Three Station, 2333 North 49th Street, Second Floor) between 7:30 AM and 3:30 PM on Monday, Wednesday and Fridays. There is a cost of 25 cents per page for these records.

Once you are able to determine the type of nuisance activity occurring at the premises, please review the following examples of nuisance abatement measures that you may include in your written course of action to abate the nuisance activity. These suggestions are not exclusive, may not apply to the particular premises, and you may propose other nuisance abatement measures that would be appropriate under your particular circumstances.

- Participate in the Department of Neighborhood Services' Landlord Training Program and make a good faith effort to apply the knowledge from the course and attend refresher classes. Information on this training program may be obtained by calling (414) 286-2954.
- Exchange names and telephone numbers with the owners and operators of neighboring premises.
- Participate in a local block watch, neighborhood association, landlord compact and property management association.
- Attend the monthly crime prevention meetings conducted by the local Milwaukee Police District Community Liaison Officer who can be contacted at CLO Phone Number.
- Institute the use of written screening criteria that are provided to each applicant at the time each proposed adult resident receives a written application; and, conduct background checks of all prospective adult tenants and residents.
- Institute the use of a written lease for each adult tenant that include provisions relating to disorderly behavior, noise, garbage disposal, use of common areas, illegal activity, tenant responsibility for guest conduct, and the prohibition of sub-leasing and long-term guests. Timely enforce any lease violations.
- Review the tenancies of all the current residents in the property. This may include the termination of tenancies and reapplication by existing tenants for new tenancy.
- Regularly inspect the interior of the property to confirm that the residents are your tenants, confirm that the premises are actually used as a residence, and to determine if the doors and windows have been fortified or the premises outfitted with surveillance or delivery mechanisms.
- Monitor the property for evidence of drug activity. This may include observation of clear corner cuts of baggies strewn about, excessive quantities of plastic sandwich baggies found in odd places, presence of numerous weight scales or communication devices and drug paraphernalia such as unusual pipes, empty cigar wrappers, burned hollow tubes, etc.

• Install "No Loitering" signs in the front and rear of the exterior of the property. This signage permits police to cite loitering individuals in the yard and sidewalk area.

• Draft and serve a no trespassing order against identified nuisance persons and provide the local police district station a copy of the served order.

Provide the local police district station with an updated current tenant list.

If you propose a course of action which is rejected by me or fail to timely respond to this request, and a subsequent nuisance activity occurs on or after 13 days after receipt of this notice, the premises will be subject to placement of a special charge as a lien on the property by the Commissioner of the Department of Neighborhood Services for the cost of any police services and enforcement.

Once you have been billed for the costs of police services and enforcement for three or more separate nuisance activities within one year of the date of this notice of nuisance premises, the premises may be designated a chronic nuisance, pursuant to MCO § 80-10-6, and each and every subsequent incident of nuisance activity at the premises may be deemed a separate violation and result in a citation being issued to you for failure to abate the nuisance activity. Each citation would subject you to a forfeiture of not less than \$1,000.00 or more than \$5,000.00. Upon default of payment of a chronic nuisance citation you would be subject to imprisonment in the county jail or house of correction for a period of not less than 40 days or more than 90 days for each violation.

On Thursday, May 07, 2015, at 10:58 PM, An MPD Sergeant observed several shots being fired from the parking lot of Ralph's Coffee, 4538 W. Lisbon Ave.

The suspect fired multiple rounds towards the two victims. The victims were struck by the suspect's round, which required injury to both victims. The victims both required medical attention for their injuries.

The suspect was observed fleeing from the location from a green, 4-door vehicle. The suspect crashed 4 blocks north of the shooting incident. The suspect then fled from the accident scene on foot, leaving his vehicle running and open. The suspect's identity and narcotics were discovered in the abandoned vehicle.

Both victims went to Ralph's Coffee to order and pick up food. The suspect started an argument with the victims when they were waiting for their food. The argument was very brief and the suspect left the premise. The victims left the premise, and their friend waited for their food. The suspect was standing in the parking lot, and turned around and fired about 10 shots at him and his brother. Both victims ran towards W. Lisbon Ave. for help.

Another handgun was located near the two shooting victims when they were lying in the street.

The victims identified the suspect in a photo array.

GREEN (B/M 12-21-76; 4719 W. Garfield Ave), stated he had just left Ralph's Coffee Shop Bar, located at 4538 W. Lisbon Ave, when two individuals robbed him at gunpoint.

The armed robbery (IR#: 15-003-0058) occurred in the northeast corner of the parking lot, as GREEN was walking to his vehicle. The two subjects were armed with AK-47 assault riffles. There were a number of witnesses in the parking lot during the time of this armed robbery; however nobody called the Police.

After getting the story from GREEN, P.O. THOMPSON and I went to the tavern to view the video. The owner, Ralph E. NEELY (B/M 12-16-51; 3525 N. 50th ST), was at the tavern at the time and was very cooperative. There was an exterior video camera that caught part of the incident on film. The camera was affixed to the south east corner of the building facing northeast towards the direction of the incident. A copy of the incident was downloaded from the recording hard drive and placed on Police inventory.

NEELY stated he was at the tavern at the time of the incident, but did not see anything. NEELY stated he was inside the tavern closing up at the time the incident took place.

I am not sure what you can do about this situation, but I hope it can be addressed in some way.

- 1. On 02/18/2014 a Milwaukee police officer responded to 5007 West Center Street (Uptown Café) in an attempt to retrieve video regarding a burglary. After several failed attempts by phone and in person to contact the applicant, the officer gave up and no video was obtained regarding Milwaukee police incident report # 140460041.
- 2. On 04/27/2014 Milwaukee police responded to a shooting at 5004 West Center Street. Two subjects were struck by gunfire. These subjects told officers they were in the area to patronize Jay's Uptown Café, but they were shot prior to entering the business. Additionally, a vehicle owned by a patron of Jay's Uptown Café was struck by gunfire. Milwaukee police incident report #141170023 filed.

3. On 11/09/2014 Milwaukee police responded to a subject with a gun complaint at 5007 West Center Street (Jay's Uptown Café). Chuck Brady, the head of security, stated there was a fight inside the premise. Brady stated two of the subjects that were fighting were kicked out and they were armed with guns. Brady believed the subjects retrieved the guns from their cars. Brady further stated a security guard was taken to the hospital. James Perry was interviewed at St Joes Hospital. Perry stated a fight broke out and when he attempted to help other security guards he was knocked to the ground by an unknown subject. While on the ground he felt a poke to the left side of his head. Perry than used his mace and sprayed the crowd. He then felt someone bite his ear. Perry received 30 stiches to the back of his head, 4 staples to

his right hand, 4 stiches to his right ear and 3 stiches to a puncture wound. The agent was on scene but did not witness the fight. No video was available for this incident. Milwaukee police incident report #143130014 filed.

- 4. On 03/29/2015 Milwaukee police responded to a shots fired complaint in the area of North 50th Street and West Center Street. Police received calls from citizens about shots being fired in the area as well as Shotspotter activity in the same area. After the initial call for shots fired, officers were dispatched to St. Joseph's hospital to meet a shooting victim. The victim told officers he had been at Jay's Uptown Café around 11:20pm. When he exited the business around bar close and returned to his car. The victim decided to urinate outside of his vehicle when he observed an unknown subject fire numerous shots in his direction from a long gun. The victim suffered 11 wounds as a result of this incident. Officers later discovered 15 spent casings in the area of the shooting and that the victim's car sustained damage from 15 gunshots. The agent stated there was a large crowd that night for his birthday but there were no problems inside the tavern. Milwaukee police incident report #150880024 filed.
- 5. On 08/23/2015 Milwaukee police were dispatched to 5007 West Center Street for a shooting and fight complaints. While at that location, officers were informed a victim had gone to St. Mary's hospital indicating he had been shot in a tavern in the area of North 49th Street and West Center Street. The victim stated he left the business with other patrons when he heard 7-8 gunshots. The victim later realized he'd been shot and was taken to the hospital. The victim suffered a gunshot wound to the foot during this incident. A total of 17 casings and 2 bullet fragments were recovered from the shooting scene. Milwaukee police incident report #152350026 filed.

NARRATIVE SECTION: This report is written by P.O. Ashley VAN DRISSE, assigned to District 3, late power shift. This report is a summary from IR # 14-117-0023 (1st Degree RES (2cts), 2nd Degree RES and ESBUODW) that occurred on Sunday, April 27 2014 at 2:09AM at the location of 5004 W. Center St. This incident occurred across the street from "Jay's Uptown Cafe", which was operating at the time of this offense.

As a result of this incident, two subjects were wounded by gunfire (Mark RILEY ROBERSON and Pierre C. BROWN)

and an unrelated vehicle was damaged as a result of the shots being fired.

The victim of the 2nd Degree RES, David W. EDMONSON, stated to squad 9358, Det. Shaun LESNIEWSKI that he, his friend Pierre C. BROWN, who was struck 4 times by gunfire, and another unknown subject were in the area because they wanted to patronize "Jays Uptown Cafe", however, he, BROWN and the other subject never made it into the tavern because of this incident.

When viewing video surveillance of this incident, I was able to see two vehicle's pull up next to one another while facing westbound on W. Center St at 5004 W. Center St. Both vehicles were in the westbound lane of traffic. It appears that the passenger of the vehicle closer to the center lane of W. Center St., opened the door slightly and began to fire a gun. That vehicle then drives off quickly. The driver of the vehicle closest to the parking lane is then observed sticking a hand out of the drivers holding a firearm and shooting it at the other vehicle as it drove away. The vehicle that was closest to the parking lane then drives off westbound. A few minutes later, a B/M subject carrying a broom and dustpan is observed walking east from the south side of Center St at approximately 5005 W. Center St., which is near the front door to the tavern. This subject then crosses W. Center St. and begins sweeping up the exact area where this incident occurred. It appeared that this subject was wearing a dark shirt which is common for security from Jay's Uptown Cafe to be wearing. Also being that it was approximately 2:15AM, it should be noted that no other businesses in the immediate area were open.

According to reports, both vehicles involved in this incident were driven to St. Joseph's Hospital where BROWN was dropped off because of his injuries from one vehicle and Mark RILEY-ROBERSON was dropped off from the other vehicle RILEY-ROBERSON was treated at St. Joseph's Hospital for a gunshot wound to his left arm, however BROWN was later transported to Froedtert Hospital due to the severity of his injuries.

The unrelated vehicle that was struck by gunfire belonged to, Wesley RENFRO, who was patronizing Jay's Uptown Cafe when this incident occurred.

Three .45 cal casings, two .40 cal casings, two partially deformed bullets and two bullet fragments were located on scene and placed on MPD Inventory.

This case is pending.

This report is written by P.O. Frank YINKO, District Three, Late Power Shift. This report is a summary of reports filed under IR# 143130014. On Sunday, November 9th, 2014 at 1:17AM, Squad 3481 (P.O. Kyle JELINEK and P.O. Matthew CLAUDIO) responded to 5007 W Center St (Jay's Uptown Café) for a Subject with Gun complaint.

Upon arrival, P.O. JELINEK interviewed Chuck E. BRADY, who stated he was head of security and that there was a fight inside of the premise in which he was working. BRADY stated it was a typical busy night and there was also a birthday party being hosted. BRADY then stated there was a fight that broke out inside the premise and security tried to intervene. BRADY stated once security got control of the fight, two subjects were then kicked out of the bar and they were armed with guns. He described the first subject as a B/M, light complexion, 5'11", wearing a red plaid jacket, armed with a black semi auto handgun. He described the second subject as a B/M, dark complexion, wearing a puffy jacket, armed with a silver semi auto handgun. BRADY stated he thought the subjects retrieved the guns from their vehicles, but was uncertain. BRADY stated during the fight he thought a security guard named "James" was possibly hurt and was already taken to a hospital. BRADY was unsure if the premise video system was working.

P.O. JELINEK interviewed the victim, James H. PERRY, at St. Joseph's Hospital. PERRY was bleeding from the mouth, left side of his face and the back of his head. PERRY stated he was working as a security guard at Jay's Uptown Café located at 5007 W Center St. PERRY stated he works for himself (Internal Police Services) as an independent contractor. He stated he was working the door from inside of the premise. PERRY then stated while working the door he was approached by an unknown female who stated "they are fighting". He stated he then turned around and observed a bouncer attempting to break up a fight. PERRY stated he then went over to help the bouncer, at which time an unknown person grabbed him from behind by pulling on his hooded sweatshirt pulling him to the ground. He stated as he was on the ground he felt a "poke" to the left side of his face. PERRY then stated he grabbed his "bear mace" and began spraying it into the air. At this time PERRY said there were approximately10 subjects surrounding him. PERRY also stated while on the ground he felt someone bite his right ear. He stated he continued to spray his mace and the crowd dispersed out of the bar. PERRY then stated he got up and went to the kitchen area to rinse his face when the bartender, "Dave", observed how bad he was hurt. He stated "Dave" drove him to the hospital. PERRY stated he did not know what was used to cut him and that he could not identify the subject(s) who cut him. "Dave" was not on scene when P.O. JELINEK arrived at the hospital.

PERRY's injuries:

Left cheek - 4" laceration that required approximately 30 stitches; back of head - 3" laceration that required 4 staples; right hand - 1" laceration that required 4 stitches; right ear - ½" puncture that required 3 stitches. The licensee, Odean H. TAYLOR, was present during the incident, but stated he was in his back office and did not see the fight. TAYLOR told P.O. JELINEK there was no video at the premise. TAYLOR told P.O. Anthony WILSON that he didn't have the security code to assess the surveillance system. TAYLOR stated his wife, Kendria J. TAYLOR, has the security code to assess to their surveillance system. Odean was unable to contact his wife, Kendria, by phone.

On 11-13-14, I advised Odean TAYLOR there would be a License Premise Report filed regarding IR# 143130014. TAYLOR stated he noticed the video was not working on 11-06-14, but did not know the exact day it stopped working. He stated there was a problem with the hard drive, it was repaired, and is currently working. He stated he did not witness the incident, because he was in the back office.

He stated that he was home with his daughter prior to that. He stated that he wasn't meeting anyone, but ended up talking with some females while at the bar. He stated that after bar close he crossed the street and went to his black 2008 Audi Q7 SUV that was parked facing east in the laundromat parking lot at 5030 W. Center St. After starting his vehicle he stepped out to pee. BENSON then stated that a second or two later he observed a subject come from the north between the laundromat and the building to the east with a long gun. He stated that the subject fired the weapon in his direction and he quickly got into his vehicle. He stated that he heard at least two more shots and realized that he had to get out of there or he was going to die. BENSON said that he backed up a little bit and then went forward, east, hitting a white dumpster and then a white car parked on W. Center St. facing west. He stated that he was unsure how many shots were fired but that it was a lot. He stated that he drove himself to St. Joseph's Hospital. BENSON was shot in the left wrist, left palm, left middle finger, left foot, left calf, left thigh two times, left hip, right hamstring area, and two spots on left buttocks. Located on scene were 15-7.62mm casings. BENSON'S vehicle was found to have been struck 15 times.

On Sunday March 29, 2015 at 11:01pm P.O. YINKO and I spoke with licensee Odean H. TAYLOR (b/m, 03-26-79), regarding the incident. TAYLOR stated he had a large crowd night; he was having a Birthday party for himself. TAYLOR stated there were no problems inside the premise during the evening and estimated 100 people had been turned away do to occupancy.

The hearing before the Licenses Committee will take place on 12/1/2015 at 10:15 AM, in Room 301-B, Third Floor, City Hall. If you wish, you may provide testimony at the hearing regarding the request; see below for further information. You are not required to attend the hearing. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing. Please review the information below and if you have further questions regarding this process, please contact the License Division at (414) 286-2238.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
