## OBJECTIONS TO THE LICENSES DECEMBER 1, 2015 REPORT

- 1. Under "Recommendations" the report states there were 5 ayes and 0 noes on the vote for nonrenewal. This is incorrect. The vote was actually 4 ayes and 1 no with Alderman Puente voting against the motion for nonrenewal.
- 2. The Licenses Committee reports that the license is being non-renewed because the location is a threat to the "health, safety and welfare of the community." There is nothing in the record to indicate that the store is such a threat. The alderman testified at the hearing that the store was dirty and in poor condition. However, the Department of Neighborhood Services has no holds on the property and there are no work orders or other violations at the property. According to the Department of Neighborhood Services' standards the property is not a threat to the health, safety or welfare of the community.
- 3. The Committee also based its decision on neighborhood objection. While there was neighborhood objection, there was also a significant amount of neighborhood testimony in support of the license. Anthony Robinson, Aaron Terrance and Nyisha Givens all gave testimony that was in support of license. The Committee's Findings of Fact do not adequately state the testimony in support these three individuals offered.
- 4. The Applicant respectfully requests the Common Council renew the license with a warning letter or alternatively with a suspension.
