Re: Report of the Renewal Application of Todd G. Sokolowski, Agent for Sokolowski Enterprize, LLC for a Class "B" Tavern and Public Entertainment Premises Licenses for the premises located at 4024 South Howell Avenue in the City and County of Milwaukee, Wisconsin ("Jerseys Pub & Grill").

- 1. Todd G. Sokolowski, Agent for Sokolowski Enterprize, LLC holds Class "B" Tavern and Public Entertainment Premises licenses for the premises located at 4024 South Howell Avenue in the City and County of Milwaukee, Wisconsin ("Jerseys Pub & Grill"). Said license expires at midnight, February 6, 2016.
- 2. An application to renew said licenses was filed late with the Office of the City Clerk on December 1, 2015.
- 3. Pursuant to Chapters 90 and 108 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. There was a Milwaukee Police Department report dated December 1, 2015.
- 4. Pursuant to Chapters 90 and 108 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, on December 21, 2015 the City Clerk's Office provided timely notice of the police report and neighborhood objections to the Licensee. A copy of the police report and neighborhood objections was included with the notice. The matter was scheduled for a hearing on the police report and neighborhood objections on January 5, 2016 at 8:45 a.m. in Room 301B of the third floor of City Hall. At said date, time and place, the Licensee appeared and was represented by Attorney Andrew Arena, 1110 North Old World Third Street, Suite 515, Milwaukee, WI 53203-1117.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. On February 5, 2014, Milwaukee police responded to a theft complaint at 4024 South Howell Avenue (Jersey Pub & Grill). The caller, Scott Rick, identified himself as a bartender at the business and told police that a customer had taken a green vinyl bag containing \$2,860.00 from behind the counter. A police incident report was filed.



- B. On December 24, 2014 Milwaukee police responded to an armed robbery complaint at 4024 South Howell Avenue (Jersey's Bar and Grill). The investigation revealed the business was robbed at gunpoint. A police incident report was filed.
- C. On February 19, 2015, Milwaukee police responded to an anonymous complaint of gambling, smoking and underage patrons at 4024 South Howell Avenue (Jersey's Pub and Grill). Officers observed no violations, but were told by the applicant that there is a card tournament at the business every Saturday. The applicant also told officers this tournament is a fund raising event for softball teams and does payout small amounts to the winners. The applicant was advised by officers not to host gambling events.
- D. On April 15, 2015 a 20-year old Milwaukee police aide, working in conjunction with Milwaukee police, was able to purchase two Miller High Life brand beers from the bartender, Scott Rick, at 4024 South Howell Avenue (Jersey's Pub and Grill). Officers informed Rick of the Respect 21 program and that forms would be sent to the bar. The applicant did not enroll in the Respect 21 program and two citations were issued on June 25, 2015. Scott Rick was issued citations for Sale of Alcohol to Underage Person and Presence of Minor at Licensed Premises. He was found guilty of both on August 13, 2015 and fined, respectively \$373.00 and \$384.00.
- E. David Bartel, 126 East Norwich testified that he is sickened by the public urination of the bar patrons, the garbage that is left, and motorcycles leaving at 1:00 to 2:00 a.m.
- F. Kelley Murphy, 4021 South Burrell Street testified she lives directly behind the bar and has seen intoxicated patrons around her house littering and being loud. She stated that she sees people on the back deck smoking and drinking. She stated she has called the bar several times to complain.
- G. Alderman Witkowski testified that he has received emails regarding the noise, improper use of the volleyball courts, litter, empty cups and bottles, vomiting, and lewd behavior. He added that the parking lot that is being leased is full of debris and he requested a revocation.
- H. Attorney Arena stated that the applicant will do a better job of managing his patrons and will rope off the back deck.
- I. Scott Rick, the applicant, stated he will do a better job of cleaning up trash around the property and in the parking lot.

1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapters 90 and 108 of the Milwaukee Code of Ordinances.

- 2. Based upon the above facts found, the Committee concludes that the licensee has not met the criteria of Chapters 90 and 108 of the Milwaukee Code of Ordinances to allow renewal of the Class "B" Tavern and Public Entertainment Premises Licenses for the premises located at 4024 South Howell Avenue in the City and County of Milwaukee, Wisconsin ("Jersey's Pub & Grill") without the issuance of a ten (10) day suspension.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should not renew the Class "B" Tavern and Public Entertainment Premises Licenses for the premises located at 4024 South Howell Avenue in the City and County of Milwaukee, Wisconsin ("Jersey's Pub & Grill") without the issuance of a ten (10) day suspension based on the neighborhood and aldermanic testimony.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of four (4) ayes and one (1) abstention recommends that the licensee's Class "B" Tavern and Public Entertainment Premises Licenses for the premises located at 4024 South Howell Avenue in the City and County of Milwaukee, Wisconsin ("Jersey's Pub & Grill") be renewed with the issuance of a ten (10) day suspension based on the police report, neighborhood and aldermanic testimony.

Said suspension is to be in effect from 12:01 a.m. on February 7, 2016 until 11:59 p.m., February 16, 2016.

Re: Report of the Renewal Application of Donald R. Lewis for a Class "B" Beer and Class "C" Wine, Food Dealer's and Public Entertainment Premises Licenses for the premises located at 2451 West Fond du Lac Avenue in the City and County of Milwaukee, Wisconsin ("Young Urban Jazz").

- I. Donald R. Lewis holds Class "B" Beer and Class "C" Wine, Food Dealer's and Public Entertainment Premises Licenses for the premises located at 2451 West Fond du Lac Avenue in the City and County of Milwaukee, Wisconsin ("Young Urban Jazz"). Said license expires at midnight, January 6, 2016.
- 2. An application to renew said licenses was filed late with the Office of the City Clerk on December 16, 2015.
- 3. Pursuant to Chapters 90 and 108 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. There was a Milwaukee Police Department report dated December 30, 2015.
- 4. Pursuant to Chapters 90 and 108 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, on December 30, 2015 the City Clerk's Office provided timely notice of the police report and neighborhood objections to the Licensee. A copy of the police report and neighborhood objections was included with the notice. The matter was scheduled for a hearing on the police report and neighborhood objections on January 5, 2016 at 10:00 a.m. in Room 301B of the third floor of City Hall. At said date, time and place, the Licensee appeared and was represented by Attorney David Bangert.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. On October 18, 2015 at 10:38 p.m., officers responded to a Shotspotter call at 2467 West Fond du Lac Avenue. The call was updated to a shooting one minute later. A victim was located at the mouth of the alley at 2470 West Cypress Street. The scene of the shooting was located behind Young Urban Café, 2451 West Fond du Lac Avenue. The investigation revealed the victim had been inside the Young Urban Café at



a private party. He had arrived intoxicated and was very loud and annoying causing the bartender to ask him to leave. He was shot after he left the premise.

- B. On October 21, 2015 at 12:29 a.m., officers responded to a fire at 2451 West Fond du Lac Avenue. Based on the damage to the front of the building it appears someone doused the front of the building with a flammable liquid and ignited it.
- C. On December 22, 2015 at 10:00 a.m., a meeting was held at the district's conference room with Donald Lewis, the agent from Young Urban Jazz, regarding a homicide that occurred on October 18, 2015 and an arson that occurred on October 21, 2015. On October 18, 2015, Lewis stated the premise was not operating as Young Urban Jazz, that the premise was being used to host a private birthday party. The first call relating to the homicide was a Shotspotter call that came in at 10:38 p.m. Alderman Stamper informed Lewis that part of his agreement to support Lewis to get his licenses was consideration for the church close by and that one of the conditions was for Lewis to be closed by 6:00 p.m. Lewis stated that the premise was not operating as Young Urban Jazz, but was merely hosting a birthday party on the premise. Lewis was informed while the premise is in use, that it is operating as Young Urban Jazz even if the premise is holding a private party and Is still subject to the responsibilities and limits of his license.

The second incident that occurred at the premise was an arson, which occurred on Wednesday, October 21, 2015 at 12:29 a.m. after the premise was closed.

During the meeting, areas of discussion for improvement to prevent further incidents were camera system, security, a policy for dealing with problem patrons; security checks of patrons and no weapon/loitering signs.

Lewis indicted that he has video cameras at his premise, but his recording system had been unable to record for several months and was not operational at the time of the 2 incidents. The recording system has been replaced after the arson and currently has 4 security cameras that record both outside and inside the premise and will hold recordings for 300 days.

Lewis has one armed security guard in uniform on the premise when they are operating, but was unable to provide the full name of the armed security guard or the name of the security company. Lewis stated he would verify the credentials of his security and that they are licensed by the state and insured. Lewis stated we would adopt a formal policy on how his employees will handle a customer that becomes a problem, including calling the police if viewed necessary. Lewis stated he does not have a loitering sign, because it was never a problem. Lewis stated he would be adding a no weapons allowed sign at the premise. Lewis further stated that he will no longer host private parties at the premise.

Attorney Bangert stated that the applicant has hired an armed security guard as well as installed no loitering signs and security cameras.

- D. David Powell, 2500 West Medford Avenue stated that he has seen loitering and drug dealing outside of the premises.
- E. Theresa Fox, 2500 West Medford Avenue stated she has seen unwanted cars in the church parking lot and a lot of traffic around the premises.
- F. Daniel Maynard, 910 West Eula, Glendale, Wisconsin stated he has known the applicant for many years and is an employee.
- G. Earl Ellis, 3940 North 63rd Street stated he is a musician and has played with the applicant.
- H. Dean Lee, 6700 North Grangeline Road, Glendale, Wisconsin stated he is a musician and has known the applicant for over 30 years and plays at the premise.
- I. Alderman Stamper stated the agreement to open the bar was for it to close by 6:00 p.m. on Sundays and when that agreement was breached a homicide occurred.

- 1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapters 90 and 108 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the Licensee has not met the criteria of Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of the Class "B" Beer and Class "C" Wine but renew the Public Entertainment Premises and Food Dealer's Licenses for the premises located at 2451 West Fond du Lac Avenue in the City and County of Milwaukee, Wisconsin ("Young Urban Jazz") without the issuance of a ninety (90) day suspension.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should not renew the Class "B" Beer and Class "C" Wine licenses or renew the Public Entertainment Premises and Food Dealer's Licenses for the premises located at 2451 West Fond du Lac Avenue in the City and County of Milwaukee, Wisconsin ("Young Urban Jazz") without the issuance of a ninety (90) day suspension based on the police report, neighborhood and aldermanic testimony and operating outside the plan of operation.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of three (3) ayes, one (1) noes and one (1) abstention recommends that the Licensee's Class "B" Beer and Class "C" licenses should not be renewed and the Public Entertainment Premises and Food Dealer's

Licenses for the premises located at 2451 West Fond du Lac Avenue in the City and County of Milwaukee, Wisconsin ("Young Urban Jazz") be renewed with the issuance of a ninety (90) day suspension based on the police report, neighborhood and aldermanic testimony and breaking the agreement.

Said suspension is to be in effect from 12:01 a.m. on January 19, 2016 until 11:59 p.m., April 17, 2016.



In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council should exercise its discretion to not renew the Class "D" Operator's license held by Michelle S. Eckert without undergoing a ten (10) day suspension based upon the police report.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, recommends that the Class "D" Operator's License of Michelle S. Eckert be renewed with a ten (10) day suspension based upon the police report.

- 2. Based on the above facts found, the Committee concludes that the Licensee, Jacob E. Dehne has not met the criteria of Chapter 125 of the Wisconsin Statutes or Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of the Class "D" Operator's license based upon nonappearance.
