

# Tradename/Trademark Information

#### · Why register?

If your bank, your customers or suppliers require you to register your business name or logo, submitting the application would register the name and/or mark on the state level.

#### Who does it help?

Registration of a Tradename/Trademark makes it a public record and enables consumers to identify the owner of a business.

#### Will I own the name and/or mark?

Registration of a Tradename/Trademark in Wisconsin *does not give ownership*; it does make it a public record that the registration is being used.

#### How do I own the name and/or mark?

Rights and ownership in Wisconsin of a Tradename/Trademark are gained through usage, not through the registration.

#### · Am I required to register?

No. <u>Wisconsin Statute 132.01</u> does not require the registration of Tradenames/Trademarks. Therefore, the Department of Financial Institutions (DFI) has only a partial listing of names/marks in use by businesses/individuals operating in Wisconsin.

#### · How do I know if someone else is using it?

Search the internet, DFI website at <a href="www.wdfi.org">www.wdfi.org</a> (Tradename/trademark data base), telephone books, trade journals and other publications to be certain you are not infringing on another party's rights.

### Should I contact DFI if someone uses my name or logo?

No. The Department of Financial Institutions has no authority to determine who has rights to a name/mark. Any conflicts must be resolved by the parties involved, or by the courts.

#### How do I get exclusive rights to a name?

To obtain an opinion regarding exclusive rights, please consult a private attorney.

## Tradename/Trademark Registration Instructions

The name of a business, product, label, logo, or form of advertisement; are some examples of items that may be registered with the Department of Financial Institutions. The registration is not required, but is a good way to notify the public of the use of a certain name or mark. Conduct a general internet search and our website <a href="https://www.wdfi.org/apps/TrademarkSearch/Search.aspx">https://www.wdfi.org/apps/TrademarkSearch/Search.aspx</a>, to be sure that the name you intend to register is not already in use.

The filing fee is \$15 per Tradename/Trademark, and the registration remains on record for 10 years and may be renewed before the 10 year time period has expired.

A registration may be "assigned" to another party during the 10 year period, using the assignment form <a href="http://wdfi.org/Notary">http://wdfi.org/Notary</a> Public and Trademarks/defaultTrademark.htm.

- 1. Check the appropriate box to indicate if this is a new registration or a renewal of an unexpired tradename/trademark.
- 2. Enter the date of first use or anticipated first use of the tradename/trademark.
- 3. Enter the legal name of the entity that is registering the tradename/trademark. For sole proprietors, enter the first and last name of the sole proprietor. For corporations, LLCs, partnerships, etc., enter the registered name of the entity.
- 4. Enter the physical location of the entity registering the tradename/trademark.
- 5. Optional If the certificate should be mailed to a location that is different from the registrant's address in #4, enter the mailing address.
- 6. If an entity name is entered (e.g. Corporation, LLC, LLP, etc.) the name must be exactly the same as #3. If the entry is a design or a combination of a name and design, a description must be entered and a sample of the design must be included.
- 7. Enter a brief description of the business and/or goods for which this registration will be used.
- 8. Provide the contact information for the person who will respond to correspondence regarding this registration.
- 9. Print your name and title and sign in the presence of a notary.
- 10. Notary must complete this section in its entirety.
- 11. Submit \$15.00 payment for each name/design registered, and mail the form(s) to the address listed at the bottom of the registration form. If applying for multiple names/designs, submit a separate application for each name/design. One check for all is acceptable.
- 12. Applications are processed every Wednesday. Once the application is processed, your information will be updated on <a href="https://www.wdfi.org/apps/TrademarkSearch/Search.aspx">https://www.wdfi.org/apps/TrademarkSearch/Search.aspx</a> on the following Thursday. In addition, you will be sent a certificate as confirmation of the Tradename/Trademark that you submitted and application for. Contact us if you notice any discrepancies.
