# MILWAUKEE METRO CENTER MINOR MODIFICATION TO THE DETAILED PLANNED DEVELOPMENT BERGSTROM AUTOMOTIVE – GM Certified Used Car PROJECT: Description and Owner's Statement of Intent

This minor modification to the detailed plan development in Milwaukee Metro Center is hereby submitted by Bergstrom Automotive. This statement, together with the below described exhibits and supporting materials, comprises the minor modifications.

# II. DESCRIPTION OF THE DEVELOPMENT

The minor modifications consist of changing the Bergstrom Milwaukee Hummer automotive dealership into a Bergstrom GM Certified Used Car automotive dealership. The building alterations that will be made in this conversion include adding a twenty (20) square foot vestibule addition, removing and replacing the existing façade, adding a flat roof, and repainting a portion of the existing structure.

# III. COMPLIANCE WITH STANDARDS

The proposed minor modifications provide for or comply with the standards by Section 295-812 and 295-813 as follows:

- A. Size The project site contains 5.09 acres with two existing structures. The minor modification will include a twenty (20) square foot addition which will be constructed over existing impervious surface.
- B. Setbacks No change to the existing conditions
- C. Screening and Open Spaces No change to the existing conditions.

- D. Landscaping No change to the existing conditions. All damaged landscaping at the building will be replaced at the end of construction.
- E. Circulation Facilities No change to the existing conditions.
- F. Lighting No change to the existing conditions
- G. Parking No Change to the existing conditions
- H. Utilities No change to the existing conditions
- I. Signage Signage is described and located on Exhibit "6". Building Signage will be individual internally illuminated, plastic faced light bar, metal sided letters. The existing Hummer building signage is to be removed and replaced with new signage. The area of the new signage will not exceed the area of the existing Hummer signage being removed. Refer to Exhibit "6" for removal of Hummer signage. The existing directional signage will be modified to indicate Bergstrom GM Certified Used Car in lieu of Hummer. NO pylon signs will be added to this site.

# IV. MINOR MODIFICATIONS

Subject to the limitations contained in Section 295-813(4) of the Milwaukee Code of Ordinances, and in order to maintain flexibility as the development proceeds, Bergstrom Automotive expressly retains the right to make reasonable minor modifications provided that the limitations contained in the above cited section of the ordinance are not exceeded.
