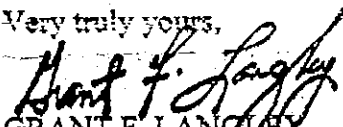
Dear Mr. Jackson:

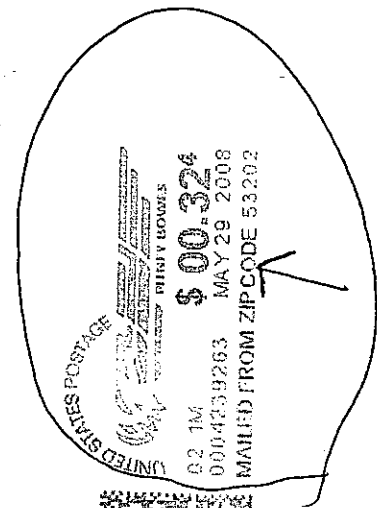
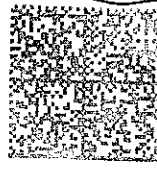
