
Dear Ms. Maliszewski:


We have received your claim in the amount of \$86.55, relating to damage sustained to your vehicle when it allegedly collided with a pothole at or near South 3<sup>rd</sup> Street and North Oklahoma Avenue on April 1, 2008.

Our investigation reveals the Infrastructure Services Division (ISD) reviewed their records and the records of the DPW Call Center regarding this incident. They found the ISD had patched West Oklahoma Avenue on a consistent basis. The winter weather has hampered the repair work and the ability of the patch materials to remain in the repairs. The ISD followed its normal procedures and it was acting within the city's discretion. Therefore, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
