Sally,

I can understand your comments, but disagree on a couple of points.

NH is proposing demolishing the house to install surface parking. While I know that parking around there is not overly abundant, a lot full of asphalt hardly seems the 'best use' for the property. Especially when you consider that Concordia has been fighting for years to preserve its historic housing stock.

The house may not be a Pabst Mansion, but it is historic, even if by virtue of its age alone, and pertinent in maintaining our neighborhood's and our city's history. We don't discard portions of our population when they pass a certain age just because they haven't discovered the next theory of relativity or invented the next integrated circuit. There are other properties in that area that are already vacant, or hosting non-historic non-contributing buildings, that could provide parking for NH. If they own this property, they could either pursue an adaptive re-use (administrative offices, adjunct classroom space) or sell this to a restoration-minded owner-occupant to finance other alternatives.

On Monday the Historic Preservation Commission denied Neighborhood House's application for a certificate of appropriateness to demolish this house which is next door to Neighborhood House. This house is in the Concordia historic district.

As you may recall, this house was built sometime in the 1850's making it one of the oldest surviving homes in Milwaukee. It is probably the last home on the original Watertown Plank Road. Richardson Pl. is the only remaining section of the Watertown Plank Road in Milwaukee.

Neighborhood House seeks to demolish the house to construct a surface parking lot.

Neighborhood House can appeal this decision to the full Common Council. Accordingly, HCNI along with any other citizens/stakeholders will have the opportunity to formally weigh in on this issue if an appeal is taken. Based on prior discussions at HCNI meetings, it appeared that the consensus of opinion was that this house should not be demolished especially given the fact that the alternative use was a surfacing parking lot. I'm so glad to hear Alex's, Marc's and others' comments in opposition to the demolition of this house. My sentiments exactly. I was still an employee of NH when this transaction took place, and I can tell you that the staff (the less well paid ones that were told we had a deficit and don't spend any money)were not wild about the decision. Especially since they either 1) didn't drive to work or 2) would not be the ones parking in those spaces.

How did a decision to buy and tear down a house in a historic district get made when the board has 2 members who live in the district, and one of them works for the Dept. of Community Development? Did the decision get made without the full board's knowledge? Were community based members voted down by the suburban contingent on the board? (the vast majority). Do I sound like a disgruntled former employee? YOU BET I AM. That's why I quit after 17 years! There is so much positive about NH that gets canceled out by a bunch of really stupid decisions. I am so hopeful that the new administration, who inherited this "house" problem, will honor the historic nature of this house, no matter how architecturally unfancy it may be.

I remember the house as plain when I knew the family that lived there in the 80's, but I admit I don't know what constitutes "architecturally significant" when it comes to any house that isn't Victorian, Arts and Crafts, or Frank Lloyd Wright. I do know it's at least historically significant, and at it's worst, a better alternative as a home in a city with a need to keep housing stock than a parking lot for a few folks afraid for their cars.

And I think it should be strongly suggested to NH that they secure the house's inside front door, because having it wide open is an obvious invitation to enter. Many of us observed this last night. Whatever decision they make, they should do it quickly. Leaving the house empty is a BAD IDEA. The last house they bought, maybe 17-18 years ago (on 28th St.) was TORCHED.

Well, I don't want to end this negatively. Bob mentioned something about NH possibly not having the money to do a rehab. And I mentioned to a few people last night an idea I had. I believe there may be money available somewhere if they get on the sustainability bandwagon (finally a good bandwagon to be on!) and use the house as a demonstration project, do an ECO rehab., train a group of teens to work with eco friendly materials so they can get some of these jobs of the future. In other words, to think outside of the box, really do something significant for the youth in the area, make the neighbors happy, keep the house from being an eyesore, etc., etc. Could HCNI tempt them with a start up challenge grant with part of that \$23,000 that's on hand? Wouldn't that be good PR for the neighborhood also?

Can we oppose the demo but support them on an alternative use we can all be happy with? Any other ideas?

The work that Neighborhood House does makes a huge difference in the lives of individuals and in turn makes a huge difference in the quality of life for all of us. They are not asking for anything unusual, as Alderman Bauman stated, every other citizen and organization in the city has the right to request and to receive a permit to raze their buildings, the exception being buildings of historical value. This building as so well stated by Sally Witte is nothing special, and of limited if any historical value. It has been worked over with none of its original design intact and there was nothing special about it to begin with. The structure is in bad condition and will require a huge outlay just to stabilize it. But, as most of us know, enough money can restore these old houses, the question is in this instance, is it worthwhile.
