Report on the Renewal Application of the Class "B" Tavern and Public Entertainment Premises (PEP) Licenses of Gorgonio Lopez Saavedra for the premises located at 1339 South 7th Street in the City and County of Milwaukee, Wisconsin ("La Cama Club").

- 1. Gorgonio Lopez Saavedra (hereinafter "the Licensee") is the holder of a Class "B" Tavern and PEP Licenses for the premises located at 1339 South 7th Street in the City and County of Milwaukee, Wisconsin ("La Cama Club"). Said license expires at midnight on February 12, 2016.
- 2. An application to renew said license was filed with the Office of the City Clerk on November 9, 2015.
- Pursuant to Chapters 90 and 108 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On January 18, 2016, the Milwaukee Police Department responded with a report that could from the basis for renewal of said license.
- 4. On January 19, 2016 the City Clerk's Office provided timely notice to the Licensee pursuant to Chapters 90 and 108 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report, and on the neighborhood objections. The matter was scheduled for a hearing on the police department report on January 26, 2016, commencing at 10:30 a.m. in Room 301B of the third floor of City Hall. At said date, time and place, the Licensee appeared at the hearing and admitted receipt of the notice of hearing, together with a copy of the Milwaukee Police Department report. The Licensee was not represented by counsel.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. On February 15, 2015 Milwaukee police conducted a licensed premise check at 1339 South 7th Street (La Cama Club). No violations were observed.



- B. On September 20, 2015 Milwaukee police were flagged down regarding a complaint of underage patrons inside the business at South 7th Street and West Greenfield Avenue. Officers conducted a licensed premise check at 1339 South 7th Street (La Cama Club). No underage patrons were discovered and no violations were observed.
- C. On October 4, 2015 Milwaukee police conducted a licensed premise check at La Came Club based on an aldermanic complaint of loud music and patrons at the business. During this check, officers noted that the basement storage area was dirty, there were some issues with an electric panel and an exit door was lacked. The applicant was advised the exit needs to remain unlocked during business hours and that a referral to the Department of Neighborhood Services would be made regarding the issues in the basement.
- D. On November 1, 2015 officers conducted a licensed premises check at La Cama Club, 1339 South 7th Street regarding a complaint of exotic dancers. Officers did not observe any exotic dancers but did observe an entrance door that was locked during business hours. The applicant had been warned this door could not be locked because it was a fire exit. The applicant stated he locked the door to prevent patrons from entering the side door which he did not have security for. The applicant was charged with Licensed Premise-Open Entry Required and found guilty on December 16, 2015 and fined \$378.00.
- E. On December 27, 2015 officers went to La Cama Club, 1339 South 7th Street to investigate a complaint of underage drinkers. The investigation revealed there were five underage patrons on scene without a parent or guardian. The applicant was on scene and was uncooperative. He was telling the patron to not follow the orders of the police and instructing the patrons to leave. The applicant was also telling the bartenders to not give their information to the police. The applicant was detained and removed from the premise during the investigation. The applicant was cited for Contributing to Delinquency of Minor and Resisting or Obstructing an Officer, both of which are pending further proceedings on February 10, 2016.
- F. On December 27, 2015 officers responded to La Cama Club, 1339 South 7th Street to investigate an entry complaint. The investigation revealed a subject had entered the building by breaking a window and climbing through. The subject took a laptop computer. Video was recovered. The applicant was on scene and cooperative.
- G. Alderman Perez stated he is concerned about the management style of the applicant, the underage drinking, and has received community complaints.
- H. The applicant stated he has removed speakers to keep the noise down, has fixed the exit door and has a new security company.

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law, and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapters 90 and 108 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the Licensee, Gorgonio Lopez Saavedra, has not met the criteria to allow renewal of his Class "B" Tavern and PEP licenses without undergoing a twenty (20) day suspension.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew the Class "B" Tavern and PEP licenses of Gorgonio Lopez Saavedra for the premises located at 1339 South 7th Street in the City and County of Milwaukee, Wisconsin ("La Cama Club") with a twenty (20) day suspension based upon the police report, aldermanic testimony and for the danger that premises poses to the health, safety and welfare of the citizens of the City of Milwaukee.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of four (4) ayes and one (1) noes, recommends that the Class "B" Tavern and PEP Licenses of Gorgonio Lopez Saavedra for the premises located at 1339 South 7th Street ("La Cama Club") in the City and County of Milwaukee, Wisconsin be renewed with a twenty (20) day suspension based on the police report and aldermanic testimony.

Said suspension is to be in effect between 12:01 a.m. February 13, 2016 through 11:59 p.m. March 3, 2016.

Report on the Renewal Application of the Class "B" Tavern and Public Entertainment Premises Licenses of Debbie Coops LLC as Agent for The Tool Box for the premises located at 1500 West Scott Street in the City and County of Milwaukee, Wisconsin ("The Tool Box").

- 1. Debra J. Torres (hereinafter "the Licensee") is the holder of a Class "B" Tavern and Public Entertainment Premises Licenses for the premises located at 1500 West Scott Street in the City and County of Milwaukee, Wisconsin ("The Tool Box"). Said license expires at midnight on February 10, 2016.
- 2. An application to renew said license was filed with the Office of the City Clerk on December 1, 2015.
- 3. Pursuant to Chapters 90 and 108 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On December 1, 2016, the Milwaukee Police Department responded with a report that could from the basis for renewal of said license.
- 4. On January 15, 2016 the City Clerk's Office provided timely notice to the Licensee pursuant to Chapters 90 and 108 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report, and on the neighborhood objections. The matter was scheduled for a hearing on the police department report on January 26, 2016, commencing at 10:30 a.m. in Room 301-B of the third floor of City Hall. At said date, time and place, the Licensee appeared at the hearing and admitted receipt of the notice of hearing, together with a copy of the Milwaukee Police Department report. The Licensee was not represented by counsel.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. On November 23, 2014, Milwaukee police responded to a battery complaint at 1500 West Scott Street (Tool Box). Officers spoke to the bartender, Jennifer Rosiak, who stated she was unaware of any trouble. Officers made several attempts but, were unable to contact the caller.



- B. On December 19, 2014, Milwaukee police conducted a licensed premise check at 1500 West Scott Street. No violations were observed.
- C. On January 15, 2015, Milwaukee police conducted a licensed premise check at 1500 West Scott Street. No violations were observed.
- D. On April 2, 2015, Milwaukee police responded to a fight/battery complaint at 1500 West Scott Street (The Toolbox). The bartender, Jennifer Rosiak, told officers a patron of the bar had thrown a bottle at her when she refused to continue serving him. The assailant, along with two additional patrons, was removed from the bar and had fled the scene prior to the arrival of officers.
- E. On April 9, 2015, Milwaukee police responded to a battery complaint at 1500 Wet Scott Street (The Tool Box). The bartender, Robert Fielbelkorn, told officers that a male and female had been arguing inside the business. Later, while watching the live feed of the surveillance camera, Fielbelkorn observed the male strike the female several times while they were both outside the building. The male then forced the female into a vehicle, which then fled the scene. Fielbelkorn then called police. The vehicle and both parties were located a short time later and the male was arrested. The officer observed no violations inside the business. Milwaukee police incident report filed.
- F. On June 25, 2015, Milwaukee police responded to a trouble with a subject complaint at 1500 West Scott Street (The Toolbox Tavern). The bartender told officers a customer had become disorderly, yelling obscenities and engaging in verbal confrontations with other customers, and was escorted out by other customers. The disorderly subject remained outside kicking the locked door and pounding on the window. After several minutes, the subject gave up and walked away. This subject was not located by officers, who observed no violations while inside the business.
- G. On July 5, 2015, Milwaukee police responded to a fight complaint at 1500 West Scott Street (The Toolbox). Officers determined the fight had dispersed prior to their arrival and no violations were observed inside the business.
- H. On July 11, 2015, Milwaukee police responded to a battery complaint in the area of 1500 West Scott Street (The Toolbox Tavern). Patrons inside the business indicated the call had not been placed from that location and no sign of an altercation was observed. Officers were unable to locate the caller.
- I. On August 22, 2015, Milwaukee police responded to a shots fired complaint at 1500 West Scott Street (The Toolbox). A security guard for the business, Cory Boye, told officers he heard approximately 3-4 gunshots around 2:00 am while closing down the bar. Officers discovered a pool of blood on the sidewalk on the southeast side of the building which they followed to 1308 South 15th Place, where they discovered Brandon Hervey. Hervey told officers he had been involved in a fight outside of The Toolbox, but he doesn't remember with whom. While investigation this incident, officers also responded to an accident at South Cesar E

Chavez Drive and West National Avenue. It was discovered the operator of the vehicle, Gabriel Velazquez, had been shot. Velazquez died from his injuries. It was discovered that Velazquez had been at The Toolbox earlier, where he got into an argument with other patrons. Velazquez then gets into his car and attempts to run over the patrons he had argued with, one of which produced a gun and fired in the direction of the car Velazquez was driving. Milwaukee police incident reports filed.

- J. On October 3, 2015, Milwaukee police conducted a licensed premise check at 1500 West Scott Street (The Tool Box). No violations were observed.
- K. On November 15, 2015, Milwaukee police conducted a licensed premise check at 1500 West Scott Street (The Tool Box). Officers discovered one patron who had not attained the legal drinking age of 21. This patron was cited and a letter was sent advising the applicant to enroll in the Respect 21 program.
- L. David Torres, 1825 South 5th Street, is the applicant's husband and stated he is unsure of how the altercation resulting in a homicide occurred because it happened outside of the establishment. He added that they have done a lot to mitigate the noise, and they clean up outside. He doesn't believe he has affected the school and would like an opportunity to try and improve things.
- M. Alderman Perez stated he has met with the applicant many times and the neighbors feel the property is a nuisance. He recommends nonrenewal.
- N. Captain Wurth stated she has significant concerns regarding the violence at the premises and drug trafficking in the area. As well as the amount of police resources needed to control the issues. She added the premises is becoming a nuisance property. She recommends nonrenewal, individuals present in opposition.
- O. Steven Hasbrook, 221 Scenic Ridge Ct., President of Notre Dame School is concerned about the safety of his students, their families, and the faculty because the school has activities until 6 p.m.
- P. Mary Schneider 1505 West Scott stated the premises is very loud, that she can feel the vibrations from the music in her house and has asked the owners to close the door many times. She stated there is fighting at night and there are empty beer bottles and cans all over.
- Q. Davie DiAntonio. 3129 South Vermont Avenue, Assistant Principal of Notre Dame School stated he is concerned about the safety of their students, their families and the community as well. They hold events at night after 6 p.m. and the bar is dangerous to their students, families, and visitors.
- Q. Emilia Meledez, 2025 South 28th Street, Business and Facilities Manager of Notre Dame School stated she agrees with the previous speakers. She added she sees people outside the bar when students are being dismissed and the liquor delivery trucks block the school's driveway.

R. Linda Delon, 2576 South 28th Street is a parent of a Notre Dame student, stated she sees intoxicated patrons and beer bottles all over when she is picking up her daughter from school. She recommended the bar open later so she and others don't have to witness this behavior

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law, and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapters 90 and 108 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the Licensee, Debra J. Torres, has not met the criteria to allow renewal of his Class "B" Tavern and Public Entertainment Premises licenses.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Utilities and Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to nonrenew the Class "B" Tavern and Public Entertainment Premises licenses of Debra J. Torres for the premises located at 1500 West Scott Street in the City and County of Milwaukee, Wisconsin ("The Tool Box") based on items #5-8, 10 and 12 in the police report, and aldermanic, police, neighborhood, and applicant testimony and for the danger that premises poses to the health, safety and welfare of the citizens of the City of Milwaukee.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of four (4) ayes and one (1) noes, recommends that the Class "B" Tavern and Public Entertainment Premises Licenses of Debra J. Torres for the premises located at 1500 West Scott Street ("The Tool Box") in the City and County of Milwaukee, Wisconsin not be renewed based on items #5-8, 10 and 12 in the police report, and aldermanic, police, neighborhood, and applicant testimony.

- 1. Israel Ocampo (hereinafter "the Licensee") is the holder of a Class "B" Tavern and PEP Licenses for the premises located at 2724 South 13th Street in the City and County of Milwaukee, Wisconsin ("Exoticas the Club"). Said license expires at midnight on March 5, 2016.
- 2. An application to renew said license was filed with the Office of the City Clerk on December 28, 2015.
- 3. Pursuant to Chapters 90 and 108 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On January 4, 2016, the Milwaukee Police Department responded with a report that could from the basis for renewal of said license.
- 4. On January 19, 2016 the City Clerk's Office provided timely notice to the Licensee pursuant to Chapters 90 and 108 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report, and on the neighborhood objections. The matter was scheduled for a hearing on the police department report on January 26, 2016, commencing at 2:00 p.m. in Room 301B of the third floor of City Hall. At said date, time and place, the Licensee appeared at the hearing and admitted receipt of the notice of hearing, together with a copy of the Milwaukee Police Department report. The Licensee was represented by Attorney Ronnie Vargas.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. On January 4, 2015 Milwaukee police conducted a licensed premise check at 2724 South 13th Street (Exoticas the Club). No violations were observed.



- B. On February 10, 2015 Milwaukee police conducted a licensed premise check at 2724 South 13th Street (Exoticas the Club). No violations were observed.
- C. On February 13, 2015 Milwaukee police responded to a battery complaint at St. Francis Hospital. The caller told police he was at a strip club at 2720 South 13th Street where he was battered by security from the business because he became friendly with a dancer. Officers then spoke to the applicant and security at the business. They were aware an incident had occurred, but denied It involved a physical altercation. Officers attempted to speak to the dancer involved, but she refused to answer questions.
- D. On April 19, 2015 Milwaukee police responded to a battery complaint at 2724 South 13th Street (Exoticas the Club). Security for the business told officers several patrons had become unruly and were removed from the club. Once outside, these same subjects began screaming and yelling. The three subjects were issued citations for disorderly conduct.
- E. On May 30, 2015 Milwaukee police responded to a traffic hazard at 2724 South 13th Street (Exoticas the Club). The caller told officers he was unable to unload equipment and supplies for a job site because an area of the street was blocked by traffic cones placed in the street by the business. Officers told the business manager, Brandon Lewis, he could not put traffic cones in the street and he needed to remove them.
- F. On June 7, 2015 a fight started across the street from the tavern located at 2725 South 13th Street. Once the combatants dispersed, security noticed a man lying in the street. Police were called and the man was brought inside to render aid. During this incident, a subject became unruly and was later placed into police custody. An incident report was filed.
- G. On September 30, 2015 Milwaukee police conducted a licensed premise check at 2724 South 13th Street (Exoticas the Club). During this check, it was pointed out that the business has four functioning cameras on the exterior of the business. Officers observed seven bottles of contaminated liquor, which were disposed of, and discovered that there were no employees present with either a Class "D" or Class "M" license. The applicant was cited for Responsible Person on Premises Required.
- H. On October 19, 2015 Milwaukee police responded to 2724 South 13th Street (Exoticas the Club) to drop off a citation for the incident outlined above (September 30, 2015). At this time, the officer determined that there was no one present at the business who was licensed to serve alcohol. The business closed voluntarily and the applicant, bartender and bar manager were cited.

As to the bartender: Takeyah Norman

Charge: Class "D" Operators License Required

Finding: Not adjudicated

As to the manager: Ricardo Valentin

Charge: Class B Managers License Required

Finding: Due for pre-trial 01/13/2016 8:30 am branch 2

As to the applicant: Israel Ocampo

Charge: Responsible person on premises required Finding: Due for pre-trial 01/13/2016 8:30 am branch 2

I. On January 16, 2016, Milwaukee police were dispatched to St. Mary's Hospital to investigate a shooting. The victim told officers he had stepped on another patron's shoe while inside the business and that patron became very upset. When the victim left the business, a group followed. One of the members of that group discharged a firearm into the vehicle the victim was in, striking the victim in the arm. On January 18, 2016 Milwaukee police were dispatched to the premises for a wanted subject. Security told officers that the subject who committed the shooting was inside the tavern. This subject fled prior to officer's arrival. An incident report was filed.

- J. Alderman Perez stated his district is across from this premises and he and his residents are concerned about the violence and nuisance behavior. Alderman recommended nonrenewal.
- K. Julian Merced, 1332 West Cleveland stated he can see the premises from his home and it is loud and a nuisance. He has witnessed shootings, traffic hazards, after-hours parties in the parking lots, and people parking in his parking lot. He has to call to get the cars that are parked illegally ticketed and towed.
- L. Patrick Housfeld, 2567 South 12th Street stated the premises is across the street from Grandview High School and parking is limited. Littering has increased and he has witnessed cars racing and cruising, gunshots and has been run off the road on his bike by customers of the premises.

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law, and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapters 90 and 108 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the Licensee, Israel Ocampo, has not met the criteria to allow renewal of his Class "B" Tavern and PEP licenses.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to nonrenew the Class "B" Tavern and PEP licenses of Israel Ocampo for the premises located at 2724 South 13th Street in the City and County of Milwaukee, Wisconsin ("Exoticas the Club") based upon the police report, aldermanic testimony and public testimony and for the danger that premises poses to the health, safety and welfare of the citizens of the City of Milwaukee.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of five (5) ayes and zero (0) noes, recommends that the Class "B" Tavern and PEP Licenses of Israel Ocampo for the premises located at 2724 South 13th Street ("Exoticas the Club") in the City and County of Milwaukee, Wisconsin not be renewed based on the police report, aldermanic testimony and public testimony.



- 3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On January 3, 2016, the Milwaukee Police Department responded with a police report that could form a basis for nonrenewal or suspension of said license.
- 4.
