Dear Ms. Crawford:

We have received your claim for the amount of \$11,250.37 in relation to the medical bills you incurred on July 23, 2015.

The Milwaukee Police Department reports they received a call reporting a disoriented person in the 300 Block of East Reservoir Avenue. The police responded to complete a welfare check, and the assistance of the Milwaukee Fire Department was requested to complete a medical examination. At that time you were incoherent, so the fire department transported you to the hospital. While you were at the hospital you advised the hospital staff that you would be leaving the hospital. The Milwaukee Police Department was notified that you would be leaving the hospital and could not be held because there was no Chapter 51 in place.


Our investigation reveals that the police undertook the necessary and appropriate action on a request to check on your welfare. Because the police were not negligent in this matter, the City would not be liable. Accordingly, we are denying your claim.




