Subchapter 1:

- 1. Definitions generally combined into one section. Definitions specific to subchapters were kept in that subchapter.
- 2. Definition of "at a disadvantage with respect to business location" revised to improve clarity/readability. No substantive changes.
- 3. Definition of "at a disadvantage with respect to employment" split into two sentence to improve clarity/readability. No substantive changes.
- 4. Definition of "at a social disadvantage" split into paragraphs a to d to improve clarify/readability. No substantive changes.
- 5. Definition of "direct financial assistance" changed: \$1,000,000 threshold reduced to \$500,000, for discussion purposes. Additional changes may be needed, per Comptroller audit. Additional WORC input warranted.
- 6. Definition of "local business enterprise": removed redundant provision in par. b. Substantively unchanged.
- 7. Definition of "unemployed or underemployed" revised to remove the 5 year limitation.
- 8. Added definition of workforce development.
- 9. No changes were made to other definitions.
- 10. Office of Small Business Development changed to Office of Workforce Development (OWD).
- 11. Duties of the OWD: expanded to include all workforce development programs (not just SBE). Duties largely taken from current s. 370-3.
- 12. RPP report requirements: Unchanged.
- 13. SBE & LBE report requirements: language borrowed from 370-5-4 and 365-7-2, respectively. Additional WORC input warranted.
- 14. Duties of contracting agencies: code provisions from various chapters consolidated. Substantively unchanged.
- 15. Performance assurance procedures: Removed redundant language. No substantive changes.

16. Sanctions and penalties: consolidated provisions relating to sanctions and penalties into one section. No substantive changes.

Subchapter 2:

- 1. Redundant definitions moved to subchapter 1. Remaining definitions unchanged.
- 2. Goals (city contracts): unchanged from current 309-41-2.
- 3. Administration: Edited for clarity/readability. No substantive changes.
- 4. Goals (development agreements): unchanged from 355-7-1.
- 5. Administration: added "monitoring". Various code provisions (s. 355-5 and s. 355-7-2) combined into one chronological section.
- 6. Exceptions: New provisions added for discussion purposes. Additional WORC input warranted.

Subchapter 3:

- 1. Creation; Purpose: Unchanged.
- 2. Goals: Unchanged. Combined from s. 370-5-1 and s. 370-27.
- 3. Certification requirements: Substantively unchanged. Draft s. 370-35-2 taken from current s. 355-13-4-c.
- 4. Joint ventures: unchanged from current s. 370-5-3.

Subchapter 4:

- 1. Creation; Purpose: unchanged.
- 2. Application: unchanged.
- 3. Administration: Various code provisions reorganized for clarity/readability. Substantively unchanged.
- 4. Obligations of contracting departments: Par. a Moved language relating to \$25,000 threshold from s. 365-7-1-e. Added par. e for discussion purposes.
- 5. Duties of contracting agency: Language in par. c simplified. Substantively unchanged.

Subchapter 5: Unchanged from current code provisions (apprenticeship and on-the-job trainee requirement, first-source employment utilization, and other requirements).
