5. DESCRIPTION OF PROJECT:

This proposal is for the construction and installation of a custom handrail for the set of 5 stairs between the sidewalk level of State Street and the walkway leading to the front porch stairs of the home at 2742 W. State Street (photos #1 and #2). The railling will be located on the west side of the steps, which is where there is evidence an old railing previously existed (photo #3). The design will reflect some of the details in the woodwork seen on both the exterior and interior craftsmanship (photo #4).

A local blacksmith (Eric Stenzel) will be using inspiration derived from various designs by Cyril Colnik to create a custom piece. His preliminary renderings are attached (photos #5-#8).

The railing meets code requirements at 36 inches in height. The main feature of the railing will measure 68 inches in length. It will measure approximately 90-100 inches in complete length depending on the decorative finishes at the ends of the railing. The railling will be constructed out of steel with an antique patina finish.






Revised Handrail Design o4-08-2016
