Re: Report on the Renewal Application of the Class "B" Tavern, Public Entertainment Premises (PEP) and Food Dealer licenses of Martin Jimenez-Segura as Agent for MC Jimenez, LLC for the premise located at 2537 West National Avenue in the City and County of Milwaukee, Wisconsin ("Candelas").

FINDINGS OF FACT

1. Martin Jimenez-Segura (hereinafter "the Licensee") is the holder of Class "B" Tavern, PEP and Food Dealer licenses for the premise located at 2537 West National Avenue in the City and County of Milwaukee, Wisconsin ("Candelas"). Said licenses expire at midnight on May 20, 2016.
2. An application to renew said license was filed with the Office of the City Clerk on March 29, 2016.
3. Pursuant to Chapters 90 and 108 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On March 30, 2016, the Milwaukee Police Department responded with a report that could form the basis for renewal of said license.
4. On April 27, 2016 the City Clerk's Office provided timely notice to the Licensee pursuant to Chapters 90 and 108 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report, and the neighborhood objections. The matter was scheduled for a hearing on the police department report on May 10, 2016, commencing at 8:30 a.m. in Room 301B of the third floor of City Hall. At said date, time and place, the Licensee did not appear for a second time.
5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. A notice of the hearing as well as a copy of the police report was sent to Martin Jimenez-Segura at 2537 West National Avenue, Wisconsin 53204 on April 27, 2016 by U.S. prepaid first-class mail in an envelope bearing the return address of the License Division. The address of 2537 West National Avenue, Wisconsin 53204 is the address given by the Licensee on his application. The envelope was not returned to the License Division



by the United States Postal Service. The Licensee failed to appear at the hearing on May 10, 2016.


CONCLUSIONS OF LAW

1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law, and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapters 90 and 108 of the Milwaukee Code of Ordinances.
2. Based upon the above facts found, the Committee concludes that the Licensee, Martin Jimenez-Segura, has not met the criteria to allow renewal of his Class "B" Tavern, PEP and Food Dealer licenses.
3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to nonrenew the Class "B" Tavern, PEP and Food Dealer licenses of Martin Jimenez-Segura for the premises located at 2537 West National Avenue in the City and County of Milwaukee, Wisconsin ("Candelas") based on the second nonappearance.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of three (3) ayes and two (2) excused, recommends that the Class "B" Tavern, PEP and Food Dealer licenses of Martin Jimenez-Segura for the premises located at 2537 West National Avenue ("Candelas") in the City and County of Milwaukee, Wisconsin not be renewed based on the second nonappearance.
