No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

4. On 06/04/09 at 1:47 am, Milwaukee police were dispatched to 11400 W Silver Spring for a Battery complaint. Police spoke to the victim who stated she was at Silk when another patron came up to her spat in her face and also made threats to harm her. Security removed the suspect from the tavern and officers issued the suspect a citation for disorderly conduct.

5. On 04/21/12 at 2:24 pm, Milwaukee police investigated an accident complaint at 11400 W Silver Spring Drive. Investigation revealed a patron had damage done to his auto while he was inside the club. Police spoke with management who stated that the car was parked out of surveillance range and did not capture this incident. A report was filed.

- 6. On 05/13/12, Milwaukee police conducted a License Premise Check and found no violations.
- 7. On 05/19/12 at 2:15 am, Milwaukee police conducted a License Premise Check and found no violations.
- 8. On 07/06/12 at 12:20 am, Milwaukee police responded to a Battery complaint at 11400 W Silver Spring. Investigation revealed an employee, who was highly intoxicated, was causing a disturbance and had slapped two patrons inside the club. Other club employees' took the subject to a back room and attempted to call her a cab, but the subject refused and left on her own, falling several times. A security guard filmed some of the incident on his cell phone, which was played for police. Police did speak with the subject who refused to talk with police and hung up on the officer. There were no recording surveillance cameras inside the establishment.

10. On 01/01/2015 occupants of a vehicle responded to Silk to pick up an individual that was an employee there. One of the occupants of the vehicle commanded a dog in the car to attack the person they had just picked up. The victim was able to exit the vehicle and ran back into Silk. An armed Security Guard employed by Silk Exotic fired a handgun at the dog. The Investigation revealed the Security Guard, Laderle R. Williams, is a convicted felon from a case on 12/05/14 and was prohibited from possessing a gun. Members of District Four had a meeting with Jon Ferraro regarding this incident. Mr. Ferraro stated he hired the security guard nine years ago and fired him once he was informed by the police. Milwaukee police incident report #150130080 filed.

- 11. On 04/24/2015 Milwaukee police, along with agents from the Department of Revenue, Health Department and Department of Neighborhood Services, conducted a tavem check at 11400 West Silver Spring Road (Silk Exotic Adult Entertainment Night Club). During this check, 16 bottles of alcohol were disposed of for various health infractions.
- 12. On 12/13/2015 Milwaukee police responded to a subject with a weapon complaint at 11400 West Silver Spring Road (Silk Exotic Milwaukee Gentleman Club). Officers spoke to Montel Jackson and Perry Wilk, who identified themselves as contracted security officers for Silk Exotic Milwaukee Gentleman Club. Wilk stated approximately 10 Asian males and one Asian female were denied access into the establishment because they were not in compliance with the dress code. He also believed they were associated with the Asian Crips. Jackson told officers that a group of subjects was pushed out of the business by patrons and security. Two of the members of this group returned to their autos and retrieved handguns, which they fired approximately 6 times. Milwaukee police incident report #153470007 filed.
- 13. On 01/07/2016 Milwaukee police met with Jon Ferraro regarding the shots fired incident described in item #12. Mr. Ferraro stated the club will be repairing and putting cameras in the parking lot and he is willing to work with Milwaukee police to keep the business safe.

#### PA-33E Narrative

This report Is written by P.O. Kent U. GORDON, assigned to the District 4 Community Prosecution Unit (CPU), Early Shift.

On 4-24-15, at 12:52PM, SQ 4272 (P.O. Robert WENGER and myself) along with SQ 4164 (P.O. Tracey GENIESSE), and SQ 4265 (P.O. Carrie RESNICK) responded to Silk Exotic Adult Entertainment Night Club located at 11400 W. Silver Spring Rd. to conduct a tavern check. Special Agents with the Department of Revenue, an agent with the Department of Neighborhood Services, and an agent with the Health Department were also there with us to assist with the tavern check.

We were met by Perry A. WILK (w/m, 2-6-86) who is the General Manager (GM) of Silk Exotic. We then informed WILK of our reason for being there, and he then assisted us by producing all of the necessary licensing documentation for the establishment, and the bartenders of the establishment. I also observed that Silk Exotic was open and operational at the time of our tavern check, and there were approximately 5 patrons inside of the establishment.

WILK first produced the Class B Tavern License (License #0202114), which read as follows;

WILK also informed me that they had one bartender working at the time we were there, Daniel L. SCHULTZ (w/m, 5-2-85). I then went to speak with SCHULTZ so I could check to see if he had the proper Class D Operator's License. Upon speaking with SCHULTZ he provided me with his Class D License, which read as follows;

Overall, WILK was very cooperative during the tavern check, and was receptive to try and remedy any infractions that were found by the agents on scene. Before concluding the tavern check the Special Agents with the Department of Revenue had WILK dispose of 16 bottles of various alcoholic beverages due to health infractions.

This Report of Incidents Involving Licensed Premises report was submitted by P.O. Martinez MOORE PS# 015951 assigned to District 4, Late Shift.

On Sunday, December 13, 2015, at 12:18 A.M., Squad 4365, P.O. Ralph MCCLAIN and I, was dispatched to a subject with weapon complaint at 11400 W. Silver Spring Rd, Silk Exotic Milwaukee Gentleman Club. Silk Exotic Milwaukee Gentleman Club is located in the City and County of Milwaukee.

Upon our arrival, I interviewed the exterior Security Officer, identified by his Wisconsin Driver's license, as Montel S JACKSON B/M, 04-24-92 address of 4905 N 37th St; Milwaukee, WI 53209, cell phone# 414-241-4021. My interview of Montel JACKSON was conducted in the east parking lot of Silk Exotic. Montel JACKSON was not under the influence of drugs or alcohol, maintained a calm demeanor, and was well-spoken.

Interview of Montel S JACKSON B/M, 04-24-92

Montel JACKSON stated he is a contracted Security Officer for Silk Exotic Milwaukee Gentleman Club. JACKSON stated he is assigned mobile patrol in the parking lot. Montel JACKSON stated he is the only security officer that patrol the parking lot. JACKSON stated he is employed by Scott Lucas Special Services, located at 3917 Wooded Ridge Tr; Colgate, WI 53017.

Montel JACKSON stated on Sunday, December 13, 2015, at approximately 12:15 A.M., while conducting mobile patrol of the parking lot, he observed approximately 10 Asian males, and one Asian female, park their respective vehicles on the far east side of the parking lot. JACKSON described the vehicles as a 1995 to 2000, Honda CRV, silver, 4dr, SUV, unknown plates, and a 1995 to 2000, Toyota Corolla, 4dr, tan, unknown plates. JACKSON stated as the aforementioned subjects egressed from their vehicles, they were dressed in primarily blue and black baggy clothing attire.

Montel JACKSON stated he observed the subjects walk towards the south east entrance (main entrance) to gain access into the club. JACKSON stated moments later, he observed the subjects return to their vehicles. Montel JACKSON stated he suspected the subjects were denied access because they were not in compliance with Silk's dress code. JACKSON stated he observed one of the Asian males place a blue bandanna in the Toyota Corolla, then as a group, returned to the main entrance.

Montel JACKSON stated he observed the aforementioned subjects entered the foyer area of Silk Exotic. JACKSON stated moments later, he heard "muffling" noises over the radio from Silk Exotic interior security. Montel JACKSON stated soon thereafter, he observed patrons yelling as they were exiting the club. JACKSON stated he suspected a disturbance, then responded hastily to the main entrance. Montel JACKSON stated when he entered the foyer, he observed patrons, and security, attempting to push the Asian males out the club. JACKSON stated he observed one Asian male laying on the floor. Montel JACKSON stated he was unaware if the subject was on the ground as a result of being battered or intoxicated. JACKSON described the Asian male, on the ground, physical characteristics as following: 25-30, 5'6", 170, heavy built, short hair, clean shaven, wearing a ripped tee shirt, and blue jean pants.

Montel JACKSON stated he assisted the Asian male to his feet. JACKSON stated he assisted in escorting the subjects (Asians) out the club. Montel JACKSON stated while in the parking lot, the Asian males began speaking in a different language. JACKSON stated soon thereafter, the Asian male he assisted to his feet, and an unidentified Asian male, attempted to assault him. Montel JACKSON stated they swung on him, however where unable to make contact due to their lack of balance. JACKSON stated he returned punches in self-defense. JACKSON stated the altercation was brief. Montel JACKSON stated he followed, from a distance, as the subjects returned to their respective vehicles. JACKSON stated they momentarily congregated around their

aforementioned vehicles. Montel JACKSON stated he heard one of the Asian males yell out boisterously, "Get .the gun, where's the gun!"

JACKSON stated he then observed Suspect #1, identified as an Asian Male, 5'7", 160, slender built, fair complexion, short hair, goatee, wearing a blue tee shirt underneath a black hooded sweatshirt, blue jean pants, retrieve an unspecified handgun from the passenger's side of the Toyota Corolla. Montel JACKSON stated he observed suspect #1 walk towards the center aisle of the parking lot, with the handgun in his right hand, in a downwards position, alongside his leg. JACKSON stated he observed the suspect in the act of raising the handgun. Montel JACKSON stated he immediately concealed himself behind a vehicle. JACKSON stated he heard Suspect #1 discharge his handgun once.

Montel JACKSON stated simultaneously to Suspect #1 discharging his firearm, he observed, from a concealed position, Suspect #2 rapidly discharging an unspecified firearm from the far east lanes of the parking lot; on the passenger's side of the Honda CRV. JACKSON stated he estimates that Suspect #2 discharged his firearm approximately 5 to 6 times. Montel JACKSON described Suspect #2 as an Asian male, 25-30, 5'8", 170, medium build, short hair, shadow beard, plaid button down shirt that has a blue, black, and white checker pattern, and blue jean pants.

Montel JACKSON stated the aforementioned suspects, along with the rest of their party, entered the Honda and Toyota, then exited the east parking lot. JACKSON state he last observed the vehicles traveling eastbound on W. Silver Spring Rd. Montel JACKSON stated he is willing to be a complainant, and will appear in court as needed. JACKSON did not have any further pertinent information pertaining to this investigation. My interview of Montel JACKSON was concluded.

P.O. MCCLAIN interviewed two witnesses regarding this incident. The witnesses were identified as Perry A WILK W/M, 02-06-86 address 4605 N 107th St; Wauwatosa, WI 53225, cell phone# 414-915-2215; and Rachel C KUEHN W/F, 01-08-84 address of 1101 Gertude St; Waukesha, WI 53186, cell phone# 262-510-9185. Perry WILK is employed as a Security Officer for Silk Exotic, and Rachel KUEHN was a patron.

#### Interview of Perry A WILK W/M, 02-06-86

Perry WILK stated he is employed as a Security Officer for Silk Exotic. WILK stated he is posted at the main entrance. Perry WILK stated on Sunday, December 13, 2015, at approximately 12:15 A.M., he observed the aforementioned Asian males attempt to gain access into Silk Exotic. WILK stated he denied the subjects access because they were not in compliance with their dress code. Perry WILK stated the subjects began using derogatory language and throwing up gang signs as they began to walk away from the club. WILK stated he suspects the subjects are associated with the Asian Crips. Perry WILK stated he went back inside the club and did not hear any gunshots, furthermore stated there was no further altercation with the aforementioned Asian males. P.O. MCCLAIN interview of WILK was concluded.

#### Interview of Rachel C KUEHN W/F, 01-08-84

Rachel KUEHN stated she was seated in VIP when this incident occurred. KUEHN stated for no known reason, she observed security hastily rush towards the main entrance. Rachel KUEHN stated moments later, her eyes became watery. KUEHN suspected that Mase was deployed in the vicinity of the altercation. Rachel KUEHN stated her party was advised to stay seated. KUEHN stated she did not visually observe any altercation. Rachel KUEHN did not have any further pertinent information pertaining to this investigation.

P.O. MCCLAIN also interviewed a Manager, identified as Craig T PLOETZ W/M, 10-27-62 address of 4777 Mellard Ct; Colegate, WI 53017. PLOETZ stated that the owner, identified as Scott A KRAHN W/M, 04-03-64, is temporarily out of town and there isn't anyone with access to the camera system.

One 9mm Luger spent casing, silver, was located in the second aisle of the parking lot, from the south, approximately 175 feet to the east of the building.

Six .45 caliber Federal spent casings, brass, was located on the far east end of the parking lot.

I, P.O. MOORE, who is Crime Scene Trained, captured 22 evidentiary digital photographs depicting the scene at a documented time of 1:52 A.M. The photographs were captured with a Milwaukee Police Department issued, Fuji Film Fine Pix S4800 digital camera, camera# 57056.

Afterwards, the casing were recovered then subsequently inventoried under Milwaukee Police Inventory# 15044265.

This incident is currently pending.
