If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

On Saturday May 14, 2016 I was assigned to work the Wisconsin WINS Youth Tobacco Initiative, which checks area vendors for age compliance tobacco purchases. Assisting in this assignment was a 16 year old who is not of legal age to purchase tobacco.

At approximately 10:10am the juvenile entered Singh Gas, 1545 W Hopkins St. He attempted to buy a single cigarette but was denied the purchase with the clerk telling him they do not sell single cigarettes.

This report is written by B.O. ErickRADECKI, District Five, Early Shift, Anti-Gang Unit.

On Tuesday, 01/05/16, at approximately 7:22pm, while assigned to squad 5282 with my partner's (P.O. Phillip FERGUSON and Justin SCHWARZHUBER) we attempted to conduct an FI stop on a vehicle that was at the 'gas pumps with dark tinted windows and no front plate.

Upon approaching the vehicle, the driver, later identified as Dominique K. LUCKETT, (B/M, 12-27-90) put the vehicle in reverse and then put the vehicle in drive and fled out of the gas station. Before exiting the gas station LUCKETT struck another vehicle that was also at the gas pumps. Once exiting the gas station lot, LUCKETT drove the vehicle West bound on Atkinson Ave at a very high rate of speed.

Squad 5436, P.O.'s Jeff KENNEDY and Josh YANG were on another assignment in the area of 15th and Atkinson when the observed the vehicle crash at the intersection and observed LUCKETT running from the vehicle.

We then changed locations to the intersection of 15th and Atkinson to stay with the vehicle. The vehicle information is a Blue, Toyota, Camry Solara, 2 door, with WI plate of 341-XUN. Upon searching the vehicle we located a small corner cut plastic baggie of a Gray powdery substance that tested positive for Heroin and weighed 0.4g. While walking the flight path that LUCKETT took to escape arrest we also located more Gray powdery substance that tested positive for Heroin and weighed 9.8g.

LUCKETT was arrested for Possession of Heroin with intent to deliver, Fleeing, and resisting.

P.O. Jasen RYDZEWSKI conducted a QP of LUCKETT and he admitted to Fleeing and resisting but would not admit to the Heroin.

Video was also ordered through BOFI for this incident

This case is pending for DA review.

This report is written by PO Michael WALKER, assigned to District Five, Community Prosecution Unit.

On Monday, December 30, 2015 at 6:36 PM the Milwaukee Police Department received a 911 call reporting a shooting at 807 W. Atkinson Ave. (B.P. gas station). Squad 5282 (P.O. Eric Kradecki and P.O. Kurt Ziarnik) were dispatched at 6:38 P.M. and arrived minutes later. Upon arrival the officers observed a vehicle stuck in the snow in the driveway on the northeast corner of the gas station lot. A victim was found lying face down in the snow on the driver's side of the vehicle, with suspected gunshot wounds. Life saving measures were attempted, but were unsuccessful and the victim was pronounced dead at the scene.

The scene of this incident was the lot of the B.P. gas station at 807 W. Atkinson Ave. The gas station is located on the southwest corner of N. 8th St. and W. Atkinson Ave. This incident took place on the eastern entrance, which faces W. Atkinson Ave. Store video surveillance cameras monitor this parking lot.

One of the 911 callers was an employee at the gas station, Archie MCCLENDON (B/M 06-18-1952). MCCLENDON was working as a clerk behind the cashier counter during this incident. An additional employee was also present inside the store. He was identified as Clyde M SMITH (B/M 11/21/1985). CLYDE indicated that he works inside the store as a stocker. Both MCLENDON and SMITH remained on scene and were interviewed regarding this investigation. Employees on scene stated the victim of this incident was inside the store purchasing lottery tickets prior to the shooting. The employees on site did not have access to the store's video surveillance system.

The Licensee, Diane STOWERS, was not on scene during this incident. I contacted STOWERS by telephone and informed her of this incident. STOWERS sent her daughter Ramona P SWINNY (B/F 3/1/77) to the scene, who was able to provide investigators access to the store video surveillance system. The store video confirmed that the victim was inside the store prior to this shooting incident.
