The officers stated on the No Know search warrant that I had a white door which was a lie because my front door that they broke in was a wooden Brown door with a bar on it. Showing probable cause that on Tuesday, March 4<sup>th</sup>, 2008 in the County of Milwaukee, there is now located and concealed in and upon certain premises, located within the City of Milwaukee, in said County, occupied by: "John Doe" AKA "B", black male, 20-24 years old, 510-602, 190-200 lbs, dark complexion, with a bald head more particularly described as follows:

DESCRIBE PREMISES: 3217 W. Vliet Street is the lower of a two-story duplex having green colored siding with white trim. The residence has gray asphalt shingles. The front door is white in color and faces north. The numbers 3217 are affixed just left of the front door. This premises is located in the City of Milwaukee, County of Milwaukee; State of Wisconsin.

Search to include all storage areas accessible to the above listed individuals, all persons present on premises, certain goods, autos, garage, chattels and property, to-wit:

DESCRIBE OBJECTS OF SEARCH:

1. Marijuana
2. Scales and narcotics packaging equipment
3. Firearms, ammunition, gun cases, manuals
4. Documents, utility bills, keys, and other items used to show who is in control of premises

Which thing(s) (were used in the commission) or (may constitute evidence) of a crime, to-wit:

DESCRIBE CRIME OR CRIMES: Possession of Marijuana with the Intent to Deliver While Armed, a violation of Wisconsin State Statutes 961.41 (1m)(h)1 & 939.63

Now, THEREFORE, in the name of the State of Wisconsin, you are commanded forthwith to search the said premises and/or the said person(s) for said things, and take possession thereof, if found.

You are further commanded to return this warrant within forty-eight hours after execution before the Assistant Chief Deputy Clerk of the Circuit Court, Crime, Misdemeanor, Traffic Division, or his designee, to be dealt with according to law.
