They handcuffed me all because I was trying to find out who they were and why they ran up in my home and attacked my son and nephew. I need to know if the DVD that my son recorded on the day of the incident was ever viewed and was the 911 call made on that day ever heard. The officers not at anytime identify themselves to me. Even after I continued to ask them who they were they never identified themselves. They were dressed in street clothes and had no badges visible for me to see. Again, of I had known to see were I would have never interfered. For this reason I want to appeal this decision.

On April 30, 2008 around the hours between 4:45pm and 5:00pm, at my home located at 3366 N. 4th Street Milwaukee, Wisconsin 53212. Two men entered my home and attacked my 19 year old son and my 17 year old nephew. The one that ran all the way into my home then attacked my 17 year old son who was recording the incident. He followed him outside to the front porch. After he had removed the camcorder from my son he then kicked my front door completely down and ran back into the house. At the time I did not know they were officers because they didn't identify themselves, they were not in uniform, and no badges were visible. Even after I continued asking who were they? They never said they were officers. After about 4 to 5 minutes someone from outside velled they were the FEDS. I feel they were completely out of order for their unprofessional conduct. After I heard someone yell out that they were the FEDS, I made a remark to the one inside the house that it was pitiful how they were acting like they were someone off of the street. If I had known that they were officers I would have never interfered. I would have gladly cooperated. They threw me to the floor so hard even after I told them about my medical conditions. One of the female's that ran up dug her fingernails in my shoulder that left bruises. My knees were in so much pain I had to go to the emergency room. They gave me something for the pain but after the meds wore off my knees continued to pain severely. They were bruised and burning inside. I eventually had to make a visit to my primary care doctor. My left knee had to be injected with steroids. My doctor said that the pain medication that I had been on wouldn't do me any good. If the officer felt that he was conducting himself properly why would he erase my son's call log from his cell phone, after he had called 911, and remove his DVD from his camcorder after he realized that he was recording the incident. I feel that I should be compensated for: the citation that I was issues should be thrown out; Front Door \$95.00; Son's DVD \$5.00; Pain and Suffering \$3000.00
