- 6. Uncontrolled and disorderly traffic
- Involvement in recent gunfire
- Patrons/associates carrying weapons
- Security failing to control the crowds
- 10. The liquor license that was granted was based on this establishment having Jazz/Blues type atmosphere. The current bar has consistently played hip hop type music and attracting a more out of control crowd-opposite of what was presented to license committee.

Pursuant to our conversation on September 9, 2008, the following is a chronology of events taking place at 2722 North Martin Luther King Drive, formerly known as Finesse. This new club is now named "Twist". The time frame begins on August 3rd 2008 when it is the author's belief that Finesse and its clientele changed from an upper middle class to that of a much younger hip hop crowd.

Aug.3 rd-11:16pm.

Author was awakened to 3 females arguing loudly in front of 2714 N Martin Luther King Drive. The author proceeded to let the subjects know that they were being loud and obnoxious and that they needed to take their argument somewhere else. At this point they stopped arguing for a few seconds to acknowledge the author and then continued at a louder pace. This went on for an extended period of time. This scene can be viewed on Disc #1. The police were called and responded. It was also noted that at 1:50am that there was disorderly traffic and loud conversations occurring. This scene can be viewed on Disc #2

Aug. 11th

Author observed cars parked illegally on the vacant lot at 2721 N MLK and reported to DPW. Complaint #1149301/1 citation issued.

Aug.16th - 12:31 am.

The recently placed barricades at 2721 N MLK were moved so that cars could pass through and park on the vacant lot that is clearly marked "No Parking, Dumping or Trespassing". Author observed numerous cars parking there and then entering Twist. This scene can be viewed on disc #3.

Aug. 17th 1am.

The author was awakened to loud car stereos and patrons of Twist. While watching the disorderly crowd, it was noted that the private armed security company officer was carrying on a conversation with a car blocking traffic. This went on from 1:27-1:31.

Disorderly traffic, noise and general chaos were noted from 1:32-1:36am. The author was forced to sleep in alternate quarters due to the noise. It appears that shots were fired at about 1:41am. This incident was brought to the attention of the author the following day. These scenes can be viewed on Disc 3B

Week of 8/17-8/23 Exact date unknown

Author was awakened by loud car stereos and patrons of Twist. This occurred as the bar was closing. The author continued to observe as eventually all the patrons had left. It was at this point that a male in a white t-shirt exited Twist going southbound. He approached the storefront doors of 2714 N MLK and motioned to

the author. Author opened the door and was asked "what were you doing, enjoying the scenery or what?" The tone and the demeanor of the young man was suspect. So the author continued to watch as the young man crossed the street and stopped to converse with a man in the bus shelter. This went on for many minutes. Then a car turned the corner onto King Drive going northbound. The car stopped in the right lane long enough for the man in the white t-shirt to get in. The car then proceeded to pull in the parking lot of Twist.

Aug. 21st 12am.

Author was awakened to loud car stereos and noise at approximately 10pm. Police were called and responded. Following this, shots were fired at 12:23am. Police were called again. Police and Paramedics responded. Additionally, cars were parking on the vacant lot at 2721 N MLK. The shots fired and illegal parking can be viewed on Disc #4.

Aug. 22nd 12am

Author was awakened to loud stereos and individuals yelling. Upon investigating, it appeared that armed security had placed a black female in handcuffs at 12:09am. The subject was extremely loud and was yelling racial epithets at the security officers. This went on for an extended period of time in front of 2714 N MLK. The author yelled out to the security personnel and indicated that as a result of the noise the police had been called. The police responded. Author discussed the matter with police. A ticket was issued for Noise Nuisance.

Aug. 23rd 12:28

Author was awakened by noise from car stereos and loud patrons. It was observed that 3 patrons of Twist were in the center lane of MLK blocking traffic and talking to the occupant of a Gray Yukon. This scene can be viewed on Disc 6. Additionally, author observed vehicles parked illegally on the vacant lot at 2721 N MLK. DPW was notified 1150554. 3 citations were issued.

Aug. 25th

Author was notified that as Twist was closing 1:36am, patrons were leaving with beverages in hand. Patron passes under the canopy of 2714 N MLK at 1:36am with a bottle of beer in his left hand. This scene can be viewed on Disc #7

Aug. 30th

Author was notified that as Twist was closing, 2:02am there was unruly traffic and noise. Additionally, patrons were allowed to leave with beverages in hand. This scene can be viewed on Disc 8. Author was awakened to loud car stereos and extremely unruly patrons/traffic around 1:30am. Police were called and responded

Aug. 31st

around 6:30am. The author and the police walked around the parking lots of both Twist and Ponderosa observing the remains of 2 broken car windows and large amounts of debris including numerous open liquor bottles. Twist was issued citation for Noise Nuisance. Pictures of the debris are attached. The scenes of traffic and large crowds can be viewed on Disc # 9

Sept. 1st

Sept. 2nd

Sept. 5th

Sept. 6th

Author was awake at 10:45 and observed security talking with the occupant of a car that was blocking traffic. Additionally, cones were being used to block access to parking spaces that were being held for friends/family. These scenes can be viewed on Disc #10 Author was notified that as Twist was closing there was traffic blocking MLK Drive in both directions. The video was reviewed by author and verified that traffic was blocked in both directions as a result of patrons leaving Twist. Additionally, an individual who was talking with the occupant of a vehicle that was blocking traffic was almost struck by a car that was driving in the parking lane. This scene can be viewed on Disc #11

Author was notified that patrons leaving Twist were allowed to bring beverages outside the establishment. Author reviewed the video and 2 different patrons at 2 different times are seen leaving Twist and discarding their can/cup on the property of 2714 N MLK. These scenes can be viewed on Disc #12

Author was awakened by loud stereos and patrons of Twist. While watching the crowd from a second floor deck, the author observed the following. 1:28 am. One male while standing outside Twist motioned to 3 males exiting Twist. The 4 males then congregated in front of a second floor deck. These subjects did not see author standing above them. Three of the males were encouraging the fourth to make sure the gun is cocked. They repeated this many times. The 4th subject then cocked his gun and stuffed it back in his pants. They then proceeded to head northbound towards Twist. The armed security guard yelled out to the 4 males and indicated by pointing up to author, that the author was watching and recording. Author then went down to the first floor and confronted the security guard, asking him why he acted the way he did. The security guard responded by saying in essence, "that nothing will stop a young black male faster than having a white man watching and recording." Moments later the security guard indicates to the author to go inside as "something is about to go down". Soon after 2:02am. 8-10 shots rang out. Numerous people were observed running to take cover. This incident can be seen and heard on Disc #13B. Additional footage can be found on Disc #13A

Additional incidents 1:35 Author observes 4 cars blocking both the North and Southbound lanes of N MLK

> 1:36 am. Author watched as 2 vehicles drove over the curb and into the vacant lot at 2721 N MLK. They drive around the illegally parked vehicles and exit by going back over the sidewalk and curb on the north end of the vacant lots. These scenes can be viewed on Disc 13A

> Author was awakened by loud car stereos and patrons of Twist. At closing author observed unruly traffic and gridlock. This scene can be viewed on Disc #14

Sept. 7th

Sept.11th

Author was requested by the 5th district to review the video from previous night to see if there is footage of an armed robbery that in part took place in the alley behind 2722 N MLK.

Added 9/14/08

Sept. 14th

Author attempted to retire for the night at approximately 1am. but was unable to due to a 2 door lime green convertible in front of 2714 N MLK with the stereo at ear splitting level. Upon going to view the loud patrons, it became apparent that security was unable to contain or control the large crowd that began gathering around 136am. Author further observed a total of 7 cars parking on a vacant lot that is clearly posted "No Parking". A number of the individuals were seen going directly into Twist. DPW was notified #1152986/1153054. The large out of control crowd can be seen on Disc #15. The patrons of Twist parking on the vacant lot can be seen on Disc #16.

This is an account of the most recent events as of Sept. 14th. Author will continue to document events as they occur.
