




Downtown Plan: Wisconsin Avenue Strategy and Downtown Streetcar


4th Street Extension

Catalytic Projects: Martin Luther King Drive Meinecke to Brown and Bronzeville

"Employ transportation options as both a neighborhood asset and an economic development tool."

"Develop a fixed-route transit system with street embedded guideway or rail for speed, efficiency and smoothness of travel."

"Develop a fixed-route transit system with street embedded guideway or rail as an economic development tool that provides an enhanced development environment along transit routes and confidence for investors that the route is fixed for longterm cumulative investment; that it is there to stay."

"Develop the intersection of Martin Luther King Drive and North Avenue as a retail cluster and transit oriented development (TOD) node."






