Hello,

On Friday, October 9, 2015, I jumped in cab 490 a little after 6 pm to take a ride from the airport to the Psifter Hotel. I believe the driver's name was Mohammad. He asked me why I was in town and I told him that it was to see my boyfriend play basketball against the Bucks.

The standard cab ride from the airport to downtown should be no more than \$35. The driver continued to go in circles adding up their fare. I even pulled up the GPS on my phone and told him that he was going in circles. He told me that he knew what he was doing. I was intimidated by him after his tone of voice escalated when I told him that I saw the same landmark twice in the drive to the hotel. The cab drive added up to \$53. This was unheard of. He took advantage of me just because he assumed I had the funds to pay for it. He can't take advantage of a 22 year old female like that, be confrontational with.

When I got to the hotel, they made a complaint about the driver after seeing how much he charged me and told him that he is not allowed back there. But, I want to dispute the charge. I really need a refund back. At least a partial refund. I've been taken advantage of, treated poorly, and I'm disappointed.

Please let me know if you can help me.

My name is ind on Saturday afternoon 11/22/2014 Taxi driver 193 drove me and 4 other people from Mo's Irish pub Downtown to Potawatomi Bingo casino.

When we got in the car, he said it is a standard rate of \$20 to take us to the Casino. I questioned him, and asked why he wouldn't use the meter, and charge us appropriately...? He said its just a 'standard' price for trips of 5 or more people to the casino. So when I told him I will call yellow cab to confirm this \$20 fee, he just ignored me. I knew something seemed odd so I decided to call Yellow Cab to report the situation. After 193 dropped us off, and we handed him \$20 (he also said that included tip) he drove away and I immediately got on the phone to report him. I spoke with operate 16, Nadine, and she told me that what he did was absolutely illegal. She looked up what my rate should have been and it should have been \$7.41, she rounded up to eight, and she said the max that trip should have been would be \$12. They said I was correct – taxes are included, and the cab driver *can* charge for handling bags – but none of these charges should have applied.


The dispatcher asked which cab it was and I told her 193. "Oh him – we have had many complaints about him but we can't do anything".

I also called the Hilton to let the know other guests were at risk of being cheated and they put out the word to forbid 193 from waiting in their lineup.


Not once in all my trips have I had an issue – but this clown is a crook and you may want to reconsider issuing him a license; it reflects poorly on this fine city.

On Thursday, June 30, 2016, wrote: I jumped into the cab to head home. I gave him my address (southstor of I) he first stated I should take an uber. I told him I was fine and would give him a good tip. Then he pointed to the minimum fair and I agreed that I know that there. He proceeded to drive me home. I noticed that he didn't have the meter running during my trip.

As soon as we got to my home I paid him minimum + tip = \$22

He informed me that the fair would be \$25. I told him that the minimum fair from the airport was \$15, as it said on the sticker. He stated that was only from a hotel. I knew that was incorrect, so I told him that I would look. Before I could finish the sentence he began to drive from my destination and speed informing me he was driving me back to the airport. He then sped through a few red lights. I told him that I felt threaten and unsafe and would be calling 911 if he didn't stop the vehicle. He didn't listen, and fearing for my safety, I dailed 911. As I was speaking to the dispatch he began to speed and drive on the opposite side of the road.

I was a little frustrated because dispatch didn't really understand that I felt unsafe with the aggressive and unsafe driving he was doing.

He pulled over a few times to yell at me but would peel off the road and began to drive to the airport.

As soon as we got to the airport he locked the door, to lock me. I jumped out to talk to the taxi dispatch. I had informed her that I was a federal employee and I was late for a meeting with The VA and he was withholding me and my possession against my will.

The other cab drivers hearing the commotion and listening to my statement grabbed his keys and opened the back to allow me to get out.

Fearing that the situation could escalate quickly, I left and called an uber avoiding the driver.

Doyne Ave, Milwaukee, on Wednesday 6/10/15 between the hours of 10am and 2pm. This is in regards to the Driver with Cab #151 and the Driver's cell phone number is: 414-333-9321.

received phone call from Clinic Nurse that patient needed to come into the Cancer Center for emergent lab work and transfusion by this afternoon today (6/10). The patient normally uses Interfaith volunteer services but they are unable to do last minute/same day arrangements. This Social Worker agreed to arrange a cab voucher (with Froedtert paying) for her to be brought from home to the Cancer Center. This Social Worker scheduled pick up time for 1015 via main office scheduling (Elizabeth (I believe) at p: 271-1800) and she provided the roundtrip rate of \$42 for the voucher. I confirmed with Elizabeth that this was a round trip ride from pt's home address to CCC. The patient was picked up on time and brought to Cancer Center. Our front Main Lobby desk Rep- Mary- phoned Yellow Cab when R.R. was ready to be picked up after treatment. This Social Worker had already provided the cab voucher to Mary in the Lobby to give to the driver. This Social Worker received a phone call from Mary advising that cab driver is arguing the voucher price and is present to transport pt home (roundtrip). Mary put the driver (name unknown but Cab # 151, his cell: 414-333-9321) on the phone with this SW, who was in a different part of the building. The driver was rude in tone and stated "there is no way that \$42 is for round trip, she lives all the way in Brown Deer." SW agreed to verify price again with the office but instructed the driver that this was already pre arranged and approved at the voucher price of \$42 with the main office. SW then phoned the main scheduling office and spoke to a gentleman and explained the above. The Rep agreed with the voucher price of \$42 and stated he would phone his driver to resolve his concern and transport home could continue. This SW assumed this was resolved and pt was transported home. SW then received another call from Lobby Rep- Mary 20 minutes later, that while she was at lunch break a volunteer notified her that the cab driver "kicked her out of the cab" and told the pt to go back to the lobby. SW then phoned Yellow Cab p: 271-1800 back immediately and asked to speak to a Supervisor and was transferred to speak with Omar- Secretary on Board of Directors updating him on above of the inappropriateness of the driver to: 1. Being rude with the CCC staff, 2. Challenging the cost of the cab voucher when the policy/protocol is for SW to arrange payment/voucher with main office staff not driver 3. Continuing to argue the price of the cab voucher with this SW when his job was to drive the cab, not argue cost of a charity voucher 4. To force pt to exit the vehicle when he was instructed to honor the cab voucher. Omar requested SW email a formal complaint against the driver. Omar insisted he was sending a cab asap to transport pt back to her home, as reflected in the existing cab voucher. [RE: Yellow Cab Co-Op Taxi Incident- Cab Permit #517 Driver #5117]

This letter is intended to describe an incident that occurred on the afternoon of January involving the driver of Yellow Cab Co-Op Taxi number 517. I entered the taxi 2015 around line outside of the Amtrak station and boarded the first available taxi. I entered the vehicle with my luggage and gave the driver my destination. The driver began en route to my destination, and aside from carrying on a cell phone conversation the ride appeared to be fairly typical. As we neared my destination the driver ended his cell phone conversation and asked for my address again. Being that traffic on Prospect Avenue was very busy as usual, I asked the driver to pull into the driveway of the apartment building neighboring my own. He did so and ended the trip requesting that I pay cash. After telling him that I did not have cash and would be paying with a Visa, I was told that his machine was not working but I could give it a try. After several failed attempts with the card transaction, he entered his glove compartment and proceeded to hook up a machine. After this, I was instructed to try processing my payment again. After doing so my payment was successfully processed and the driver began to pull out of the driveway into oncoming traffic on Prospect Avenue. He stopped directly in front of my apartment and waited for the payment receipt to print. In doing so, he stopped traffic and several cars began to blow their horns at the driver. I am not exactly sure why the driver pulled into the street versus finishing the transaction in the driveway.

After signing my receipt I asked the driver if he would pull up his seat and allow me to exit on the driver's side. After refusing I asked that he pull up a few feet into an open space that would allow me to get out without entering oncoming traffic. He became increasingly hostile as he moved his vehicle up and out further into the street. At this point cars were blowing excessively and zooming pass the driver in frustration. The driver then told me to get out and yelled "Fuck You". Afraid for my safety I began to gather my luggage and exit the vehicle slowly so that oncoming vehicles were aware that I was attempting to exit. The driver then began to exit his vehicle continuing to tell me to "Get the Fuck out". I exchanged words with the driver telling him that I would be reporting the incident to the city. As he approached me, I immediately jumped out of the vehicle dropping several of my items into oncoming traffic. He continued to

yell obscenities and stated, "Tell whoever you want. You can tell Obama." He then re-entered his vehicle and sped off. I waited for him to leave before retrieving my items that had fallen onto the street.

I am extremely disappointed in the events that occurred that evening. Not only was I treating poorly as a customer, but I was verbally assaulted and hostilely confronted. As a frequent user of taxis and rideshare services I have never encountered such an unprofessional, intimidating and blatantly disrespectful driver. While past experiences of poor service and refusal to accept credit cards has resulted in me avoiding Milwaukee taxis, I never imagined that an incident to this extent would occur. As a citizen and employee of Milwaukee, I am disgusted by the actions of the driver. While I understand that this could be seen as an isolated incident, it speaks volumes to the culture of Milwaukee taxi companies and the lack of accountability. The driver involved in this incident should not be allowed to service citizens of Milwaukee. Furthermore, Yellow Cab Co-op and the City of Milwaukee needs to be held responsible for ensuring that poorly trained drivers are not allowed to continue violating the rights of taxi passengers.

I have also filed a complaint with the Yellow Cab Co-Op and as of January 28, 2015 I have not heard from anyone regarding this incident. Please feel free to contact me about this issue. I look forward to discussing this incident and ensuring that the driver is held responsible for his actions.
