Dear Common Council President Hamilton and All Other Members of the Council:

I am writing to provide this letter of support for Commissioner Rocky Marcoux. I urge you to reappoint him as Mayor Barrett's selection to lead the critically important Department of City Development.

In my role as President of Fix Development, I have been active in efforts to build a more vibrant city through progressive real estate and other entrepreneurial projects that contribute to the social, environmental and economic fabric of Milwaukee. I have served on the Mayor's Green Team – developing a sustainability plan for our future; I am a co-founder and board member of Bublr Bikes – our bikesharing system; I am a co-founder of Fund Milwaukee – a local crowd-investing platform focused on local small businesses; I have been named Innovator of the Year; an Entrepreneur to Watch and a Woman of Influence by local business and industry leaders; and, my real estate projects located in the Walker's Point, Lindsay Heights, and Silver City neighborhoods have been recognized locally, regionally and nationally. Commissioner Marcoux has built a professional team that I can rely on in any situation. The Commissioner himself has also stood with me on many challenging projects, helping ensure success. We are at a moment when real estate development momentum is such that I believe we can continue to see transformative development in the most disinvested parts of our City. Maintaining steady leadership and strong management will be so important toward that end.
