On September 11, 2008, the City Clerk's Office provided timely notice to the Licensee, pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24 of the Wisconsin Statutes of a police report that could form the basis for suspension or non-renewal of the licensee of the licensee and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the police report on September 25, 2008 at 9:00 a.m. in Room 301B of City Hall. At said date, time and place, the licensee did appear and was not represented by counsel.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. On September 2, 2006 applicant was asked for her public passenger vehicle license by a Milwaukee Police Department officer and she pulled the license out from her breast pocket and handed it to the officer. When asked why she did not have it displayed for her passengers to see she stated that someone tried to steal it from her when she had in a holder. The applicant was cited for license not displayed which was dismissed on June 11, 2007.
 - B. On September 11, 2006 the applicant was asked for her public passenger vehicle license by a Milwaukee Police Department officer and the officer

observed she had her license backwards inside the holder. When asked why her license was not properly displayed especially when he had stopped her days ago and cited her for the same violation. The applicant stated "I didn't know that you worked at night." The applicant was issued a citation for license to be exhibited and found guilty on December 11, 2006 and fined \$110.00.

C. On February 25, 2007 officers of the Milwaukee Police Department were patrolling the area of the Amtrak Station checking for taxi cab violations. Officers observed an American United van, No. 236, parked in the taxicab stand waiting for a fare. The applicant was asked to see both her daily safety checklist and trip sheets. The applicant handed the officer one page and did have sheets for the last several days, which included February 22, 23, 24 and 25. The applicant was issued a citation for daily safety checklist required and found guilty on April 27, 2007 and fined \$50.00.

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24, Wisconsin Statutes.
- 2. Based upon the above facts found, the Committee concludes that the licensee, Clementine M. Brown, has not met the criteria of Chapter 100 of the Milwaukee Code of Ordinances or § 349.24 of the Wisconsin Statutes to allow renewal of his Public Passenger Vehicle Driver license without undergoing a ten (10) day suspension of said license based upon a police report.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Public Safety Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew the Public Passenger Vehicle Driver license held by Clementine M. Brown based upon the police report with a ten (10) day suspension of said license.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of three (3) ayes and one (0) noe and, recommends that the Public Passenger Vehicle Driver license of be approved with a ten (10) day suspension of said license based upon the police repot.

Said suspension is to be in effect from 12:01 a.m., November 1, 2008 through 11:59 p.m. November 9, 2008.
