5. DESCRIPTION OF PROJECT:

Remove Cedar Siding on East Side of House.
Old siding to be completely removed as it is warped and destroyed.

Replace siding with western red cedar siding identical to original siding. (6" wide bevel siding - 1/2" bevel). Siding will be overlapped by 1.5" leaving 4.5" exposure (per original pattern)
Replace water table at base of siding including angled top board and bottom trim board (western red cedar - identical in dimensions to original).
Replace corner trim boards and top trim boards (western red cedar - identical dimensions to original)
Replace wood trim around windows (western red cedar - 4" wide).
Existing storm windows and screen windows to be kept (use existing hanger system over windows).

East Side of house can be clearly viewed in Google Street View.
