This report is written by Police Officer David Novak, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 01/04/2013 officers received information the store at 4790 N. Hopkins St was selling synthetic marijuana. An undercover buy was performed and the officer obtained a package of synthetic marijuana. A search warrant was obtained and a search of the premise was performed. One additional package of synthetic marijuana was recovered and a gun was placed on inventory for safe keeping. Tareq HAMED was ordered to the DA's office, no charges were issued.
- 2. On 05/17/2016 officers had a confidential informant go to Food Town Mini-Mart at 4790 W. Hopkins St to purchase "Spice", synthetic marijuana. The informant was equipped with a covert recording device. The informant went in and was able to buy two packages of "Spice" which the clerk obtained from a black plastic shopping bag next to the register. The informant described the clerk as a Middle Eastern male. The informant turned over the "spice" and the recording device to the officers. Upon review the officers found the recording device did not function due to operator error. The "spice" was tested by the Crime Lab and was found to contain synthetic cannabinoid not in the Wisconsin Uniform Controlled Substance Act.

- 3. On 05/18/2016 officers had a confidential informant go to Food Town Mini-Mart at 4790 W. Hopkins St for a second controlled buy of synthetic marijuana. The informant was equipped with a covert recording device. The informant went in and was able to buy three packages of "Spice" which the clerk obtained from a black plastic shopping bag next to the register. The informant described the clerk as the same Middle Eastern male from the prior day. The informant turned over the "spice" and the recording device to the officers. The video confirmed the events described by the informant. The "spice" was tested by the Crime Lab and was found to contain synthetic cannabinoid not in the Wisconsin Uniform Controlled Substance Act.
- 4. On 06/15/2016 officers conducted a license premise check at Foodtown Mini Mart, 4790 N. Hopkins St, based on a complaint of the business selling K2 (synthetic Marijuana). The officers found an open box of Black & Mild cigars next to the register being sold individually. Under the register in a black bag they located colorful packets, which based on their training they identified as synthetic marijuana. Tareq HAMAD, the manager, stated it was potpourri and it sold for \$10.00. A total of 109 packages where recovered and inventoried.

This report is submitted by PO Trinidad RODRIGUEZ assignd to District Seven Captain's Car. Also invovled in the investigation is PO Paul MARTINEZ assigned to North Investigations attached to the MPD / FBI Southeast Wisconsin Regional Gang Task Force.

On Tuesday, May 17, 2016, PO Daniel KELLER and PO MARTINEZ met with an MPD Confidential Informant (CI) regarding a controlled buy of synthetic marijuana also known as "K2" or "Spice" from the convenience store at 4790 W Hopkins St, Food Town Mini-Mart, which is located in the City and County of Milwaukee.

The CI was searched prior to the buy and no money or contraband was found. The CI was then given \$40 of US currency from MPD draw# 16-038, which was photographed and equipped with a covert audio/video recording device. The CI was then dropped off near the store from our undercover (UC) vehicle.

At approximately 12:41pm, PO KELLER and PO MARTINEZ observed the CI enter the store at 4790 W Hopkins St. The CI then returned to us at approximately 12:43pm and handed us (2) sealed pouches of "Dank" and "7H" potpourri (suspected synthetic marijuana) and the recording device. The CI was re-searched and no money or contraband was located.

The CI stated that they purchased the (2) pouches of "Spice" from the clerk behind the counter, for \$20 each. The CI described the clerk as a Middle Eastern male, approximately 25 to 35 years old, 5'8, 250lbs, short dark hair and having a large build. The CI stated that he/she simply waited in line and asked the clerk for "2 spice". The CI stated that the clerk then took the recorded money from him / her and entered the transaction into the cash register and placed the money in the register as well. The CI stated that the clerk then retrieved the two packages, which were in a black plastic shopping bag, from the top of the counter to the right of the register.

The CI was later dropped off and we then conveyed the evidence to District 5. At District 5, PO KELLER and PO MARTINEZ photographed the pouches. PO MARTINEZ then opened each pouch and poured the green, leafy substance into (2) paper folds. The pouch labeled "Dank" had a total weight of 5.27 grams without packaging and the pouch labeled "7H" had a total weight of 4.44 grams. A small sample from each pouch was submitted to a NarkII 05 field test with negative results. The substances were then placed on inventory # 16017197.

The covert video was later reviewed. It was then learned that no images or video were captured of this event due to operator error.

The photos were then sent to PO Trinidad RODRIGUEZ of District 7 who is the primary investigator of this investigation.

I did have all packages sent out to the Wisconsin State Crime Lab. Findings showed presences of synthetic cannabinoid not in the Wisconsin Uniform Controlled Substance Act.

PA-33E Narrative

This report is written by PO Penny BROWN assigned to the License Investigation Unit.

On Wednesday, June 15, 2016, at approximately 10:30a.m., PO Denise RUEDA and I conducted a license premise check at Foodtown Mini Mart, which is located at 4790 N. Hopkins St., in the City and County of Milwaukee. This was based on an anonymous complaint the establishment was selling single cigarettes and Synthetic Marijuana also known as K2 or spice.

Officers entered the business and could smell a strong odor of cigarette smoke, which became stronger as we approached the office and sales counter. Officers identified ourselves to the manager on duty, Tareq A. HAMED A/M 06/02/62, and advised him it is illegal to smoke inside a licensed premise. We then advised HAMED that we would be conducting a license premise check, which would include checking the licenses and looking at how the business is run. HAMED provided officers with the business licenses, which were valid. As I was walking behind the counter to check tobacco and any tobacco violations, I observed an open box of 5 Black & Mild cigars, with 3 cigars missing from the pack, right next to the cash register. The pack was originally a sealed pack, and therefore, not for individual sale. HAMED was advised it was illegal to open a box and sell cigars individually. I then observed two black plastic bags under the cash register area. The bags were open and I observed colorful packets inside, which based on my training and experience, I knew synthetic marijuana to be packaged in the manner. I asked the cashier how much they sell the packets for, to which he stated \$10.00 each.

At that time HAMED became irate stating that officers had no legal right to enter the store and begin searching. I advised HAMED that due to the fact the store held a license issued by the City, officers can legally enter the store and conduct a license premise check. HAMED stated that possessing herbal potpourri was not illegal. I advised HAMED that although it is packaged as herbal potpourri, we know it to be synthetic marijuana. I also questioned him as to why a customer would pay \$10.00 for a bag of potpourri. HAMED stated we could not prove it was being used as synthetic marijuana, therefore, he objected to officers taking the product. I advised HAMED that we would in fact be confiscating the product, and sending samples to the crime lab for testing of the prohibited chemical compounds. I advised HAMED if the testing revealed there were no banned substances in his product, it would be returned to him. HAMED was provided with a PP-33 Property Receipt for the product.

In total there were 109 packages of various brands and weight of suspected Synthetic Marijuana. These items were placed on MPD Inventory #16021145.

It should be noted that PO Trinidad RODRIGUEZ, District 7 Days, was the lead investigating officer on complaints of synthetic marijuana being sold from this establishment. PO RODRIGUEZ conducted undercover buys using a confidential informant. On Tuesday, May 17 and Wednesday, May 18, the confidential informant was able to purchase synthetic marijuana, on both dates. See MPD IR # 16-138-0066.

NARRATIVE SECTION: This report is writtne by P.O. Matthew Kaltenbrun assigned to District 7, Early Shift, Squad 7282. On Wednesday January 2nd, 2013 at about 1:50p.m. P.O. Zebdee Wilson was working in an undercover capacity and entered the Food Town Mini Mart located at 4790 N Hopkins St.

- P.O. Wilson continued east in the store and to the counter located along the north wall and to the east where he spoke with a I/M about 30 years of age, 5'6", 260 lbs and was wearing a black shirt with a red shirt underneath with blue jeans whom appeared to be an employee who was standing behind the counter.
- P.O. Wilson asked for a cigar and the proceeded to ask the store clerk for "Mike and Ikes". It should be noted that officers had received information from a concerned citizen that the Food Town Mini Mart had been selling synthetic marijuana and that customers would have to ask for "Mike and Ikes" from the store clerks and they would receive a sealed package of "Scooby Snax" potpourri 4g for \$15.
- P.O. Wilson stated that the store clerk then reached under the counter to the employees left side and retrieved a sealed package of "Scooby Snax" potpourri and was advised that the "Mike and Ikes" were \$15. P.O. Wilson exchanged a \$50 bill with the last four of the serial number being 113A for the cigar and "Scooby Snax".
- P.O. Wilson then retrieved the "Scooby Snax" and cigar and exited the store. P.O. Wilson later conveyed the "Scooby Snax" to District 7 where I later placed it on drug inventory # 1300189. It should be noted that "Scooby Snax" is sold as synthetic marijuana and is advertised online as creating a "high" similar to marijuana.

A search warrant was later reviewed by ADA Antonella Aleman and signed by Court Commisioner Barry Phillips.
On Friday January 9th, 2013 at about 6:30p.m. my partner, P.O. Omarlo Phillips, and I along with P.O.'s Kent Tuschl, Daniel Vidmar, Daniel Roufus, Matthew Dresen, and Sgt Malcolm Blakely performed a search warrant at the location of 4790 N Hopkins St.

Upon entering the store, patrons were escorted from the business, I proceeded to the north east corner of the store. Along the north east corner of the store is a small office area with safety glass separating the office from the store and a door way which was located behind the counter. I then performed a search of HAMED which revealed a sealed 4gr bag of "Scooby Snax" Kush potpourri in his front left pants pocket and 7 4gr sealed bags of "Scooby Snax" green apple potpourri in HAMED'S right rear pocket.

I then asked HAMED if there were any weapons on the premises and he responded that a firearm was located in the safe. HAMED then unlocked the safe and I recovered a loaded chrome and black semi automatic Ruger SR99c firearm with a black case, two magazines, 15 rounds of 9mm Hornady ammo, and a sales receipt. Located under the eastern most sales counter was a white and clear plastic drawer cabinet. Inside of the top drawer of that cabinet was one sealed 4 gr package of " Scooby Snax" strawberry smash potpourri.

With Sgt Blakely as a witness, along with HAMED, I searched the premises and safe for a \$50 bill with the last four of serial number being 113A but was unable to locate the bill.

The "Scooby Snax" were recovered and later conveyed to District 7 for processing and the firearm for safekeeping. Other employees that were onscene were identified as Anas I ZIDAN, W/M, 12-17-71, Hussam T. HAMED, W/M, 6-15-87, and Ayman K. MUSAITEF, W/M, 12-20-91.

The "Scooby Snax" were placed on inventory # 1300453 and the firearm was placed on inventory # 13000448. HAMED was ordered into the DA's office on Thursday January 10th, 2013 at 1:30pm.
