REPORT CARD RELEASE DATES

We have updated timelines! Please review and help communicate across your district about the important dates below. We'll begin posting report card resources in the coming week. Stay tuned for details on resources in next week's DAC Digest.

Monday, September 26: SECURE RELEASE

- Preliminary report cards will be released via SAFE.
- Preliminary report cards are EMBARGOED until the public release.
- Results should not be released in any way prior to the public release.
- The secure release allows schools/districts to review their report card data, plan their local media release, and initiate an inquiry process if needed.

Monday, September 26 - October 3: INQUIRY PROCESS

- This is an opportunity for schools/districts to report potential data issues to OEA.
- Note that this is a one week window, shorter than in prior years; please review your report cards as soon as possible after they are available in SAFE.
- Report cards are based upon certified Individual Student Enrollment System (ISES) data and Wisconsin Student Assessment System (WSAS) results, both of which have already been verified by districts. In the case of choice schools, the report cards are based on data in WISEdata, again already verified by the schools.
- If you want to initiate an inquiry, the first critical step is submitting the inquiry form. Forms will be available on report card website on September 26 and must be submitted by October 3rd.
- Do not send evidence with your inquiry form. You will receive a reply with instructions for sending evidence, if warranted.

Monday, October 31: PUBLIC RELEASE

- Final, public report cards will be released via the DPI website.
- Final, secure report cards will replace preliminary versions in SAFE. The secure versions are never to be released publicly. Rather, they are to be used by educators to guide school and district improvement planning.

ACCESS for ELLs

- REMINDER WIDA AMS Availability
 - WIDA AMS will be available for <u>existing users</u> on September 19
 - WIDA AMS will be available for new DACs on September 26
 - Ensure your DAC contact info is up-to date here
 - Log-in information will be emailed to the address on file on the above dates.
- REMINDER Districts may choose to upload Private School Rosters in October
 - Districts with substantial numbers of Private School students taking ACCESS for ELLs may elect to upload PreID files October 4 - November 1.
 - These students will receive PreID labels to be placed on booklets to avoid bubbling in student information.
 - DPI will upload the statewide Public School roster on November 1.
- REMINDER WISEdata and ISES differences
 - ISES automatically reclassified ELs who were in grades 4-12. WISEdata no longer does this.
 - District EL and SIS staff will need to ensure that students have the appropriate ELP code in the local SIS. Students in grades 4-12 who should be reclassified as Former ELs based on their 2015-16 ACCESS for ELLs score should have ELP code 6.

- REMINDER DLM Required Test Administration Training is now live in Moodle. Both
 returning and new test administrators must complete the modules and open the certificate of
 completion prior to using the optional Instructional Tools Interface or the required Spring

 - All educator portal 'teacher' accounts have current access to the trainings. DACs are
 now loaded as 'facilitators.' Additional 'facilitators' can be added by the test coordinator
 by locating the Facilitator Trainer Template available on the <u>DLM Webpage</u>.

 users must install the new KITE Client in order to deliver the DLM alternate assessment during
 the 2016-17 school year. The new software update covers all platforms and includes new

- DACs should notify their business offices to use "Source 630 Project 522" when purchasing the literacy screener required by Wis. Stats. 118.016.
- Districts will be able to seek reimbursement for 2016-17 expenses in the spring 2017 semester. DPI will be creating a reimbursement request form for districts to submit their expenses.
