This is to notify you that on September 23, 2008, the City's Licenses Committee voted to recommend to the City's Common Council that your renewal application for a Class "D" Bartender license be denied based upon nonappearance.

On September 26, 2008, you were sent a true and correct copy of the findings of fact, conclusions of law and recommendations of the Licenses Committee with respect to your renewal application for a Class "D" Bartender license in which the Committee recommended that your renewal application be denied. You were further notified that the Milwaukee Common Council would consider the matter at its meeting of October 7, 2008 commencing at 9:00 a.m. in the Common Council Chambers on the third floor of City Hall, 200 East Wells Street, Milwaukee, Wisconsin. Following consideration of the report of the Licenses Committee, the Common Council adopted the recommendation of the Licenses Committee by a vote of fourteen (14) Ayes, zero (0) Noes, and one (1) Excused to not renew your license.
