

Substitute ordinance relating to the change in zoning from Multi-Family Residential and Two-Family Residential to General Planned Development for the properties located at 3940 West Lisbon Avenue and part of 1929 North 39th Street and approving the First Amendment to the General Planned Development known as United Methodist Children's Services, located North af West Lisbon Avenue and West of North 39th Street, for development of apartment housing and community space, in the 15th Aldermanic District.

(1) In accordance with the provisions of Section 295-907(2) of the Code relating to the procedures and establishment of planned development districts, the Common Council approves the sub-ject General Planned Development, a copy of which is attached to this Com-mon Council File as Exhibit A which is on file in the office of the City Clerk and made a part as though fully set

(2) The zoning map is amended to change the zoning for the area bounded and described as follows: Lots 8, 9, 10, 11, 12,-13, 14, 15, 16, 17

and 18 in Lisbon Avenue Park, in the Northwest 1/4 of Section 24, Township 7 North, Ronge 21 East, in the City of Milwaukee, County of Milwaukee, State of Wisconsin, including the vacated east-west alley, and a line 169.74 feet South and parallel to the south line of West Brown Street.

(3) The requirements set forth in said general plan attached to this Comman Council File as Exhibit A, constitute the zoning regulations for the area contained in such planned development district described, provided further, that the effect of the approval of such general plan is that such plan shall limit and control construction, location, and control construction, location, use and operation of all land and structures included within the general plan to all conditions and limitations set forth in
