Our office is Counsel to Sway Guild LLC. This letter serves as our client's written objection to the "Findings of Fact and Conclusions of Law" and recommendation of the Licenses Committee ("Committee"). The specific objections are for paragraph 5D and 5I on the "Findings of Fact" (contained on page 3):

- 1. Alderman Pérez produced no evidence whatsoever of any nuisance activity, law violations nor tavern violations. As such there is no bases for Alderman Pérez's objection.
- 2. At the Committee hearing, Sway Guild LLC agreed to amend its Plan of Operation to close at midnight Sunday thru Thursday. On Friday and Saturday, the closing time would be 2:30am.
