1. Description of Grant Project/Program (Include Target Locations and Populations):

This grant will allow the Department of City Development ("DCD") to carry out a planning study to develop a framework to foster Transit-Oriented Development ("TOD") through the City's zoning code and recommend complementary strategies that can be used to attract TOD. The grant will be used to create strategies and zoning code changes to support residential and commercial development nearby transit, with a focus on preserving and promoting affordable housing near transit corridors. The study will have a geographic focus along the Historic King Drive and Walker's Point transit corridors, and the Historic King Drive Business Improvement District and Harbor District Inc. are formal partners in the proposal. The main deliverables of the planning study also may be used to help guide development along all of the City's major transit corridors, including existing express bus routes, proposed Bus Rapid Transit corridors, etc.

2. Relationship to Citywide Strategic Goals and Departmental Objectives:

Goals of the project include developing and implementing strategies to attract new commercial and residential development to commercial corridors, expanding affordable housing opportunities near transit and ensuring that the City's zoning code supports these types of investments. All of those directly align with the objectives of the work of DCD, including those found within Growing Prosperity, the City of Milwaukee's action agenda for economic development.

Funds must be expended within two years of award. DCD anticipates releasing a RFP to identify a consultant(s) for the project within one month of award. DCD will partner with the Historic King Drive Business Improvement District and the Harbor District Inc. to ensure there is substantial public engagement during the development of the planning study. It is anticipated that the actual development of the study will take roughly 18 months, with public and Common Council review to follow. DCD will begin work on implementation of study recommendations following Common Council approval.
